## General Information

### 1. What action are you requesting from the Board?

Approval of Amendment No. 3 to an IGA between Multnomah County and the City of Portland.

### 2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

The subject of the original agreement and its subsequent amendments is a jointly controlled system of conduits and fiber optic cables placed on County and City controlled property for the mutual benefit of both parties. The County and the City are currently using the fiber system for a variety of purposes. This amendment will expand those usage opportunities to a much larger area for the County and the City.

The Original IGA was for the "Portland Building to Justice Center Conduit System."  
Amendment No. 1 added the "Hawthorne Bridge System."  
Amendment No. 2 extended the expiration date of the agreement to June 30, 2020.  
Amendment No. 3 will add the "Sellwood Bridge System."

The Sellwood Bridge System will include a conduit (provided by Multnomah County) in the new Sellwood Bridge from the intersection at Hwy 43 to the intersection at SE 6th Avenue and Tacoma Street. The City will pull fiber for their use through the conduit system. The City will also provide the County with fiber from the east side of the Sellwood Bridge back to the west side of the Hawthorne Bridge, allowing the County Bridge Division to extend our camera and data network to the Sellwood Bridge.
