General Information

1. What action are you requesting from the Board?

None, this is an informational briefing.

2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

Multnomah County is participating fully in the implementation of the Affordable Care Act and Medicaid reform. Two years ago, Coordinated Care Organizations (CCOs) were established in the largest move to transform the health system. Medicaid expansion began on January 1, 2014.

Two recent reports have highlighted challenges and opportunities for the County in the context of Health System Transformation. These two reports, the County Auditor's report and consultant report from the Technical Assistance Collaborative (TAC), focused specifically on the work of the Mental Health and Addiction Services Division. Multnomah County has operated a Medicaid mental health insurance plan for many years. With the creation of CCO's and vision of state transformation, the County is operating the insurance plan in a new regional environment.

The County Auditor presented his team's report to the Board on May 1 of this year. In June the Technical Assistance Collaborative (TAC), consultants hired by the County to review both managed care operations and the Local Mental Health Authority, presented many of the same findings and recommendations as the Auditor.

The presentation will provide updates on action being taken by the Mental Health and Addictions Service Division in response to the various findings and recommendations.

In the context of health system transformation, Multnomah County works closely with our two regional CCOs, Health Share of Oregon (HSO) and Family Care. The Mental Health and Addictions Service Division in its role as managed care plan within HSO works closely with Clackamas and Washington Counties to simplify and regionalize aspects of the mental health system for both providers and clients.

MHASD works in partnership with the Behavioral Health Providers Association to implement the changes required by Medicaid reform and Medicaid expansion. MHASD also consults with county advisory groups including the Adult Mental Health and Substance Use Advisory Council (AMHSAC) and the Children's Mental Health System Advisory Council (CMHSAC). The membership of these groups includes consumers, community stakeholders and advocates.
