The County through the Sheriff's Office facilitates and provides administrative support for a countywide burglar alarm task force, working with participating cities on the administration of the False Alarms Reduction Program. County will administer Wood Village Municipal Code 8.08. This contract replaces a previous agreement, updating code references. This affects program offer 60069, MCSO Alarm Program, and contributes to ensuring that through an alarm permitting program burglar alarms are regulated to ensure validity of the alarm and reliability of alarm equipment.

Alarm permit fees collected will be allocated to the County for the administration of the alarm ordinance. All false alarm fees collected are allocated to the City to offset costs for alarm response.
