**RESOLUTION NO. 2014-014**

Ratifying the Appointment to Fill a Vacancy in the Legislative Assembly, Oregon House District 38.

**The Multnomah County Board of Commissioners Finds:**

- a. Effective at 5:00 p.m. on December 31, 2013, there is a vacancy in Oregon House District 38, due to the resignation of Representative Chris Garrett.
- b. Pursuant to state law, the Democratic Party Precinct Committeepersons of House District 38 met to choose nominees to fill the vacancy.
- c. The nominees chosen were: Ann Lininger, Sonya Fischer and Moses Ross.
- d. In accordance with procedures established by the Secretary of State, the Multnomah County Board of Commissioners considered the nominations at a special joint meeting with Clackamas County on Wednesday, January 29<sup>th</sup>, 2014 at 1:30 pm.
- e. At the conclusion of the public meeting the Commissioners voted to appoint Ann Lininger to fill the vacancy, said nominee having received the highest number of votes.
- f. Under Board meeting rules adopted by Resolution No. 2013-021, Board action at a special meeting does not take effect unless ratified at the next regular meeting.

**The Multnomah County Board of Commissioners Resolves:**

1. The Board approves and ratifies the appointment of Ann Lininger to fill the vacancy in the Legislative Assembly, Oregon House District 38 on January 29, 2014.
