**RESOLUTION NO. 03-053**

Establishing a Portion of NE 207th Avenue as County Road No. 4998

**The Multnomah County Board of Commissioners Finds:**

- a. ORS 368.106 provides that upon the acquisition of property for road purposes the County is required to survey and monument the property.
- b. The above-mentioned portion of NE 207th Avenue described as follows:  

From NE Glisan St. northerly to the southerly right of way line of the Oregon Washington Railroad and Navigation Co. more particularly described in the attached Exhibit A has been acquired, surveyed, and monumented as required by law.
- c. Further the surveys have been recorded and the real property interests acquired have been used in the construction of NE 207th Avenue consistent with Multnomah County specifications and requirements.
- d. The County Engineer finds it is in the public's interest and therefore recommends that above-described portion of NE 207th Avenue be established as a county road as authorized pursuant to ORS Chapter 368.

**The Multnomah County Board of Commissioners Resolves:**

1. The portion of NE 207th Avenue more particularly described in the attached Exhibit A, is hereby established as County Road No. 4998, in accordance with ORS Chapter 368.
2. Pursuant to ORS 368.106, this Resolution establishing County Road No. 4998 will be recorded in the Deed Records of Multnomah County, Oregon.

A public right of way from NE Glisan St. northerly to the southerly right of way line of the Oregon Washington Railroad and Navigation Co. right of way and with the centerline and right-of-way boundary lines as described by the following deeds of dedication to the public: Book 2703, Page 246, recorded 06/08/1993; Book 2495, Page 777, recorded 01/08/1992; Book 2627, Page 1011, recorded 12/21/1992; Book 2580, Page 1495, recorded 08/25/1992; City of Fairview Resolution 1-2003; Documents 96-134364, 96-176326, 96-134365, 98-206409, 96-105264, 96-173836, and 97-008214, Deed Records of Multnomah County, Oregon, and as shown on the attached right of way map. Said NE 207th Ave. being situated in Sections 28, and 33, T1N, R3E, W.M. The right-of-way to be variable in width from NE Glisan Street, northerly to the southerly right of way line of the Oregon Washington Railroad and Navigation Co. right of way.
