DEED FOR ROAD PURPOSES

MULTNOMAH COUNTY conveys to MULTNOMAH COUNTY, a political subdivision of the State of Oregon, for road purposes, the following described property:

A parcel of land situated in the northeast one-quarter of Section 6, T1N, R1W, W.M., and the northwest one-quarter of Section 5, T1N, R1W, W.M., Multnomah County, Oregon, more particularly described as follows:

Beginning at a point on the west line of said Section 5, said point being N 00°38' E, a distance of 1,315.84 feet from the west one-quarter corner of said Section 5, said point also being the northwest corner of that tract of land conveyed to Multnomah County by Suit of Condemnation, Judgment No. 75502, on April 8, 1919; thence S 62°49' E along the northeasterly line of said county tract, a distance of 93.00 feet to a point; thence S 55°44' E continuing along said Multnomah County tract, a distance of 31.27 feet; thence N 89°57' W, a distance of 209.23 feet to a point on the westerly line of that tract of land conveyed to Multnomah County, by deed recorded October 13, 1934, in Book 268, Page 351, Deed Records of Multnomah County, Oregon; thence N 00°38' E along said westerly line, a distance of 60.00 feet to the northwest corner thereof; thence S 89°57' E along the northerly line of said county tract, a distance of 100.00 feet to the point of beginning.

Containing 9,456 square feet, more or less.

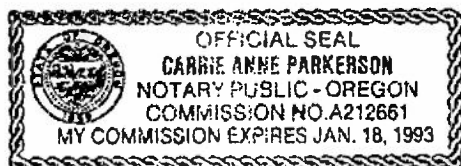

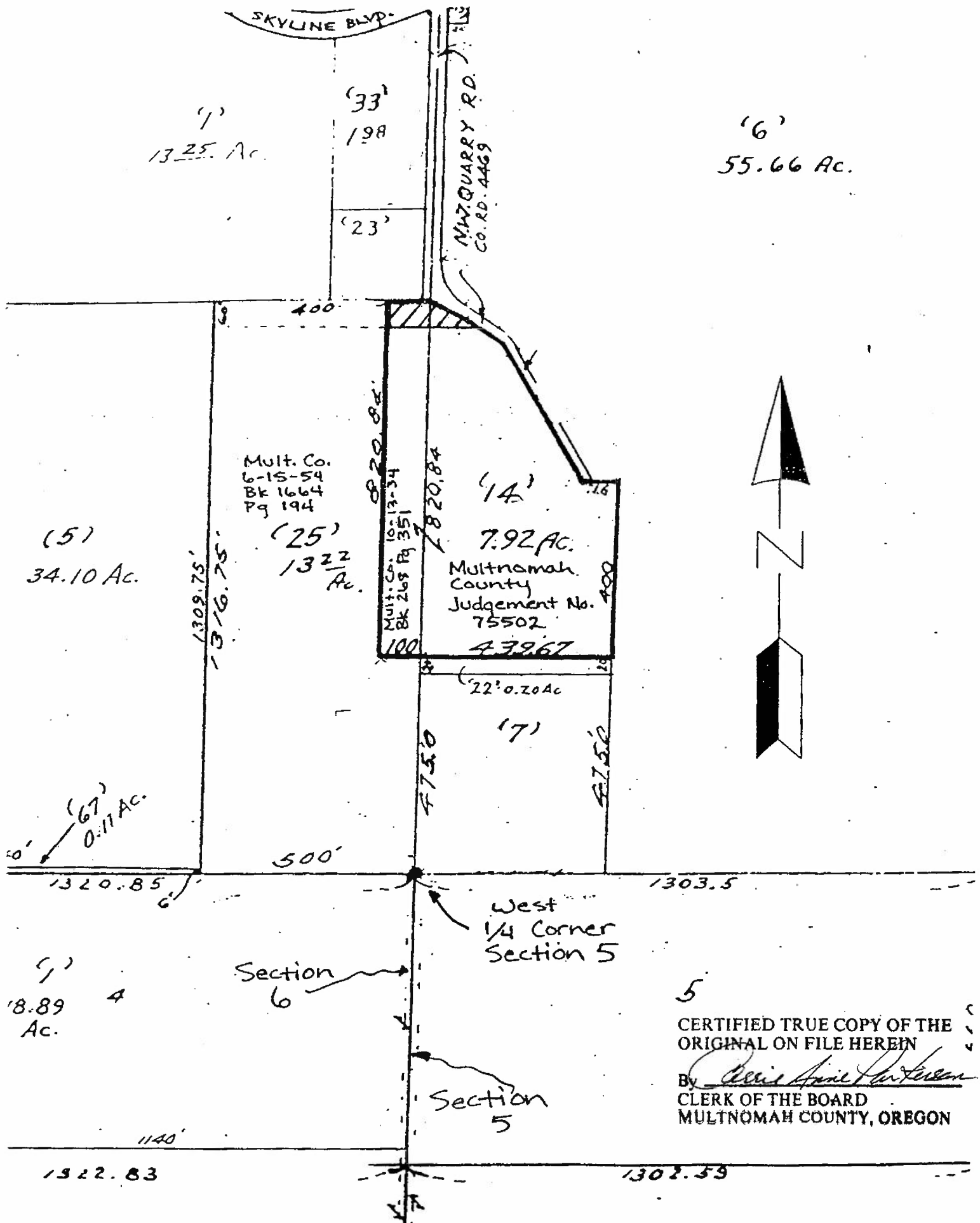
