REGULAR MEETING

Chair Diane Linn convened the meeting at 9:30 a.m., with Vice-Chair Lonnie Roberts and Commissioners Lisa Naito, Serena Cruz Walsh and Maria Rojo de Steffey present.

COMMISSIONER ROJO MOVED AND COMMISSIONER CRUZ SECONDED, APPROVAL OF R-1. JAMES OPOKA EXPLANATION. BUDGET MODIFICATION UNANIMOUSLY APPROVED.

COMMISSIONER CRUZ MOVED AND COMMISSIONER ROBERTS SECONDED, APPROVAL OF R-2. BENJAMIN CHAMBERS EXPLANATION. BUDGET MODIFICATION UNANIMOUSLY APPROVED.

COMMISSIONER CRUZ MOVED AND COMMISSIONER NAITO SECONDED, APPROVAL OF R-3. JAMES OPOKA EXPLANATION. BUDGET MODIFICATION UNANIMOUSLY APPROVED.

AT THE REQUEST OF CHAIR LINN AND UPON MOTION OF COMMISSIONER ROJO, SECONDED BY COMMISSIONER NAITO, CONSIDERATION OF THE FOLLOWING ITEM WAS UNANIMOUSLY APPROVED.

COMMISSIONER ROJO MOVED AND COMMISSIONER CRUZ SECONDED, APPROVAL OF UC-1. COMMISSIONER ROJO READ PROCLAMATION AND COMMENTED IN SUPPORT. CHAIR LINN AND COMMISSIONER CRUZ COMMENTED IN SUPPORT. PROCLAMATION 06-007 UNANIMOUSLY APPROVED.

R-4 RESOLUTION Directing Facilities and Property Management to Prepare a Major Facilities Capital Project Plan for an East County Court Facility Consisting of Four Courtrooms (With Expansion Capability to Six Courtrooms) and Associated Offices and Redirecting Funds to Construction of Such a Facility

COMMISSIONER NAITO MOVED AND COMMISSIONER CRUZ SECONDED, APPROVAL OF R-4. COMMISSIONER NAITO MOVED AND COMMISSIONER CRUZ SECONDED, APPROVAL OF AMENDMENT DELETING RESOLUTION RESOLVE 2. COMMISSIONER NAITO EXPLANATION, ADVISING THE RESOLVE WAS A RESULT OF A MISCOMMUNICATION AND THAT IT WAS NOT HER INTENT TO USE FUNDS ALLOCATED FOR CONSTRUCTION OF AN EAST COUNTY JUSTICE FACILITY FOR CONSTRUCTION OF AN EAST COUNTY COURT FACILITY. CHAIR LINN AND COMMISSIONER ROBERTS COMMENTS IN OPPOSITION TO AMENDMENT AND ADVOCATING REPLACEMENT OF THE HANSEN BUILDING. COMMISSIONER NAITO RESPONDED THAT DELETING RESOLVE 2 WILL LEAVE THE POLICY AS IT WAS ADOPTED IN RESOLUTION 04-159 AND EXPLAINED THERE WAS A MISCOMMUNICATION IN PREPARATION OF THE RESOLUTION AND THAT THERE IS BOARD AGREEMENT ON THE NEED TO REPLACE THE HANSEN BUILDING. AMENDMENT UNANIMOUSLY APPROVED.

COMMENTS. RESOLUTION UNANIMOUSLY POSTPONED INDEFINITELY.

R-5 Discussion of Multnomah County Fiscal Year 2005-2006 Supplemental Budget Proposal. Presented by Commissioner Lonnie Roberts and Chair Diane Linn.

ROB NOSSE, OREGON NURSES ASSOCIATION REPRESENTATIVE AND BECKY STEWARD, LOCAL 88 REPRESENTATIVE, TESTIMONY AGAINST SUPPLEMENTAL BUDGET AND IN FAVOR OF WAITING FOR 2007 BUDGET HEARING PROCESS. JANE KELLEMEYER AND ALICIA NUÑEZ TESTIMONY IN SUPPORT OF FUNDING FOR SUN SCHOOL PROGRAM SERVICES AND AGAINST SUPPLEMENTAL BUDGET. MAGGIE MILLER OF CITIZENS CRIME COMMISSION TESTIMONY AGAINST SUPPLEMENTAL BUDGET AND URGING BOARD TO WAIT UNTIL 2007 BUDGET HEARING PROCESS. MICHAEL HARRIS TESTIMONY IN SUPPORT OF SCHOOL FUNDING AND AGAINST SUPPLEMENTAL BUDGET. ANNA OLONBY AND CHERYL TROSPER TESTIMONY IN SUPPORT OF FUNDING FOR EARLY CHILDHOOD AND SUN SCHOOL PROGRAM SERVICES AND AGAINST SUPPLEMENTAL BUDGET. KENAN GINSBERG, KRISTA LARSON, JACKIE JAFFE AND AARON MCKINNEY

TESTIMONY IN SUPPORT OF FUNDING FOR SUN SCHOOL PROGRAM SERVICES AND AGAINST SUPPLEMENTAL BUDGET.

COMMISSIONER NAITO EXPLAINED THAT THE SUPPLEMENTAL BUDGET DOES NOT EXPEND FUNDS NOW BUT LENDS MONEY FOR BRIDGE CONSTRUCTION AND BUYING DOWN DEBT. COMMISSIONER NAITO EXPRESSED CONCERN REGARDING COMMENTS SUGGESTING CUTS TO SUN SCHOOL FUNDING AND SUGGESTED THE CHAIR RELEASE HER EXECUTIVE BUDGET IN MARCH RATHER THAN MAY TO ALLOW MORE TIME FOR FINANCIAL DECISIONS DURING THE 2007 BUDGET PROCESS. CHAIR LINN EXPLAINED SHE WANTS THE BOARD TO WORK WITH TOGETHER WITH STAFF AND THE BUDGET OFFICE TO IDENTIFY ANOTHER WAY TO FUND BRIDGE CONSTRUCTION RATHER THAN BORROWING GENERAL FUND DOLLARS. CHAIR LINN ADVISED HER EXECUTIVE BUDGET WILL INCLUDE MODEST SUMS FOR WAPATO AND SCHOOL FUNDING AND REITERATED HER DESIRE FOR THE COMMISSIONERS TO ALLOCATE FUNDS DURING THE 2007 BUDGET PROCESS RATHER THAN DOING SO WITH A 2005-2006 SUPPLEMENTAL BUDGET.

COMMISSIONER CRUZ EXPRESSED CONCERN OVER COMMUNITY MISINFORMATION AND ASKED DEPUTY BUDGET DIRECTOR MARK CAMPBELL TO COME TO THE PRESENTER TABLE. MR. CAMPBELL EXPLAINED THAT TECHNICALLY THE COUNTY IS NOT EXPENDING MONEY IN THE SUPPLEMENTAL BUDGET EXCEPT FOR AN \$8 MILLION BRIDGE LOAN TO BE REPAYED OVER TIME, AND THE REST OF THE POTENTIAL EXPENDITURES WILL BE SUBMITTED AS PROGRAM OFFERS FOR LATER VOTE. CHAIR LINN COMMENTED THAT THE LOAN REPAYMENT WOULD TAKE YEARS AND ADVISED SHE HAS FOUND \$3 MILLION WHICH COULD BE USED FOR BRIDGE CONSTRUCTION. COMMISSIONER CRUZ STATED THAT THERE IS \$21 MILLION ONE TIME ONLY FUNDING AND EXPRESSED CONCERN THAT THE CHAIR IS ADVISING SHE WON'T RELEASE HER EXECUTIVE BUDGET UNTIL MAY BUT IS ALSO MAKING PUBLIC STATEMENTS REGARDING WHAT SHE WILL BE FUNDING. MARK CAMPBELL RESPONSE TO QUESTION OF COMMISSIONER ROBERTS REGARDING THE STATE BUDGET. CHAIR LINN STATED THAT HISTORICALLY THE MULTNOMAH COUNTY CHAIR SUBMITS THE EXECUTIVE BUDGET IN MAY AND REITERATED HER DESIRE TO DISCUSS ANOTHER WAY TO FUND THE SAUVIE ISLAND BRIDGE CONSTRUCTION. COMMISSIONER ROJO ADVISED SHE WOULD BE VERY INTEREST TO SEE WHERE THE \$3 MILLION IS COMING FROM. CHAIR LINN STATED SHE WANTS TO SETTLE THIS ISSUE BEFORE NEXT WEEK.
