ORDINANCE NO. 453 \_\_

An ordinance establishing the Multnomah county Task Force on Waste Disposal Procedures.

Multnomah County ordains as follows:

SECTION I. FINDINGS.

The Board of County Commissioners finds that there is a need to:

- A. Identify waste disposal criteria and procedures which have broad-based community support;
- B. Cooperate with METRO in the development and application of waste disposal procedures so that public resources will not be wasted in disputes over the appropriateness of procedures;
- C. Improve communications between various groups affected by the waste disposal process so that all viewpoints are accounted for in the development of waste disposal procedures.

SECTION II. PURPOSE AND DUTIES.

There is hereby established a Multnomah County Task Force on Waste Disposal Procedures. The charge of the Task Force is to prepare and submit to the Board of County Commissioners a report with the following contents:

- A. A critique of the siting criteria used in METRO'S most recent site selection process and suggestions for improvements in these criteria;
- B. Suggestions for improvements in the process of applying site selection criteria to various sites, including appropriate citizen involvement procedures;
- C. Recommendations of solid waste management procedures which are appropriate for the County.

This report shall be filed with the Clerk of the Board within sixty (60) days following the appointment of all members of the Task Force. Staffing for the Task Force will be provided by the Department of Environmental Services, the Board of County Commissioners and the County Counsel Division of the Department of General Services.

SECTION III. MEMBERS.

The Task Force shall be composed of eight (8) members appointed by the County Executive with the approval of the Board of County Commissioners to be appointed on or about January 10, 1985. The membership of the Task Force shall be as follows:

- A. Two members of the Board of County Commissioners, one of whom shall chair the Task Force;
- B. Two members of the METRO council;
- C. A representative of the West Hills and Island Neighbors, Inc.;
- D. A representative of the St. John's neighborhood;
- E. A representative of the Sierra Club - Columbia Group.
- F. A representative of the Steamfitters Local Union 235.

SECTION 4. TERM.

Each member shall serve until the final report is given to the Board of County Commissioners.

SECTION 5. VACANCIES.

A vacancy on the Task Force shall be filled by appointment of the County Executive and with the approval of the Board.

SECTION 6. COMPENSATION.

Members shall receive no compensation for serving on the Task Force.

SECTION 7. Conflict of Interest.

Any member of the Task Force who has monetary or investment interest in any matter before the Task Force shall so inform the Task Force.

SECTION 8. AUTOMATIC TERMINATION.

The task force shall automatically be dissolved and cease to exist, without the necessity of any action by the Board of County Commissioners, upon the filing of the Task Force's report with the Clerk of the Board.
