

**AMENDMENT NUMBER 1
TERMINATION
LOCAL AGENCY AGREEMENT
American Recovery and Reinvestment Act of 2009

Multnomah County**

The **State of Oregon**, acting by and through its Department of Transportation, hereinafter referred to as “State,” and Multnomah County, acting by and through its elected officials, hereinafter referred to as “Agency,” entered into agreement number 25578 on May 12, 2009 (“Agreement”). Said Agreement covers the funding and execution of a paving project on SE 282nd Avenue in Multnomah County.

It has now been determined by State and Agency that the Agreement referenced above shall be terminated in its entirety as memorialized in this amendment (“Amendment”). The reason for the termination is that the project as defined in Agreement has been canceled.

Agreement number 25578 with Agency is hereby terminated in its entirety.

This Amendment may be executed in several counterparts (facsimile or otherwise) all of which when taken together shall constitute one agreement binding on all parties, notwithstanding that all parties are not signatories to the same counterpart. Each copy of this Amendment so executed shall constitute an original.

THE PARTIES, by execution of this Amendment, hereby acknowledge that its signing representatives have read this amendment, understand it, and agree to be bound by its terms and conditions.

This Project is amended into the 2008-2011 Statewide Transportation Improvement Program, (Key #16603) that was approved by the Oregon Transportation Commission on November 14, 2007 or will subsequently be approved by amendment to the STIP.
