**RESOLUTION NO. 05-142**

Authorizing the Private Sale of a Tax Foreclosed Property to LANCE WOODYARD AND ANITA BOUMA

**The Multnomah County Board of Commissioners Finds:**

- a. Multnomah County acquired the real property described in Exhibit A through the foreclosure of liens for delinquent property taxes.
- b. The property has an assessed value of \$1,100 on the County's current tax roll.
- c. Although no written confirmation was obtained from the City of Portland, the Tax Title Division is confident that the shape and size of the property, approximately 1,742 square feet, and its location make it unsuitable for the construction or placement of a dwelling thereon under current zoning ordinances and building codes, as provided under ORS 275.225.
- d. LANCE WOODYARD AND ANITA BOUMA have agreed to pay \$1,100, an amount the Board finds to be a reasonable price for the property in conformity with ORS 275.225.


**The Multnomah County Board of Commissioners Resolves:**

1. Upon Tax Title's receipt of the payment of \$1,100, the Chair on behalf of Multnomah County, is authorized to execute a Bargain and Sale Deed conveying to LANCE WOODYARD AND ANITA BOUMA, the real property described in the attached Exhibit A.




