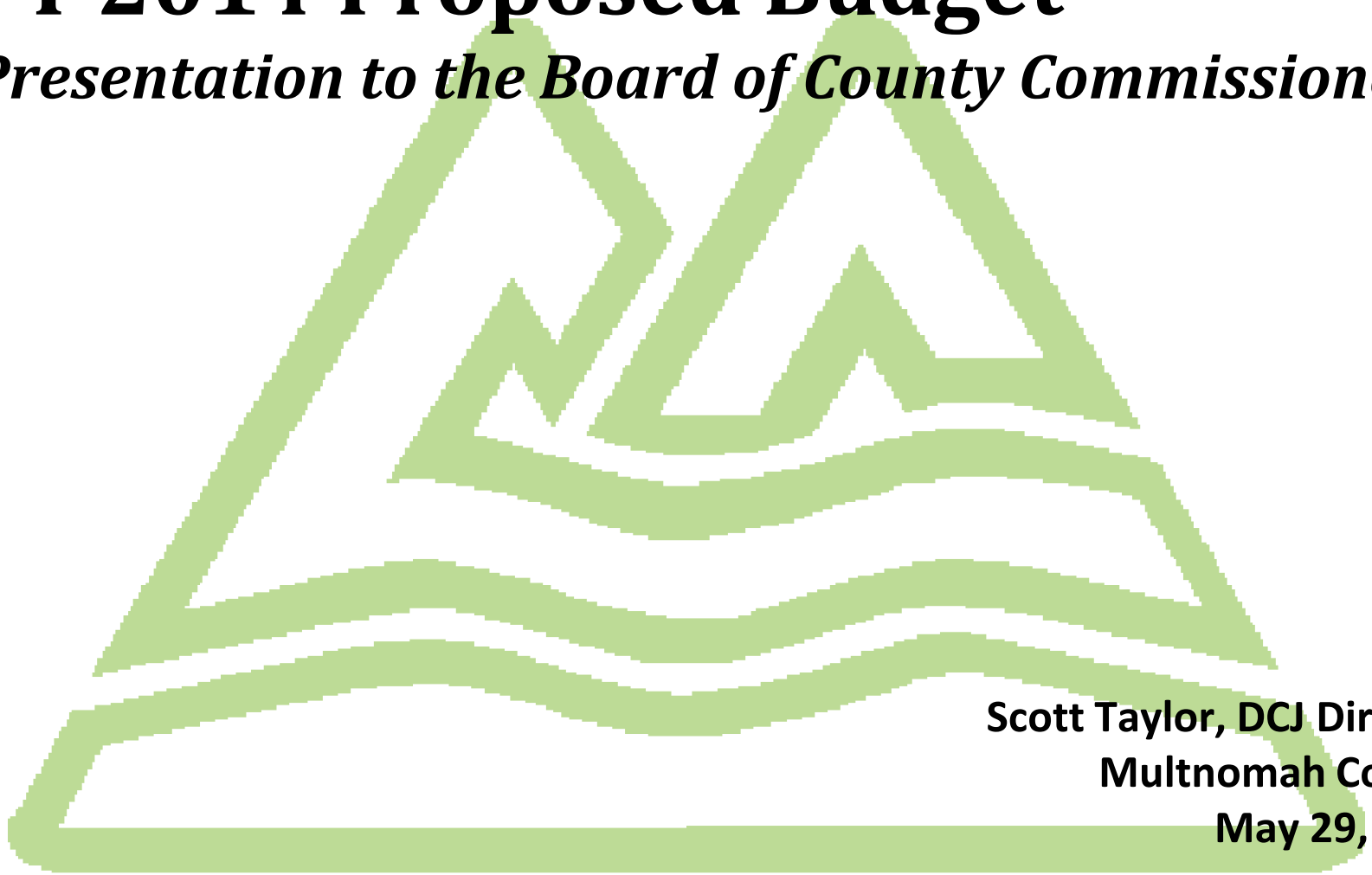

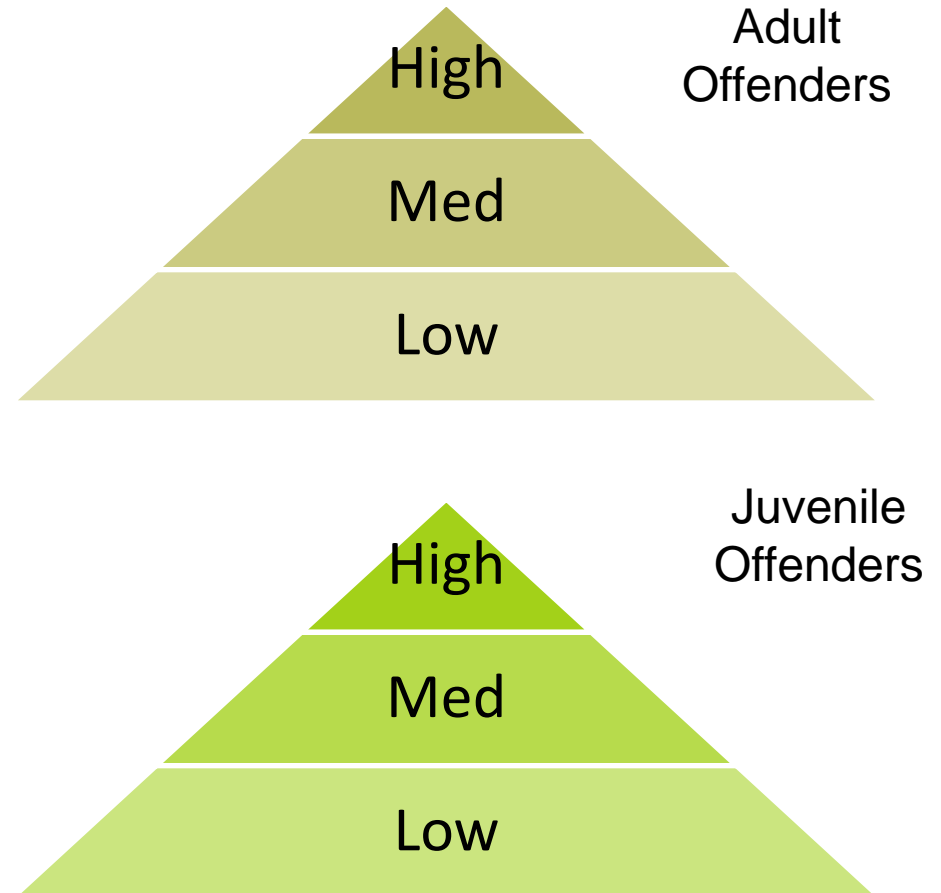

# FY13 Key Accomplishments

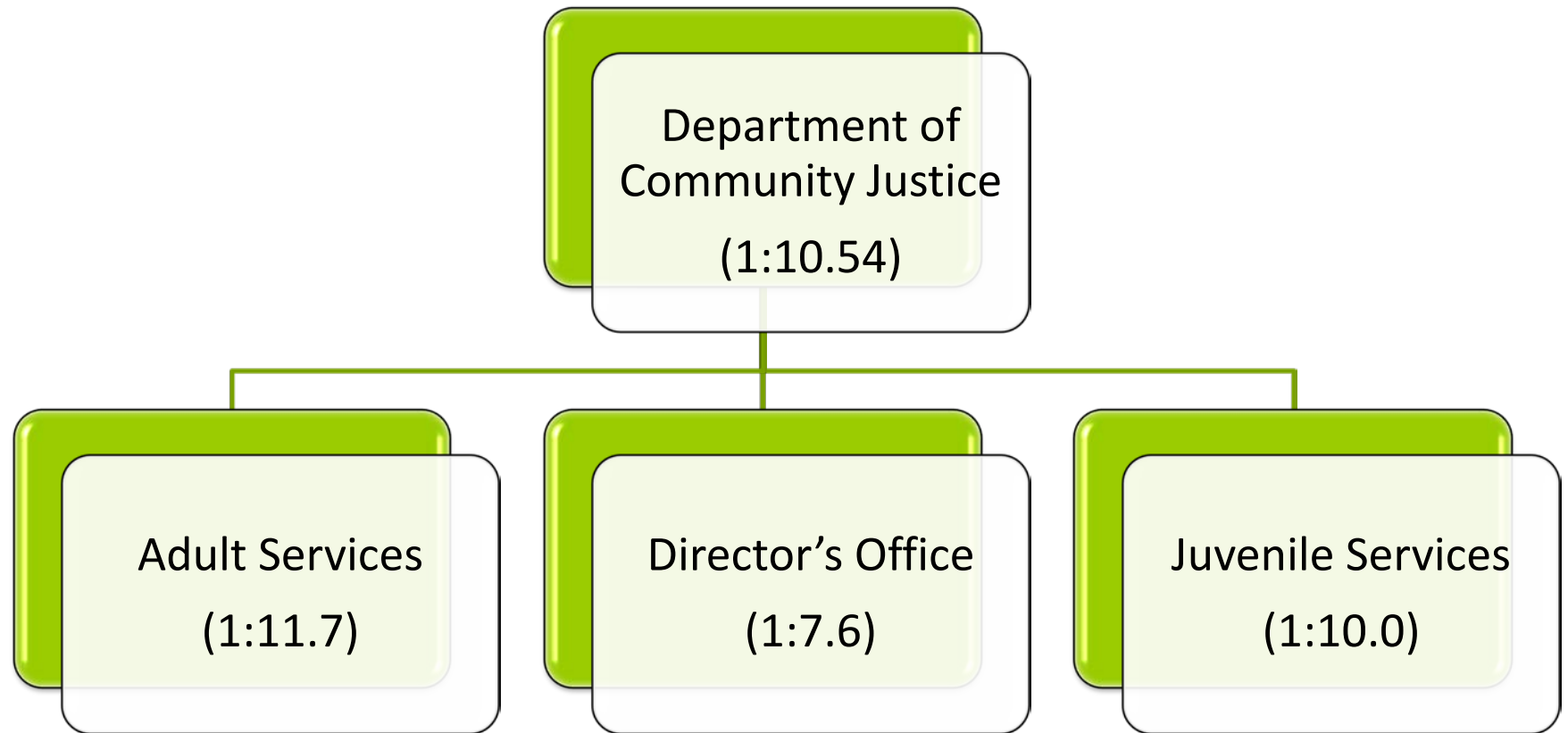
---

  - Established unit centered on needs of crime victims

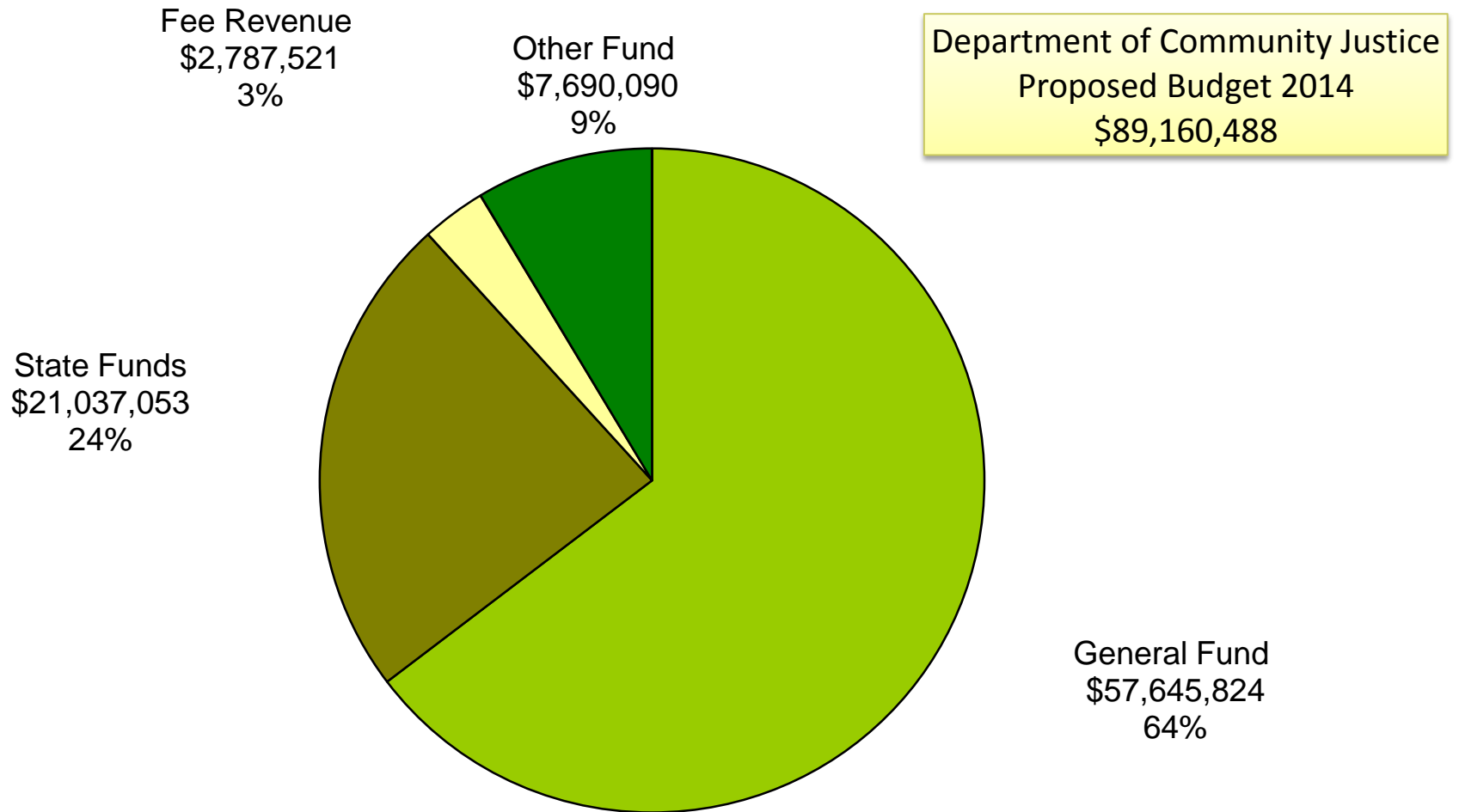


# FY14: Organizational Chart

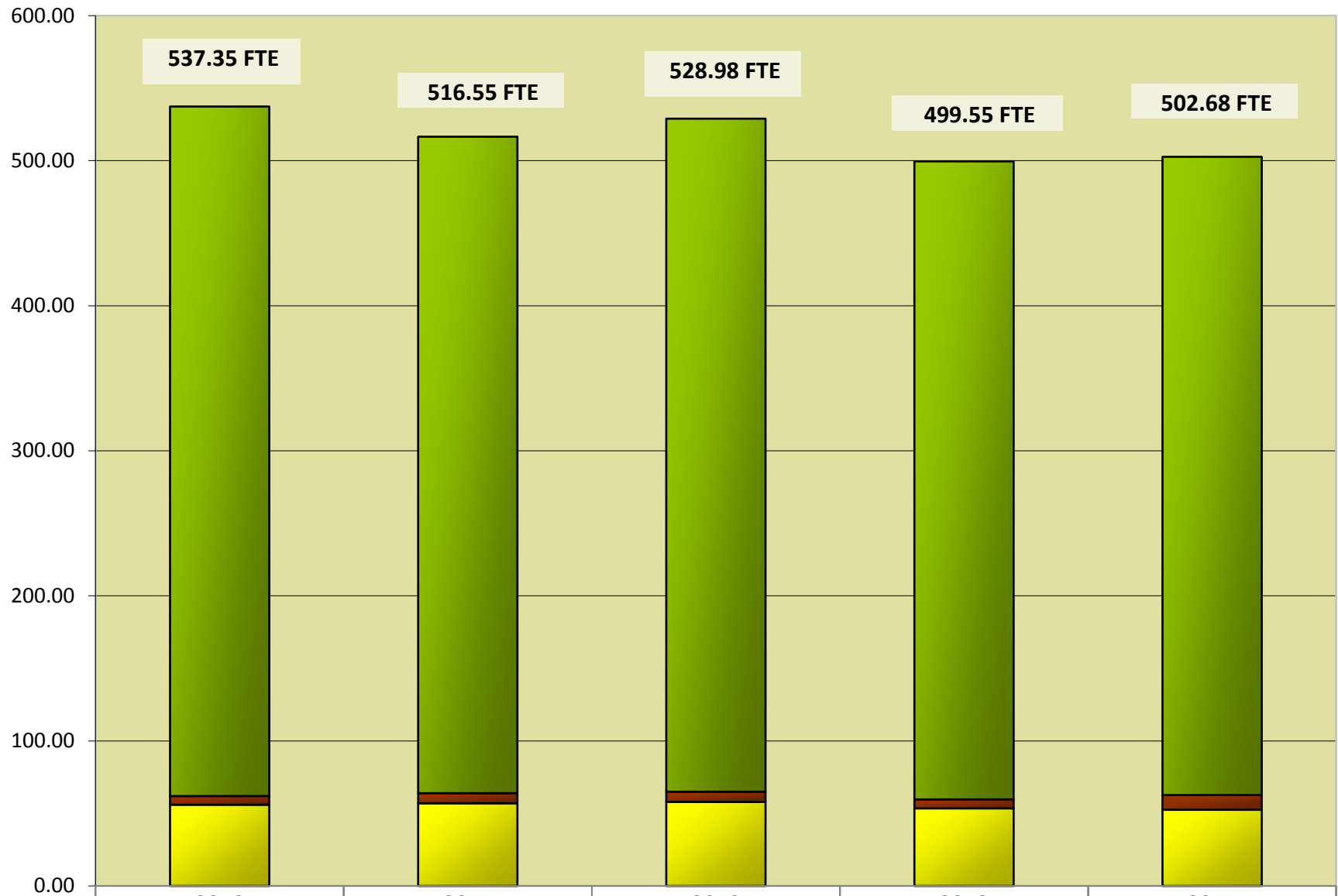

# DCJ FY14 Proposed Budget

## One-Time-Only Funding

### #50012B Juvenile Intercept Program \$293K

- Targets youth most likely end up in the “deep end” of the juvenile justice system
- Provides treatment to youth and their families in their own homes at times convenient for the families.



# DCJ FY14 Proposed Budget

## Innovative & New

### #50035 Assessment & Referral Center \$5.5M

- Combines Intake Unit & Transition Services Unit
- 31 FTE Including 2 new FTE
- \$1.5M in contracts

### #50054B Web-Enhanced Bench Probation \$444K

- Adds 4 FTE
- Contract for Electronic Case Management Service
- \$344K to be generated from new supervision fees



# DCJ FY14 Proposed Budget

---

## Additional Keeps

### **#50003B Crime Victims Unit - Expanded Collaboration \$116K**

- Funds 1 FTE CSEC Position
- Facilitates multi-disciplinary collaboration
- 95% of DCJ staff have been trained in CSEC awareness

### **#50036B Multnomah County Re-entry Resource Center \$288K**

- General funds to continue grant funds that are expiring
- Supports men and women transitioning out of county or state institutions back to the community



# DCJ FY14 Proposed Budget

---

## Additional Keeps

### #50028 Community Healing Initiative (CHI) \$449K

- Funds culturally-specific contracts in partnership with DCHS



### #50056 State Funding Adjustment \$1.19M

- Replaces OTO with state funds due to state funding adjustments
- Provides 40 Outpatient Treatment Slots, 29 Housing Beds
- Expands the Assessment & Referral Center by 2 FTE and 2 program specialists for department-wide services
- Funds the Community Partners Reinvestment (CPR) program that works with men in the jail, ages 18 – 25, and provides pre-release and post-release services



# DCJ FY14 Proposed Budget

---

## Reductions

### **#50017 Community Detention/Electronic Monitoring**

- Reduces 6 FTE
- Continues services through a contract with community provider
- Mitigation strategy: Reorganization & Voluntary Retirement Program

### **#50025 Juvenile Community Service & Project Payback Program**

- Reduces 1.5 FTE
- Creates efficiencies by consolidated functions with Adult Community Service
- Mitigation strategy: Reorganization & Voluntary Retirement Program





# DCJ FY14 Proposed Budget

---

## Reductions

### **#50042 Adult Family Services Unit**

- Reduces 1 FTE
- Mitigation strategy: Voluntary Retirement Program

### **# 50040 Adult Sex Offender Supervision & Treatment**

- Adult sex offender treatment contracts reduced by \$85K

### **# 50037A Adult Field Services-High Risk Generic Supervision**

- Employment support services contract reduced by \$65K



# DCJ FY14 Proposed Budget

---

## Other Reductions

### **#50023 Juvenile High Risk Unit - RISE**

- Reduces 1 FTE
- Funding for this position ended in FY13

### **# 50019 Juvenile Intake, Assessment, Intervention & Adjudication (IAIA)**

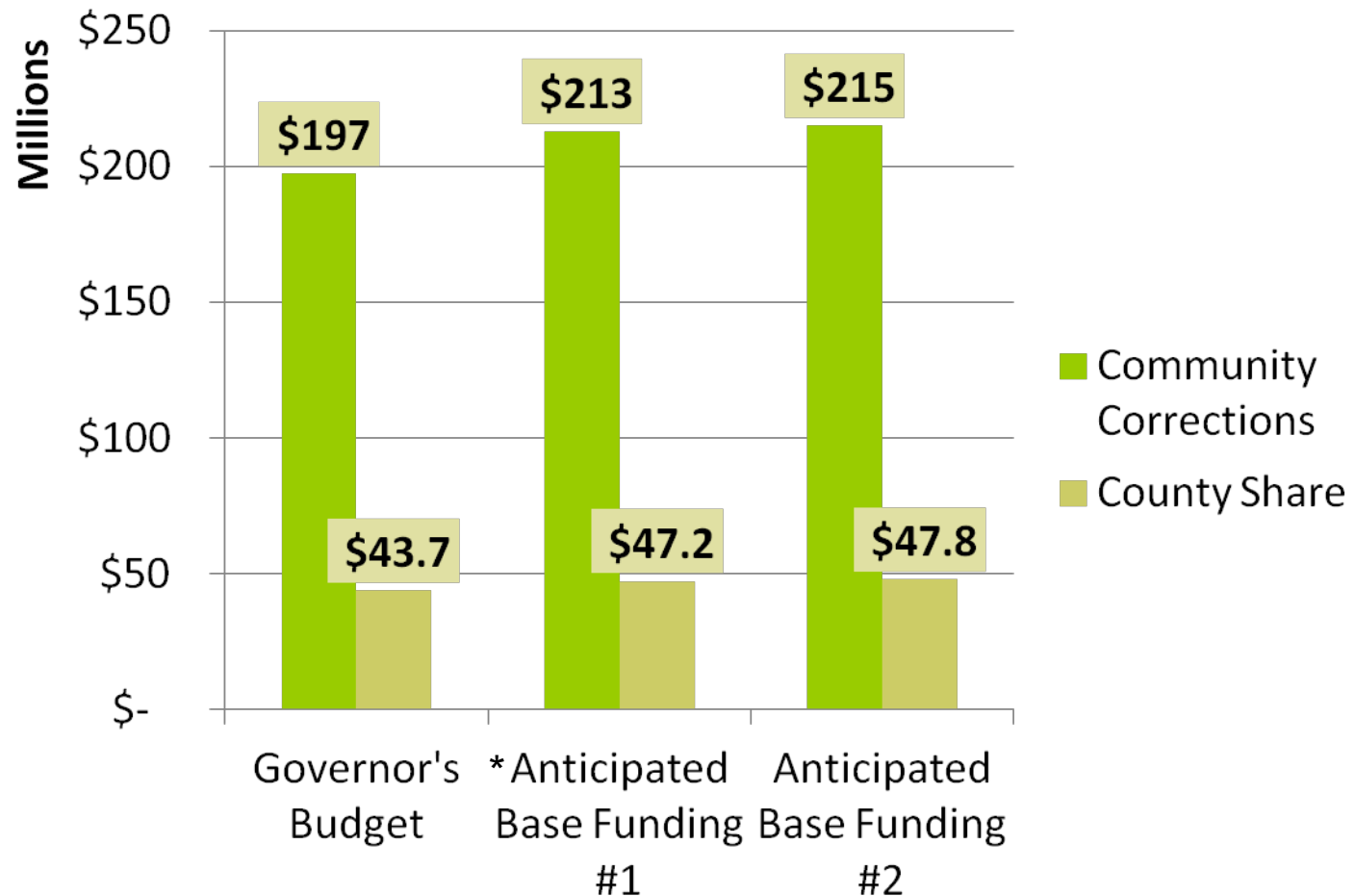
- Reduces 2 half-year positions
- Funding for these positions ended in FY13

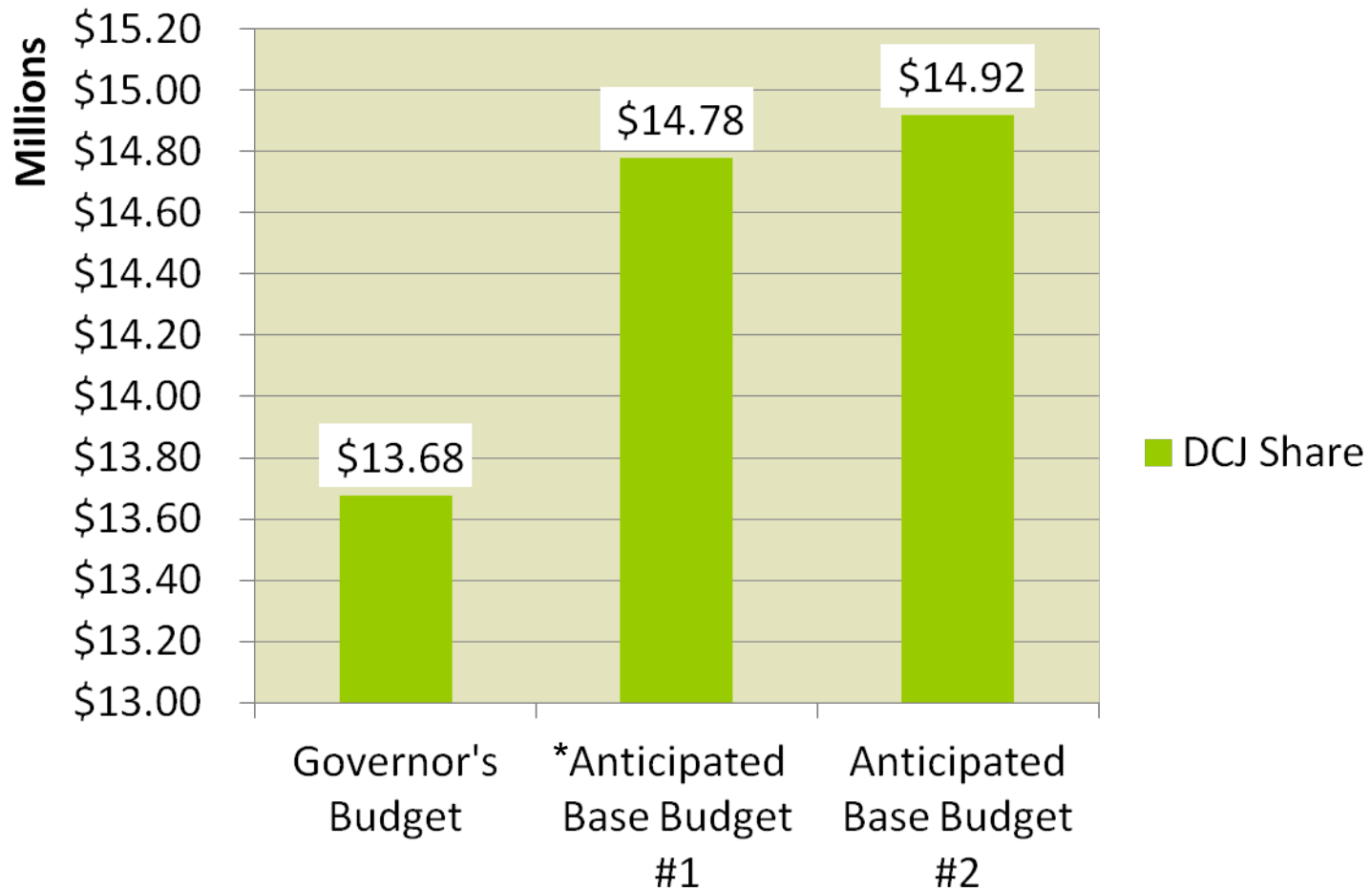
### Community Corrections Statewide Biennial Funding

# DCJ FY14 Proposed Budget

---

## Opportunities: New Federal Funding Source

### Title IV-E:

- A federal entitlement program for child welfare services
- Requires partnership and agreement with State
- Revenue Potential \$500K-\$1M
- Proposed Budget includes \$500k in expanded juvenile intercept program, shelter beds, 1 FTE case manager, and pro-social skill-building services.





# DCJ FY14 Proposed Budget

---

## Challenge:

### Realizing the Full Potential of Healthcare Reform

- Criminal justice populations are *over 7 times* more likely than the general population to meet the criteria for substance dependence
- Criminal justice populations have higher rates of serious mental illness and chronic medical conditions.
- Only about 10% currently have health insurance.
