General Information

1. What action are you requesting from the Board?

Request Board approval to reallocate adopted budgets from the following projects:

\$ 130,000 Justice Center Siemens Upgrade (shared);
\$ 50,000 Justice Center Roll-up Gates (shared);
\$ 20,000 Justice Center West side Atrium window (shared);
\$ 50,000 Reduce the Justice Center Macerator project, was \$100,000;
\$ 150,000 Mead Building Exterior project;
\$ 400,000 Total

The funds would be reallocated to the Justice Center Cooling Towers Project for a total increase of \$400,000 (shared) for a new FY11 Justice Center Cooling Tower project budget total of \$781,900.

Please note that "(shared)" means the projects are funded jointly by the Multnomah County and the City of Portland as per the Condominium association agreement.

2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

FY11 Program Offer 72071 - Program Offer 72071 totals will not be affected

During the course of project to replace one of the two cooling towers, the City of Portland requested that we replace both cooling towers at the same time. The second cooling tower is nearing the end of its life cycle. Further, there are project efficiencies related to project implementation to replace both towers at the same time. The two cooling towers on the Justice Center are critical systems.

The Justice Center Cooling Tower project is a shared cost with the City of Portland. Three projects selected for reallocation are also shared with the City.

3. Explain the fiscal impact (current year and ongoing)

The impact is to the individual project budgets and will not affect the overall FY11 Capital Improvement Program (CIP) budget.

Approval of this reallocation will result in some adjustments in the five-year Capital Improvement Program plan as follows:

- a. The Justice Center Siemens upgrade project is being delayed pending the outcome of the current Building Automation System upgrades being completed and their impact evaluated. If further changes to the building systems are needed, then the project will be placed in the Capital Improvement Program in a future year.
- b. The Justice Center Roll-up Gates project has had maintenance performed that appears to have corrected the deficiencies and lengthened its current life.
- c. The Justice Center West Side Atrium Window project may not need replacement as originally proposed and a less expensive repair is going to be made to see if that will correct the problem. If repair doesn't work then the project will be evaluated to determine the best replacement funding strategy.
- d. The Justice Center Macerator project is a system design review project to determine if a macerator system modification is necessary in order to improve performance.
- e. The Mead Building Exterior project was already scheduled as a multi-year project, and therefore, if this budget reallocation is approved, additional funds will be programmed in the County's Capital Improvement Program budget process.

The Capital Improvement Program five-year plan (FY12-FY16) is currently being requested and any other changes needed, if this budget reallocation is approved, will be incorporated as necessary.

The City of Portland condominium representative is in agreement with this budget reallocation.


