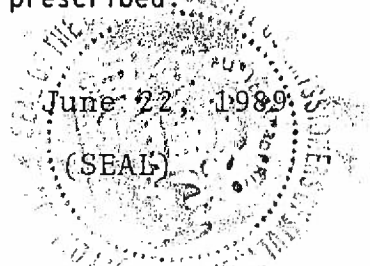
ORDER

ORDERED that the Clerk of the Board, acting on behalf of the Board of County Commissioners of Multnomah County, publish a notice as hereinabove prescribed.
