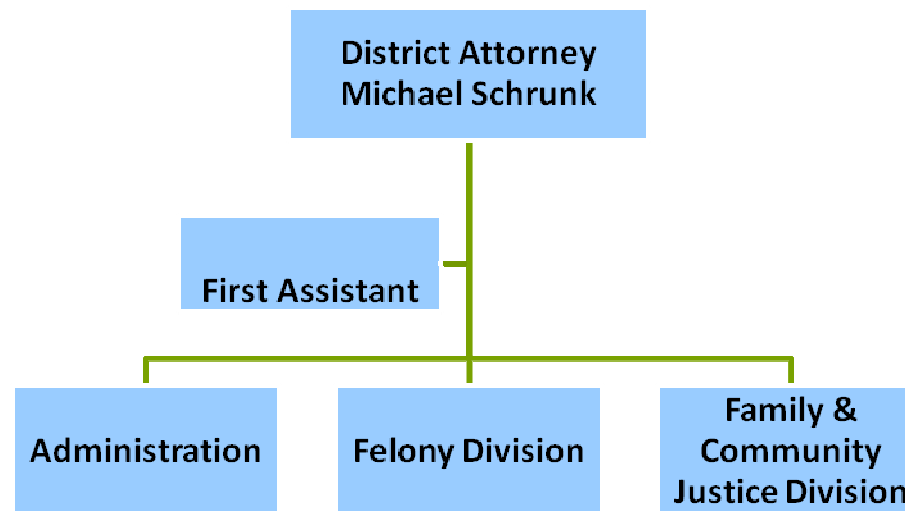

Organizational Org Chart



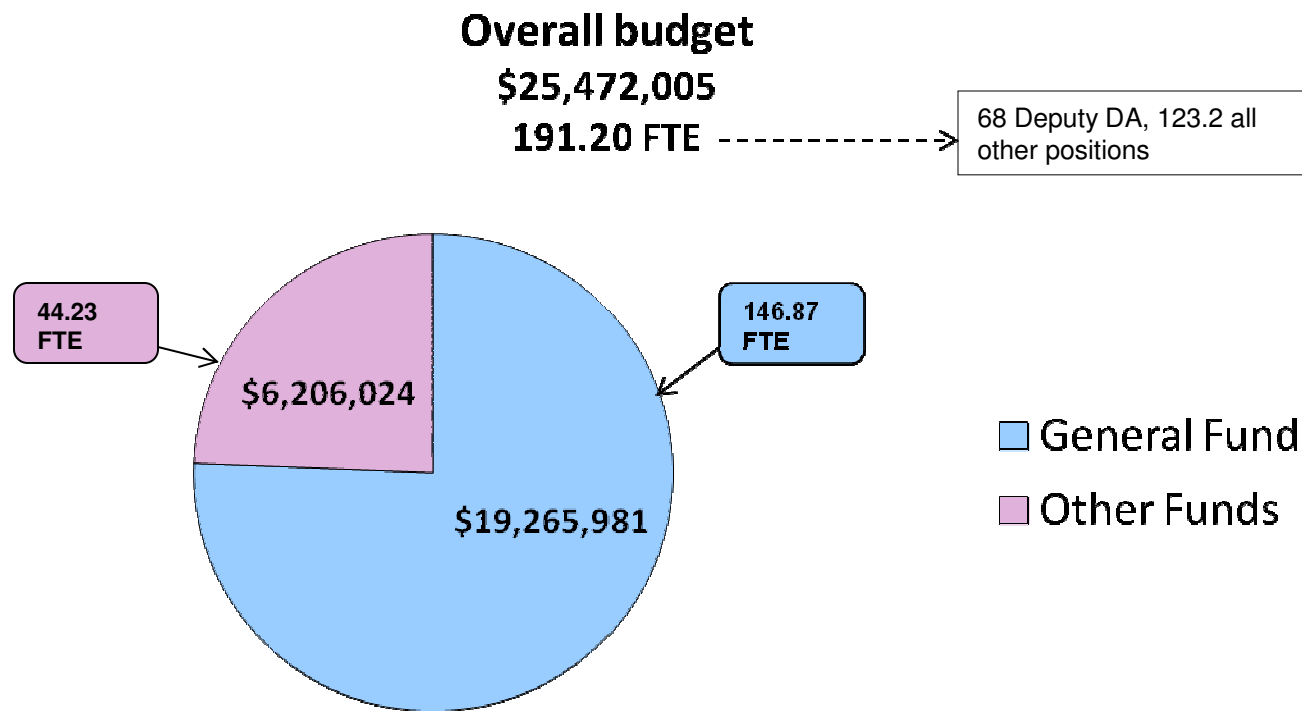
■ Span Ratio

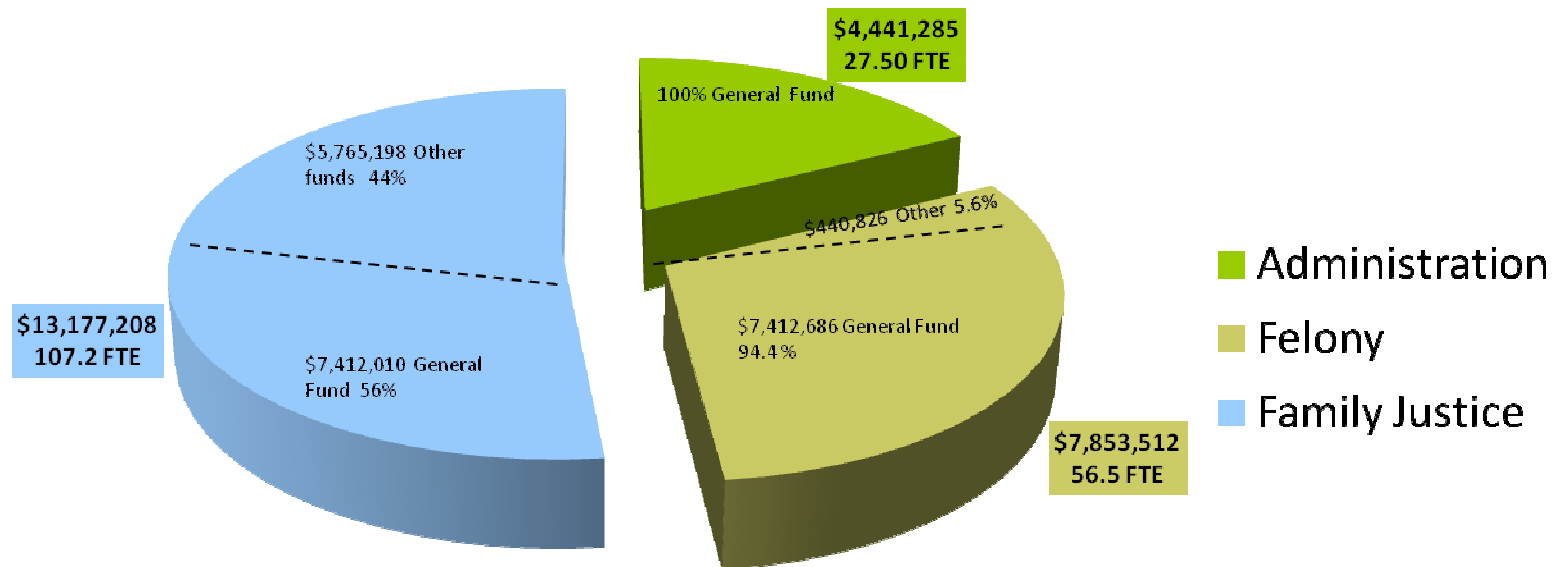

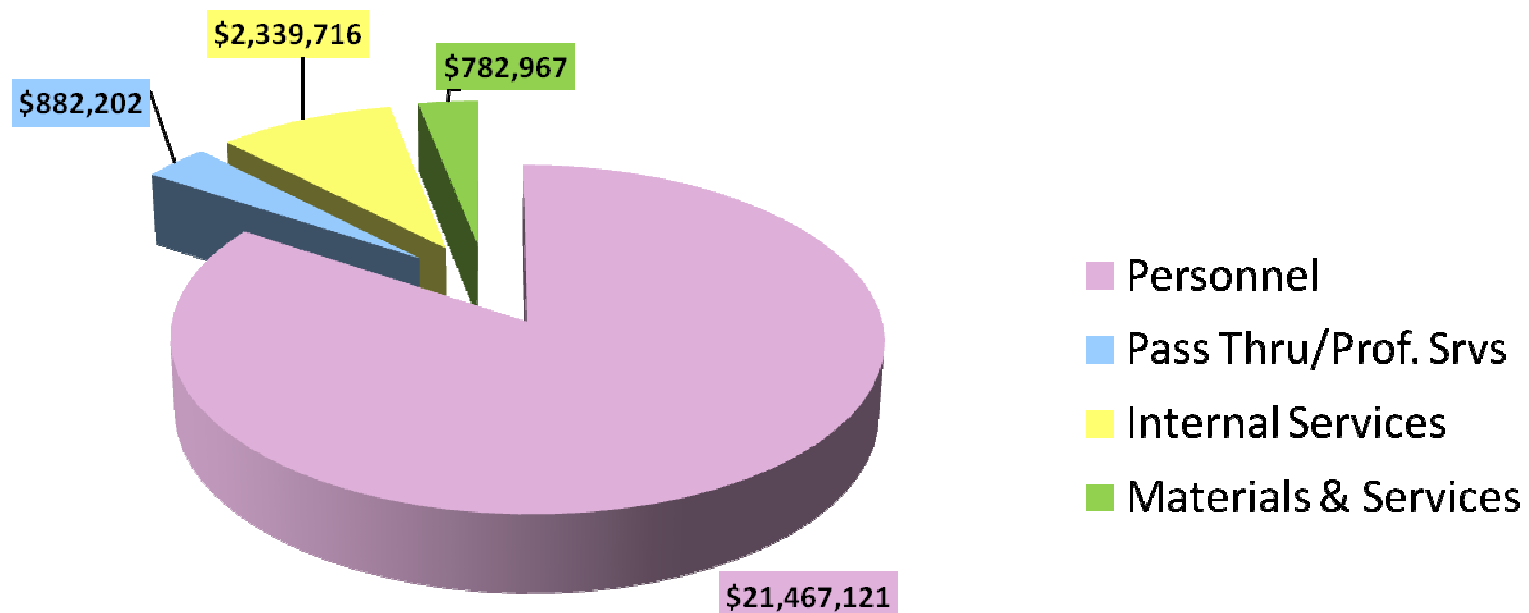

Property Crime Unit A, Drug Unit B, Unit C/Gangs, Unit D Violent Person Crime, Pre-Trial, Investigations

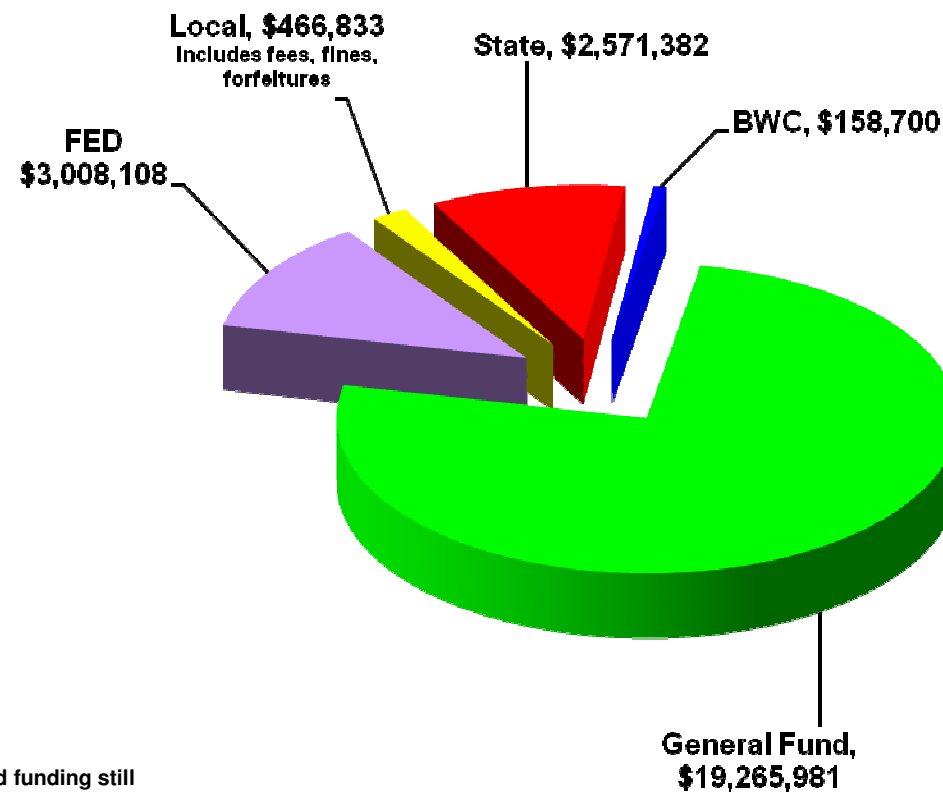

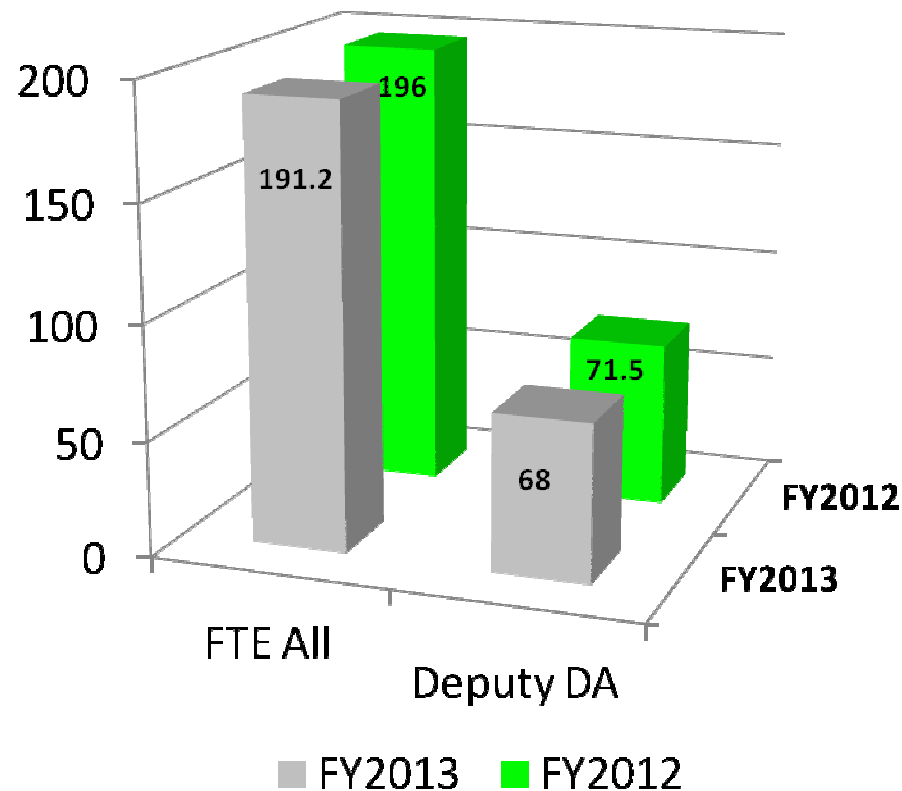
- Budget by funding source

Reduction of 1 Deputy District Attorney 2 \$116,242 County General Fund

Potential Cuts/status unknown at this time

- Program Offer 15007 B & C- Drug and Vice Unit
Reduction of .5 Deputy District Attorney 2 (Service Coordination Team) \$60,000 City funding
and 1 Deputy District Attorney 2 (Drug Impact Area) \$129,335 City funding
- Program Offer 15017B- Neighborhood DA Unit (Prostitution/Human Trafficking)

Keeps

■ Overview

The District Attorney's Office submitted twenty "In Target" Program Offers which provide administration and support for Felony, Misdemeanor and Juvenile trial units as well as programs for Victims Assistance and Child Support Enforcement.

Utilizing the Streams of Offenders framework to allocate resources, the office will continue to review approximately 7,000 high, medium and low level felony crimes and over 18,000 misdemeanor crimes annually.

With offices located in downtown Portland and the new East County Courthouse, the Child support Division will continue to provide enforcement, modification and paternity establishment services on 7250 cases and collect more than 32 million dollars during the next fiscal year.

The Office will continue its nationally recognized Neighborhood DA program working collaboratively with business associations and groups, neighborhood groups and law enforcement developing crime reduction strategies and prosecuting livability crimes.

With resources funded by the Board of Commissioners and a newly acquired grant from the state, the office is working to streamline and improve restitution services and collections for victims of crime seeking a measure of restorative justice.



District Attorney's Office FY 2013 Proposed Budget

State Impacts

- Small reductions in revenue for the Child Support Enforcement Program and the Juvenile Dependency contract will not impact our efforts in those areas next fiscal year.

Federal Impacts

- Fiscal issues at the Federal level continue to limit new grant opportunities for law enforcement and prosecutors and is reducing available funding in long standing grant sources.



District Attorney's Office FY 2013 Proposed Budget

Issues & Risks

- A surge in heroin abuse and overdose deaths
- Areas within the County impacted by drug activity
- Violent gang activity
- Human trafficking
- Data sharing amongst Public Safety Partners

Challenges

- Collaborative budgeting and strategic planning within the Criminal Justice Community
- Decreasing Federal and State funding opportunities
