General Information

1. What action are you requesting from the Board?

- The Multnomah County Sheriff's Office (MCSO) respectfully requests Board of Commissioners approve this amendment of Intergovernmental Agreement-0709008, which authorizes MCSO to provide law enforcement services to the City of Wood Village.

2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer(s) this action affects and how it impacts the results.

- Intergovernmental Agreement-0709008, authorizes MCSO to provide law enforcement services within the city limits of Wood Village. The City of Wood Village will pay MCSO for the cost of three patrol deputies, for a total of \$414, 249.00, in Fiscal Year 2018.
- Intergovernmental Agreement-0709008 relates to Program Offer 60063-18, Patrol Unit. Generally, MCSO's Patrol Unit members are responsible for the protection of Multnomah County residents and recreational visitors via emergency response, patrol, traffic education and enforcement. The Patrol Unit further provides emergency preparedness, assistance and intervention as part of the treatment service continuum. Patrol deputies and sergeants develop and implement community policing projects utilizing community based policing principles and frontline human services while providing safety to residents.

3. Explain the fiscal impact (current year and ongoing).

- Per Intergovernmental Agreement-0709008, Wood Village will pay MCSO \$414, 249.00, for law enforcement services in Fiscal Year 2018; this revenue has been anticipated and is included in the adopted budget accordingly.
