RESOLUTION NO. 00-124

Authorizing the Execution of Deed D001746 Upon Complete Performance of a Contract with
CARLTON A. and H. INEZ FRICE

The Multnomah County Board of Commissioners Finds:

- a) On 10/1/91, Multnomah County entered into a county contract 15185R2 recorded in county deed records at Book 2464 Page 2646 with CARLTON A. and H. INEZ FRICE for the sale of the real property hereinafter described;
- b) The above contract purchaser has fully performed the terms and conditions of said contract and is now entitled to a deed conveying said property to said purchaser;

The Multnomah County Board of Commissioners Resolves:

1. That the Chair of the Multnomah County Board of County Commissioners is authorized to execute a deed in a form substantially complying with the attached deed conveying to the contract purchaser the following described real property:

EXC OVERLAP IN HOMESTAKE GARDENS, LOT 7, BLOCK 4, SUNNY ACRES, a recorded subdivision in the City of Portland, County of Multnomah and State of Oregon.

2. The County's Division of Assessment and Taxation is authorized to forward the signed deed to the appropriate Escrow Officer under letter of instruction which shall provide: (a) that the deed is to be processed only upon the receipt by the County of all funds the County is due in consideration for the above described property, and all taxes and or municipal charges have been paid in compliance with ORS 307.100, and (b) that if the escrow is closed without the proper payment to the County the deed and any copies thereof shall be returned immediately to the County.

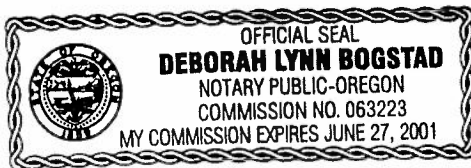
