This Matter before the Board is to offer to Surrender Jurisdiction to the city of Gresham, a portion of Towle Avenue, County Road No. 767, lying within and being within the corporate limits of the city of Gresham, for all purposes including repairs, construction and improvements, and the levying and collection of assessments therefor; and

It appearing to the Board that this Matter has been initiated through a letter from the city of Gresham, dated June 27, 1988, formally requesting the Board of County Commissioners to surrender jurisdiction to the city of Gresham unnecessary right-of-way as a result of construction and realignment of Eastman Parkway; and

It further appearing that this Matter before the Board is in accordance with ORS 373.270 initiating the proceeding for the transfer of jurisdiction of county roads within the limits of the city of Gresham to the city of Gresham, by public hearing; and

It further appearing that the public was notified by posting of notices on August 4, 1988, as per the attached affidavit, of the time, location, and portion of the county road for surrender of jurisdiction by Multnomah County to the city of Gresham;


It further appearing that by posting of the notices, the public was invited to attend a public hearing on this matter on August 25, 1988, to offer testimony and voice their concerns or support for that matter, to enable the Board of County Commissioners to determine whether it's in the best interest of the county to offer to surrender jurisdiction of the portion of Towle Avenue to the city of Gresham;

NOW THEREFORE, IT IS HEREBY ORDERED, and the Board hereby FINDS, that it is in the best interest of the county of Multnomah, to offer to surrender jurisdiction of a parcel of land in Section 9, T1S, R3E, W.M., Multnomah County, Oregon, described as follows:

All of SE 209th Avenue (Towle Avenue), County Road No. 767, lying between the south line of Lot 30, Block 3, LOOKING GLASS, a duly recorded plat of Multnomah County, Oregon (near SW Sixth Place) and the intersection thereof with the northline of the Portland Traction Co. Railroad.

FURTHER ORDERED, that the city of Gresham shall specifically accept jurisdiction of said county roads by appropriate ordinance,
