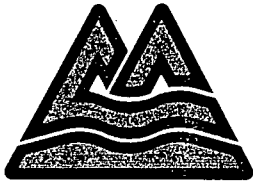

DOMESTIC VIOLENCE INITIATIVE

City of Portland - Multnomah County 1994-95 Budget Cycle

The City of Portland and Multnomah County each solicited public comment to help establish priorities in their current budget processes. The County's "Urgent Benchmarks", the City's "Your City, Your Choice" forums, and inter-jurisdictional work through The Progress Board have encouraged community involvement in priority setting and mutually reinforcing strategies. Consistently, domestic violence reduction emerges as a compelling concern.

Although important developments in intervention strategies have occurred in each jurisdiction over the last few years, the intractable problems necessitate additional effort and resources. In response Multnomah County Chair Beverly Stein and City Commissioner Gretchen Kafoury correlated their budget requests for domestic violence reduction to arrive at a joint proposal as outlined below.

As part of the City's process, Kafoury requested that the Budget Advisory Committee (BAC) of the Bureau of Housing and Community Development revisit the issue of domestic violence intervention in light of developments over the last year. Considerations included the award of a renewable grant from the State Criminal Justice Division, the start up of the new Domestic Violence Reduction Unit in the Police Bureau, and the loss of state funding for emergency housing.

In their recent deliberations, the BHCD BAC gave their highest priority to the development of additional transitional shelter capacity for women and children experiencing domestic violence. The opportunity to acquire and rehab the former Peninsula Child Care facility was answered by the allocation of existing resources for that project. The BAC's #1 add-package is a \$115,000 request for on-going funding to support the operational costs of the new facility.

The second priority of the BAC and Kafoury is a request for \$200,000 from the City to increase the capacity of the domestic violence emergency shelter/services system in cooperation with County efforts.

Concurrently, Chair Stein's office proposes allocating \$200,000 in additional resources to address domestic and child abuse. Domestic violence intervention strategies would receive \$100,000 and child abuse the other half.

I. Process of Proposal Development:

A work group on domestic violence composed of representatives from the Family Violence Intervention Steering Committee, service providers, and City/County staff developed the proposal using the following parameters:

- a) Design components for a projected \$300,000 in new resources between the two jurisdictions (City, \$200,000; County, \$100,000);
- b) Presume one-time-only funding from both City and County (the proposed components should be reviewed if on-going funding is available because different strategies and priorities might emerge)
- c) Develop components that are complementary to the anticipated renewal of a \$185,000 grant from the State Criminal Justice Division;
- d) Develop responses that take into account the increased capacities and attention of the Portland Police Bureau, the District Attorney's Office, Corrections Division, the Sheriff's office, and legal assistance programs;
- e) Increase resource development and coordinating capacity for the interdisciplinary system of domestic violence intervention; effective responses are highly interactive;
- f) Craft the proposal to increase stability in the system, provide more flexibility of response to the unmet needs, and build on proven techniques.

II. Documentation of Needs

The need for services for victims of domestic and sexual violence in Multnomah County is well-documented in locally published reports and corroborated by national studies. Included in the findings:

- * Domestic violence is the leading cause of injury for women and children; One-third of hospital emergency room cases are associated with family violence;
- * In Multnomah County in 1993, 21 homicides (a third of all homicides) resulted from domestic violence situations;
- * Domestic violence is the leading cause of homelessness for women and children;
- * Children in homes where domestic violence occurs are physically abused and seriously neglected at a rate 15 times higher than incidences in the general population;

- * Increased transitional housing and emergency shelter beds were the highest priority of the 1991 CHAS plan;
- * In 1992-93, 12,000 calls to 911 were logged as domestic violence related; the new police unit processed 1000 cases in the first 6 months of its operation;
- * In 92-93, the crisis lines recorded 22,000 requests for shelter and assistance; 80-90% of the time, no room was available in the 82 bed + vouchers emergency shelter system;
- * Effective police and justice system responses must be balanced with increased safe services for victims; arrest can serve as a deterrent or it can make the abusive situation more dangerous.
