### Director: Lee Po Cha, MBA



**IRCO is proud to announce the selection of Lee Po Cha, MBA, as our new Executive Director. Lee is succeeding IRCO's treasured former Executive Director, Sokhom Tauch, MBA, who is retiring after leading IRCO for the past 19 years.**

Lee has served IRCO since 1981 in a multitude of leaderships roles, most recently as Associate Director and Director of IRCO Asian Family Center, which he helped found in 1994. He has also played a pivotal role in the development of IRCO Africa House, breaking new ground in IRCO's commitment to providing culturally specific services for the increasingly diverse communities living in Oregon. A tireless advocate, Lee provides a voice for these communities through his service on numerous commissions and boards, including the Governor's Commission on Senior Services, co-chair of the New Portlander Policy Council, the Home for Everyone Board, past president of the All Hands Raised Board, past president of the Hmong American Community of Oregon, and co-founder of the Coalition of Communities of Color. In addition to this service, he empowers African, Slavic and Asian immigrant and refugee community leaders to organize and mobilize through community building. Lee, who speaks Hmong, Lao, Thai, and English, has worked with numerous refugee and immigrant communities in various other capacities, including behavioral counseling of delinquent youth, gang-involved youth, teen parents, youth with anti-social behavior and their families.

A former Hmong refugee from the country of Laos, Lee came to Oregon in 1978 and received his Master's degree in Business Administration from Marylhurst University. He embodies the vision of IRCO as an organization committed to helping each immigrant and refugee family achieve their full potential in their new home. When Lee is not working, he enjoys participating in community activities and spending time in nature with his wife and five children.

Ms. Sinlapasai-Okamura

received her J.D., from Northwestern School of Law of Lewis & Clark College in 2002 and is a member of the Cornelius Honor Society. She earned her B.A. (English & Philosophy) from Santa Clara University in 1998. She is an active member of the American Immigration Lawyers Association (AILA Oregon) and currently serves as the liaison for Immigration Custom's Enforcement. Her volunteer work includes chairing the DOJ's Immigrant Crime Victim's Rights Enforcement and membership in the Victims of Crime Act Advisory Committee for the State of Oregon, DOJ's Crime Victim's Rights Compliance Project Advisory Committee, F.B.I. Multicultural Committee, Oregon Minority Lawyer's Association, and Oregon Women's Lawyer's Association. She has been involved with the immigrant and refugee community most of her adult life, both in Oregon and California. In addition to her immigration law experience, she has firsthand knowledge of the challenges an individual or family can face when coming to a new country. Her family resettled in the United States as refugees from Laos in 1980.



### Taye Yemeru, Board Member

Taye Yemeru, who joined the Board in July 2014, was born in Ethiopia and has worked for the Federal Aviation Administration (FAA) since 1990. His FAA management role includes administering, investigating and enforcing safety regulations for aircraft operation and airworthiness, as well as overseeing air carrier evaluation of flight crews and aviation mechanics for proper training and qualifications. He also collaborates with the National Transportation Safety Board in investigating accidents and incidents involving air carrier industries. Prior to joining the FAA, he worked in the airline industry for more than 25 years in several aviation management positions. Through his career in aviation safety and administration, Mr. Yemeru lived in Kenya, Nigeria and India before immigrating to the United States. A dedicated humanitarian, Mr. Yemeru witnessed a flood of Ethiopians arriving in Kenya as refugees and, in response, volunteered to assist them in finding food and shelter. While living in India, he sponsored two young women, providing employment and funding educational and vocational trainings that led to self-sufficient careers. He and his wife also funded their dowries, enabling them to marry. While in the United States, Mr. Yemeru has sponsored a number of African students pursuing education in this country and has been recognized for his mentorship.

Abby Liu, Board Member, was born in China and came to the United States for advanced study in 1996. After earning her MS degree in electrical and computer engineering at Louisiana State University, she has worked in engineering, consulting, and financial services industries. Previously, she worked as a manager at PricewaterhouseCoopers LLP for five years and provided technical consulting services for corporations in litigation and business turnaround needs. She has nine years of professional experience in the private sector in Latin America and the US, mainly as a business consultant and process director in multiple firms, including Azurian, Dicorp, and Nike. During her college years, Laura cofounded FNVPT, a nonprofit organization that served low income children and teenage mothers in the slums of Bogota. She was an active volunteer with the organization for over 11 years and served as a Board Member for 3 terms. Laura came to the US for a Master's degree in Nonprofit Leadership at the University of Pennsylvania in 2011. He also served as foreign legal advisor to a Tokyo law firm. Mr. Tran earned his law degree, magna cum laude, from Lewis & Clark Law School in Portland and his undergraduate degree from the University of Chicago. He has served on the board of the Oregon Law Foundation and volunteered for Legal Aid Services of Oregon.

When Tatiana came to this country as a refugee, she was generously assisted in becoming a successful U.S. citizen, a debt she is now able to repay by helping other newly arrived refugees in their own transitions.
