Authorizing the Repurchase of A Tax Foreclosed Property by the Former Owner, the Estate of Eunice Elaine Crowder.

**The Multnomah County Board of Commissioners Finds:**

- a. The Estate of Eunice Elaine Crowder is the former owner of certain real property located in Multnomah County, Oregon, more particularly described as:

Lot 5, Block 7, Dahlke Addition

(the "Property"). On or about September 21, 2011, judgment was entered in Multnomah County Circuit Court foreclosing the delinquent taxes levied against the Property.

- b. On January 2, 2013, the County Tax Collector deeded all right, title and interest in the Property to Multnomah County as authorized under ORS 312.200.
- c. The Estate of Eunice Elaine Crowder has applied to the County in compliance with MCC Section 7.402 to repurchase the Property for \$20,630.81, which amount is not less than that required by ORS 275.180 and MCC Subsection 7.402(C).
- d. The County has received payment in the amount of \$20,630.81 from the Estate of Eunice Elaine Crowder, and it is in the best public interest that the Property be sold to the former owner.

**The Multnomah County Board of Commissioners Resolves:**

1. The County Chair is authorized to execute a deed, in substantial conformance with the attached deed, conveying the Property to the Estate of Eunice Elaine Crowder.
