Why do you want to serve on the advisory committee?

I would be honored to work for the advisory committee because the county needs a fresh voice representing communities that are often isolated from environmental progress. For the past few years I have dedicated my time to empowering specifically the refugee and Muslim community in NE Portland in areas of health and environmental issues. I have been able to use networking and resourcefulness to bring visions into reality, specifically creating a urban farm in Ne Portland.

Working with the advisory committee will enable the committee to see around corners of issues like how poverty and environmental issues are intertwined and the dynamics of privilege that hinder our City from its full potential in the area of sustainability. For my personal growth and goals as a public health professional I would feel honored to work with other minds that can offer new perspectives in helping our city flourish. My ultimate goal is to work in a position with the government to help create and implement policies for health and economic empowerment of women and families so this personally would be a wonderful stepping stone while offering your committee a determined visionary.

Sustainability focuses on the intersection of the economy, social equity and the environment. What expertise or points of view in one or more of these areas could you bring to the advisory committee?

In 2011 I became aware of a plot of land owned by the Muslim Community Center of Portland. This land was situated on N Killingsworth and Vancouver, a highly urban area of Portland. I had been working with the MCCP hosting empowerment circles to women attending the mosque and saw this land as a incredible opportunity. After a few months I had proposed, networked, and executed a plan to turn the garbage filled land into a thriving urban farm for low income and refugees in the neighborhood. This project became a spring board for me to become more involved in health and environmental disparities in our local area. I was chosen to be Green Steward ambassador for Ecumenical Ministries of Portland and Josiah Hill educating locally on lead poisoning and effects of pollution on populations in low income areas. I will continue to use my unique background of American French and Egyptian to engage people and create bridge building. In the advisory committee I will bring my educational background (BA in Women Studies with a focus on women in the economy) and my empirical knowledge of local issues.

How do you think sustainability is most relevant to the services Multnomah County provides in the community?

Sustainability is relevant in every sector of every service in Multnomah County. In my eyes sustainability is a outlook on society a change in perspective from the naivety of the recent past.

Why do you want to serve on the advisory committee?

I would like to serve on the advisory committee because I care about the long-term outlook of our community and our county. Multnomah County provides significant benefits to its constituents and is viewed as a leader. A citizen advisory committee can do a great deal of good in providing expertise, vision and new concepts. I was particularly struck by the inclusion of "innovation" in the title of the committee. The County is looking for fresh ideas, next generation technology, and the economic development it can cultivate. County constituents expect this kind of thinking from its government organizations (high expectations!), and I would like to help make the county and its office of sustainability successful.

Sustainability focuses on the intersection of the economy, social equity and the environment. What expertise or points of view in one or more of these areas could you bring to the advisory committee?

My career history is energy and the environment. My career started in river conservation, focusing on hydropower and coal development in Appalachia. Ten years ago, I moved to Portland to work on non-federal hydropower in the Pacific Northwest. In 2007, I transitioned into managing a multifamily efficiency program for the Energy Trust of Oregon. Most of our program incentives paid for upgrades at apartments in the Portland metro area. I became familiar with multifamily housing management agencies and realized that lower-income folks had limited access to healthy, comfortable, and affordable residences. In my current job at the Oregon Department of Energy, I administer the Renewable Portfolio Standard and develop new policies and analyze new technologies. For example, I'm currently working on community solar model development. I am the agency's sustainability coordinator. And in my current role, I've been able to work with county commissioners and the AOC, and I've been impressed with the work and role of counties.

How do you think sustainability is most relevant to the services Multnomah County provides in the community?

I think sustainability is for everyone. Whether it is health care services or the court system, sustainability should be for all incomes and all peoples. This is not just about the environment – sustainability means making decisions with the future in mind. The county is in a unique position to partner with community leaders and showcase good work. Innovation is just as important. It attracts economic development and gives constituents new options and choices.

I currently chair one citizen committee that oversees renewable power options on your electric and gas bill. I participate in several workgroups and committees. Some examples: a group of 30 coastal and state folks who work together on Oregon's territorial sea, the state sustainability coordinator network, or a technical oversight committee regarding the seasonal high supply of wind and hydropower. Committees and good working relationships are a cornerstone of how we do business in Oregon.

Personally, I'm a hospice volunteer. I've worked on a tiny, tiny farm. I spend my spare time in a boat or on the trail, and I play cello in a quartet and a community orchestra. I feel connected to my community on many levels. Serving on this committee would be one more step in supporting my community.

I work for the state Department of Energy, and there are currently contracts between our agency and the County. For example, my agency provides funds for low-income weatherization in oil-heated homes. I do not believe this represents a conflict with the County, because I do not oversee these contracts, the funds flow from my agency to the County, and I would not be representing the agency if I served on this committee.

Why do you want to serve on the advisory committee?

I became aware of the work of the advisory committee after discussing problems with urban air toxics, and the threat to public health in Multnomah County, with ACSI member Sattie Clark. She invited me to participate on an Air Toxics sub- Committee.

Through this work, I have been impressed by the level of dedication from Multnomah County staffers and community volunteers to the goals of promoting a healthy, prosperous and resilient community for all county residents and inspired by the effectiveness of the work.

When I moved to Oregon almost 20 years ago, I was inclined to take for granted the characteristics of Portland that are now revered nationwide: a commitment to sustainability, innovative transportation infrastructure embraced by the public, great urban neighborhoods, and great urban green spaces. In the last few years I have come to appreciate the dedicated work of individuals that has earned Portland our unique reputation. People who were willing to go far above and beyond to envision a different way to build, rebuild and sustain urban living. I believe that the Multnomah County Advisory Committee on Sustainability and Innovation is comprised of just those kind of thought leaders and I would welcome the opportunity to join them.

There is yet room to improve, even where our region has led on transportation, public health, and the green economy, there remains the opportunity to unlock the potential of a truly sustainable economy and robust society. Too many American communities struggle to realize growth economically where the costs are not disproportionately borne on the backs of low income and communities of color, which are costs we must all ultimately bare. The county, like no other public entity, is uniquely positioned to see the value in public health as a protected commodity for all. In addition, providing the infrastructure to ensure equal access to a clean and healthy environment, and strong communities built around neighborhood schools and libraries are the backbone to regional economic vitality.

I would be honored to work with ACSI toward these ambitious goals.

Sustainability focuses on the intersection of the economy, social equity and the environment. What expertise or points of view in one or more of these areas could you bring to the advisory committee?

Through my work as founder of a grass roots air pollution citizen action organization (Neighbors for Clean Air), I have worked with local industry, regulators and neighborhood based organizations to find innovative solutions to the vexing problem of harmful emissions. We seek to work directly with communities most effected by toxic emissions. DEQ's data supports that the impacts are disproportionately felt in neighborhoods with higher concentrations of low-income and communities of color. Neighbors for Clean Air has been working to reach out to leaders of these communities to educate them on the problem and to build sustainable effective grass roots action to reduce air pollution. At the same time we are working to identify and remove the systemic barriers that put these populations at greater risk.

How do you think sustainability is most relevant to the services Multnomah County provides in the community?

The county, and its residents, often bears the consequences of policy which fails to calculate the true cost of leaving populations behind or allowing the costs to disproportionately fall on vulnerable individuals: from rising chronic health needs to increases in crime, to the vulnerability of volatile tax revenue which we rely on to fund critical services.

I served on the Department of Environmental Quality Portland Air Toxics Solutions Advisory Committee that studied the data on all source categories of emissions for the tri-county metro area and worked with stakeholders to make pollution reduction recommendations.

I have served on the board of Portland Voice/We make the media – a 501 (c) 3 organization founded to establish a new online investigative journalism source for Oregon news.

With my knowledge of the community advocacy work and my experience in the field of sustainability I hope to be able to contribute at this committee.

As a current Board Member and Policy Advocacy and Civic Engagement Committee member at APANO, I advocate for the issues of equity for the underserved API communities in the areas of Health, Education and Civic Engagement. These areas overlap with the social and environmental sustainability issues.

I have also been involved in the past several years working with SERA Architects in the built sustainable environment. Most notable ones are the Oregon Sustainability Center, Tupelo Alley Apartments (LEED Gold) along Mississippi Street and currently the major renovation of the Edith Green and Wendell Wyatt Federal Building in downtown Portland (aiming beyond LEED Platinum).

With the involvements mentioned above, I bring a breadth of knowledge both from the community needs perspective and also from the construction industries.

Multnomah County has a great vision of just, safe, healthy and prosperous community. Sustainability is not a stand-alone component related only to green infrastructures.
