RESOLUTION NO. _____

Authorizing the Private Sale of a Tax Foreclosed Property as Allowed Under ORS 275.225 to Brian O. Bedard and Michela S. Bedard.

The Multnomah County Board of Commissioners Finds:

- a. Multnomah County acquired through the foreclosure of liens for delinquent real property taxes certain real property located in Multnomah County, more particularly described in a copy of a proposed deed, attached as Exhibit A ("Property").
- b. ORS 275.225 allows the County to sell County owned property, including property acquired through tax foreclosure, at a private sale if that property meets certain conditions with respect to value and the applicable zoning and building codes.
- c. The Property has a real market value of \$530 on the assessment roll prepared for the County, consistent with the requirement of ORS 275.225(1)(a).
- d. Although no written confirmation from the City of Portland was obtained, the County is confident that the location and size of the Property make it unsuitable for the construction or placement of a dwelling thereon under applicable zoning ordinances and building codes, as provided under ORS 275.225(1)(b).
- e. The County has received payment in the amount of \$2,003.14 from Brian O. Bedard and Michela S. Bedard, ("Purchaser"), an amount the Board finds to be a reasonable price for the Property in conformity with ORS 275.225.

The Multnomah County Board of Commissioners Resolves:

1. The County Chair is authorized to execute a deed, in substantial conformance with the deed attached as Exhibit A, conveying the Property to Brian O. Bedard and Michela S. Bedard, in consideration of \$2,003.14.

Legal Description:

A parcel of land in Section 9, Township 1 South, Range 1 East of the Willamette Meridian, in the City of Portland, County of Multnomah and State of Oregon, described as follows:

Beginning at a railroad iron in the West line of the Finice Caruthers Donation Land Claim 135.28 feet South of the Northeast of the J. Donner Donation Land Claim; thence South on the West line of the Finice Caruthers Donation Land Claim 33.22 feet to an iron pipe in the South line of S.W. Canning Street; thence South $89^{\circ}15'$ West along the South line of S.W. Canning Street 8 feet; thence South 150.85 feet to the center of vacated portion of S.W. Prince Boulevard and the East line of Seventh Street Terrace as located by survey by City of Portland dated June 21, 1915 in Field Book 20, page 45, said point being the true point of beginning; thence along the center line of vacated portion of S.W. Prince Boulevard South $45^{\circ}32'37''$ West 47.69 feet; thence North $86^{\circ}27'16''$ East to the East line of Block 13, Seventh Street Terrace; thence North along the East line of Block 13 and its extension Northerly to the true point of beginning.
