

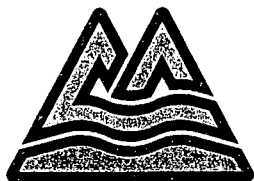

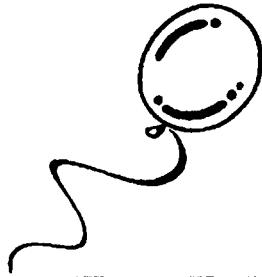

Dear Chairman McCoy and County Commissioners:

I am Sondra Pearlman, Executive Producer of **OREGON CHILDREN'S THEATRE COMPANY**, PO Box 307, Portland, 97207. OCTC presents two shows each year in the Civic Auditorium to a school audience of between 75-80,000 with a total attendance during our four year history of more than 315,000. Even though OCTC has one of the largest audience bases of any performing arts groups in the area, you may not be aware of our program. The reason for this is simple. Our audience is composed of a constituency that has neither the voice nor the dollars to make itself heard. So I am speaking to you today on behalf of the children of the metropolitan area.

The recently released ARTSPLAN 2000 stressed the contribution the arts makes to the quality of life in our city as well as its value to the growth and development of our children. ARTSPLAN states that "the arts can promote understanding between different cultural groups and that the strategy to fight crime is to combat the conditions that lead young people into it and arts programs can play an important role in this."

I know that the county is facing some difficult budgeting decisions. However, when you make those budgeting choices please consider the fact that there are alternatives for our youth and that the arts can have a great impact in reaching the young people in our community.

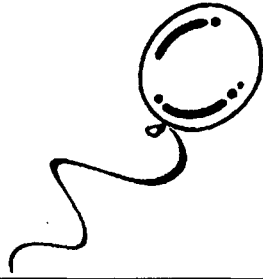
The overwhelming support OCTC has received from educators is astounding. Almost 20,000 students or 25% of our audience comes from Multnomah county. Our outreach program has been able to bring approximately 2000 children a year to the theatre - children who would not otherwise have such an opportunity. Additionally, a recent survey of teachers indicated that 10% of our audience is composed of minority populations including 5% Hispanics, 3% Southeast Asians, 1.5% Afro-Americans, and .5% American Indians. Clearly, we are reaching underserved populations.

Teachers recognize the importance of the arts to their students education and incorporate OCTC into their curriculum. Teachers who have attended our performances have written and said that "most of my students come from a disadvantaged home life. It was a thrill to take them to their first live theatre production." Another said, "if these were not available at such affordable prices, we would never be able to offer this opportunity."

Regionally, our audience comes from as far away as Albany, Hood River, Longview, and Tillamook. ARTSPLAN speaks to the issue of regionalism and has consolidated the arts community into taking a regional approach. The City of Portland has already shown its support by substantially increasing its funding for the Metropolitan Arts Commission. Multnomah County must also take a leadership role if such an effort is to be successful. We must increase the dismally low per capita contribution to the arts and set an example for other local communities to follow.

OCTC firmly believes that by educating the young people of our community to the performing arts, we not only enrich their lives today but we also begin to develop an appreciation of the arts which they can carry with them into adulthood. As a recipient of MAC, I urge you to show your support of our children and the arts and to provide leadership in this area by funding the request from the MAC. It is an investment worth making because its impact can benefit our children now and our community in the future.

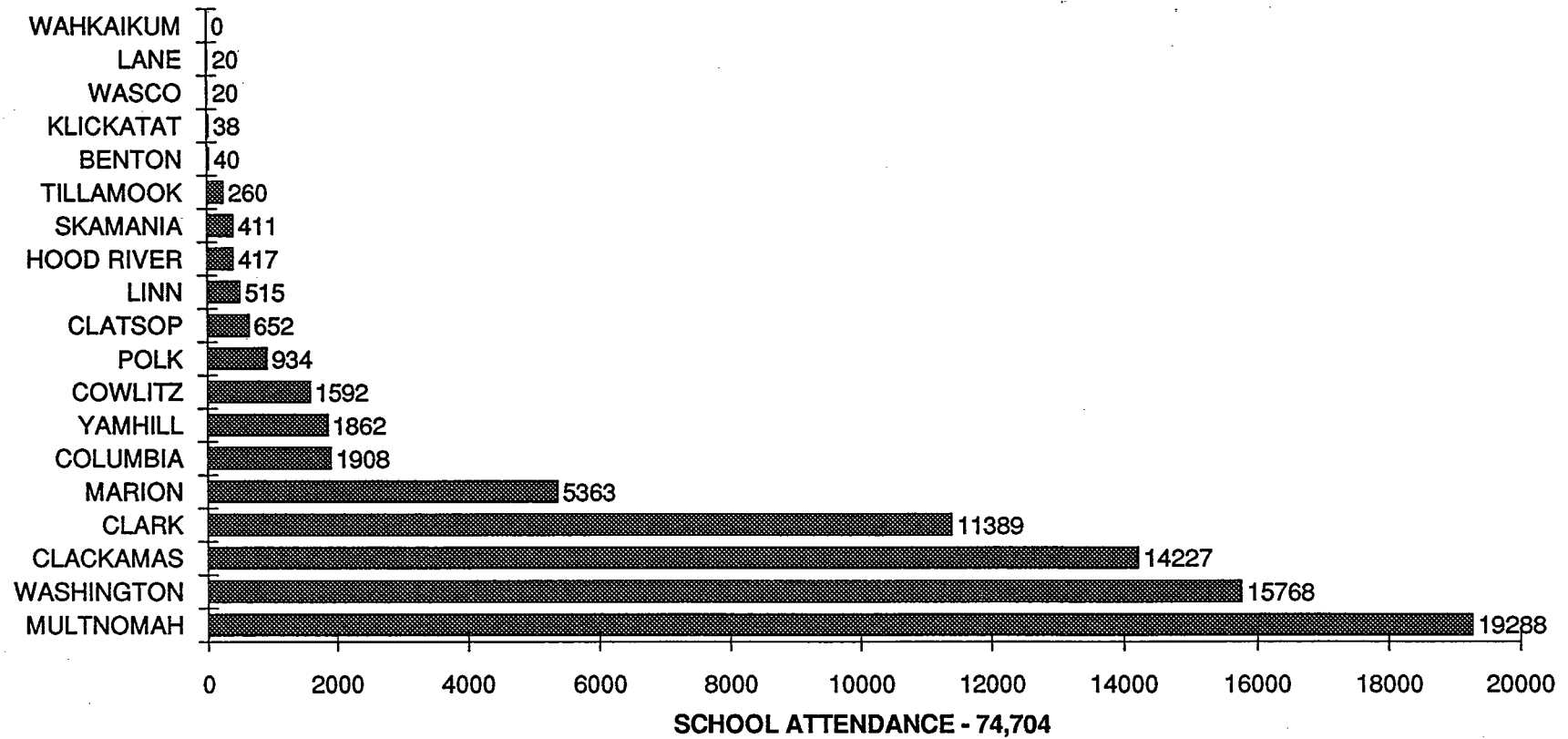

Oregon CHILDREN'S THEATRE COMPANY, a non-profit 501 (c) (3) corporation, was established by Sondra Pearlman, Executive Producer, in 1988. Each year two productions have been presented in the Portland Civic Auditorium. One production is brought in from a nationally recognized children's theatre touring company, while the other is locally produced. Each production presents 12-14 performances to school groups and one public performance. 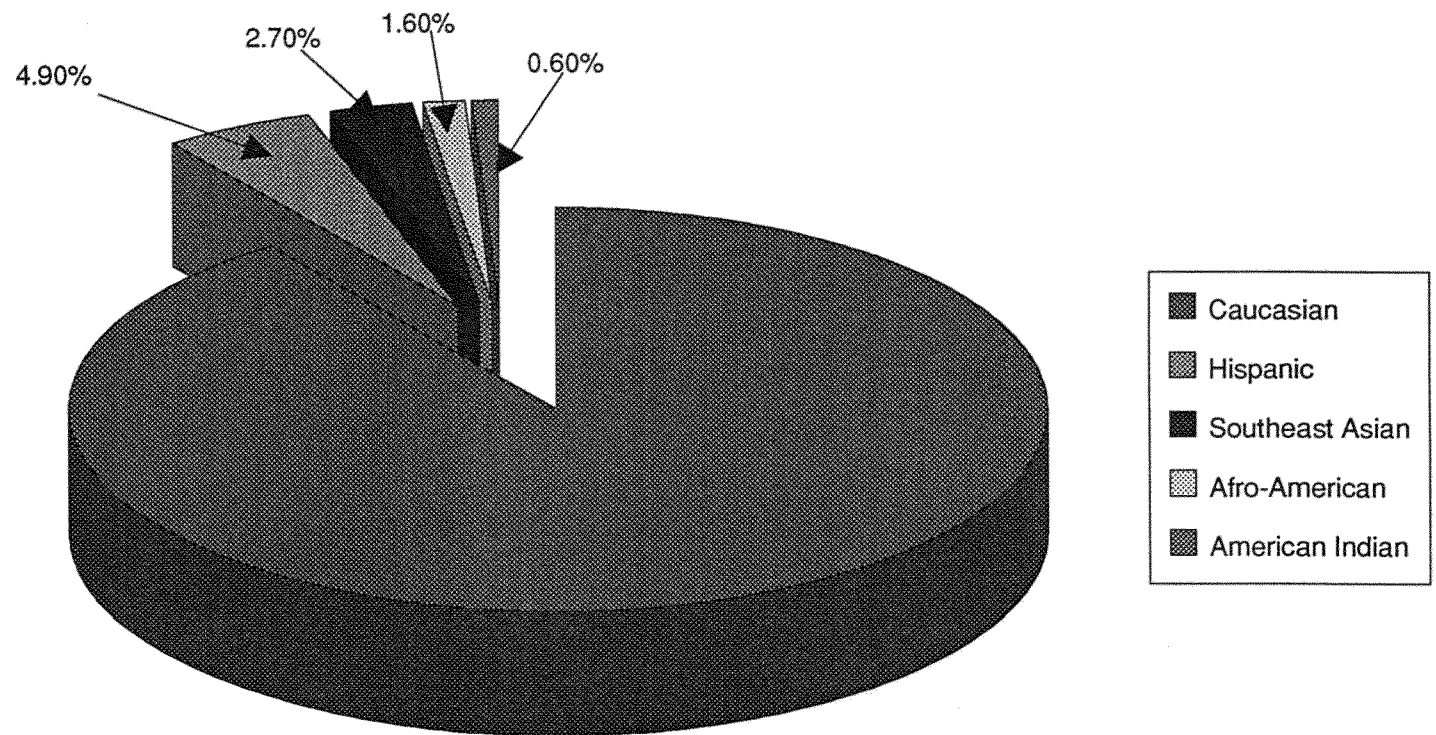

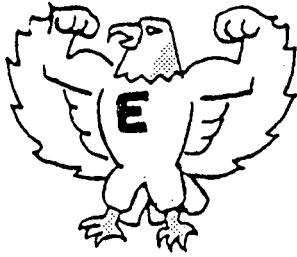
