Issues/Discussions/Findings
<p>Commissioner Smith - requested a list of all the programs in the FY 2015 Approved budget that had General Fund backfill.</p> <p>RESPONSE: See attached</p>
<p>Commissioner Wendt – During the budget worksessions, would like the departments to address how they are responding to the trend of the State replacing formula-based funding with competitive grants. The response should include what infrastructure they have in place to position themselves to apply for the funding.</p> <p>RESPONSE: The Budget Director sent an email to all departments on April 30, 2014 asking them to prepare to answer the above question during their Department Budget Worksessions.</p>
