WHEREAS, the purpose of the Multnomah County Strategic Investment Program (SIP) Policy as adopted by the Board on April 13, 1995 establishes that benefits of the program are enjoyed by current county residents, especially those who are unemployed or underemployed; and

WHEREAS, the August 3, 1995 Strategic Investment Program Contract between Multnomah County, the City of Gresham, and LSI Logic Corporation regarding LSI's Community Resources contribution, recognizes that:

in order to facilitate recruiting of large numbers of applicants for SIP jobs a social service infrastructure will have to be enhanced in outer southeast Portland and east Multnomah County; and

an enhanced service infrastructure is critical to identify the target population for SIP jobs and to create an information channel to that population; and

WHEREAS, the August 3, 1995 Strategic Investment Program Contract between Multnomah County, the City of Gresham, and LSI Logic calls for conducting a needs assessment of the service infrastructure in outer southeast Portland and east Multnomah County; and

WHEREAS, an assessment of the service infrastructure in outer southeast Portland and east Multnomah County has been conducted and recommends that Community Resources be targeted to establishing a system of delivering SIP workforce development services which:

provides universal access for all individuals interested in jobs at LSI Logic and Fujitsu Microelectronics while targeting residents of outer southeast Portland and east Multnomah County;

supports the development of the workforce infrastructure in southeast Portland and east Multnomah County;

provides comprehensive services to prepare individuals from targeted populations to qualify for entry-level jobs at LSI, Fujitsu, and other microelectronics employers; and

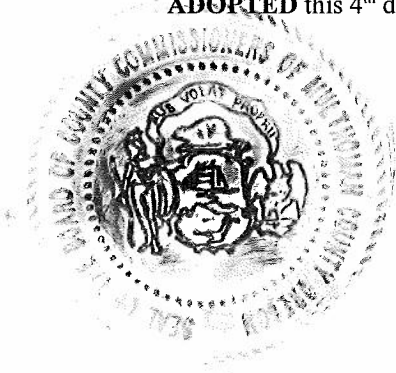
is the basis of a sectoral workforce strategy designed to enhance the capacity of the local labor market to respond to the needs of the microelectronics industry; and

WHEREAS, the emerging national and local system for delivery of integrated services for job seekers and employers is that of a One Stop system, as determined by the U.S. Department of Labor; now therefore


IT IS HEREBY RESOLVED that in order to identify and prepare target populations to fill entry-level positions at LSI Logic and other microelectronics firms, including Fujitsu Microelectronics, and support the development of One Stop Career Centers in outer southeast Portland and east Multnomah County, Community Resources revenues shall be allocated to the following activities:

\$128,000	East County One Stop Career Center (ECOS) workforce services;
\$128,000	SE Works One Stop Career Center workforce services;
\$ 70,000	English as a Second Language Project;
\$ 30,000	Enhanced Retention Project;
\$ 20,000	Workforce Initiative Tracking, Analysis, Evaluation and Reporting;
\$ 4,000	Data Capital Fund; and
\$ 20,000	contingency reserve and County indirect expenses.


