Barbara,

I have reviewed the Amendment and APR and they are approved for submission to the Board and attached here.

That said, I think the language in the Amendment regarding the "Effective Date" is vague, it reads: This Amendment shall become effective on the date it is fully executed and approved as required by applicable law.

I suspect this is ODOT required language but if we have leverage in the future to edit this I think we should. As stated, it provides no direction regarding what constitutes "fully executed" and then does not reference any specific law.
