This Matter before the Board is to offer to Surrender Jurisdiction to the City of Portland, all County Roads within the areas annexed to the City of Portland between January 1, 1988, and June 30, 1988, as described in Boundary Change Final Order Nos. 2432 and 2466 and also those portions of East Burnside Road as described in Nos. 2217, 2238, 2247, and 2346 of the Portland Metropolitan Area Local Government Boundary Commission; and

It appearing to the Board that this Matter has been initiated in accordance with Section III, B of the Intergovernmental Agreement approved by Portland City Council March 1, 1984, and Multnomah County Board of County Commissioners March 8, 1984, regarding the transition of urban services from the jurisdiction of Multnomah County to the City of Portland; and

It further appearing that this Matter before the Board is in accordance with ORS 373.270 initiating the proceeding for the transfer of jurisdiction of County Roads within the limits of the City of Portland to the City of Portland, by public hearing; and

It further appearing that the public was notified by advertisement in the Oregonian, a newspaper of general circulation, on five successive Mondays beginning November 14, 1988, and ending December 12, 1988, of the time, location and list of County Roads offered for surrender of jurisdiction by Multnomah County to the City of Portland;

It further appearing that by advertisement, the public was invited to attend a public hearing on this matter on December 15, 1988, to offer testimony and voice their concerns or support for this matter, to enable the Board of County Commissioners to determine whether it's in the best interest of the County to offer to surrender jurisdiction of all County roads within the areas annexed to the City of Portland between January 1, 1988, and June 30, 1988, as described in Boundary Change Final Order Nos. 2432 and 2466 and also those portions of East Burnside Road as described in Nos. 2217, 2238, 2247, and 2346 of the Portland Metropolitan Area Local Government Boundary Commission;

NOW THEREFORE, IT IS HEREBY ORDERED, and the Board hereby FINDS, that it is necessary and expedient and for the best interest of the County of Multnomah, to offer to surrender jurisdiction of all County Roads within the areas annexed to the City of Portland between January 1, 1988, and June 30, 1988, as described in Boundary Change Final Order No. 2432 and 2466 and also those portions of East Burnside Road as described in Nos. 2217, 2238, 2247, and 2346 of the Portland Metropolitan Area Local Government Boundary Commission; to wit:

South East Area

S.E. Division Street, No. 2850

(From S.E. 124th Avenue to a point 110 feet, more or less east of S.E. 124th Avenue.)

S.E. 124th Avenue, No. 2591

(From S.E. Division Street to a point 160 feet, more or less north of S.E. Division Street.)

North East Area

N.E. 161st Avenue, No's. 4728 and 4780

(From N.E. Sacramento Street to N.E. Russell Street.)

N.E. Russell Street, No. 4727

(From N.E. 162nd Avenue to N.E. 159th Avenue.)

East Area

E. Burnside Street, No. 1273

(From S.E. & N.E. 92nd Avenue to S.E. 124th Avenue.)

E. Burnside Street, No. 1273

(From S.E. & N.E. 148th Avenue to a point 60 feet, more or less west of S.E. 154th Avenue.)


