1. What action are you requesting from the Board?

Board approval of new liquor license application for The View Point Inn.

2. Please provide sufficient background information for the Board and the public to understand this issue.

This is a transfer of ownership as well as a renewal. The Multnomah County Sheriff's Office has completed its investigation for the above liquor license.

Assessment and Taxation reported that the former owners of The View Point Inn, Pisces Dream LLC, at the address 40301 E Larch Mountain Road Corbett, OR 97019, **have not** filed a Personal Property return which is required by law. Due to this fact they were not in compliance with the Assessment and Taxation Office. Since this is a new owner those tax arrearages would not apply to the new owner's OLCC license.

The Land Use Planning Division reported that they have no objection to the new liquor license.

Multnomah County False Alarm Reduction Program has notified us of non compliance in

payment for false alarm response and had revoked their permit. These arrearages do not affect the new owner.


Nothing in the background check of the new owner/s raised any questions or concerns.
