I remain concerned about the process through which the Board has agreed to fund Task Force expenses in the last several months, culminating in the approval of R-18 on December 31.

The funds approved for the Children's Justice Task Force were attributed to a change in the scope of the Task Force project as well as the expiration of funding from DHS Administration and the Juvenile Justice Division. What remains unclear is whether the Board made a deliberate decision to spend a sum in this range at the time the scope of the Task Force was changed. Similarly, it is not clear that the Board was aware in advance of the approximate expense of using consultants to facilitate the city-county meetings.

A related factor is that, knowing in advance the cost of a facilitator, more serious consideration can be given to the use of in-house staff. For example, the staffing and expense of the Facilities and Land Holdings Task Force has been assumed by my office, despite budget reductions.

In the future, I recommend that we determine the cost of outside facilitation services in advance of Resolutions creating the need, and seriously consider our in-house staffing options.
