ORDINANCE READ BY TITLE ONLY. COPIES AVAILABLE. COMMISSIONER NAITO MOVED AND COMMISSIONER LINN SECONDED, APPROVAL OF FIRST READING.

SINCE REPRESENTATIVES OF THE CITY OF PORTLAND, BUREAU OF PARKS AND RECREATION HAD NOT YET ARRIVED FOR R-9, THE ITEM WAS TABLED.

CHAIR BEVERLY STEIN ADVISED THAT SINCE THIS IS HER LAST BOARD MEETING AS COUNTY CHAIR, SHE WILL TAKE THIS OPPORTUNITY TO PRESENT REMARKS REGARDING HER RESIGNATION IN ORDER TO PURSUE A CAMPAIGN FOR THE GOVERNORSHIP. CHAIR STEIN REMARKED THAT THESE LAST EIGHT YEARS SHE HAS HAD THE BEST JOB EVER; THAT SHE HOPES TO GET AN EVEN BETTER ONE; THAT SHE HAS BEEN HONORED TO HAVE HAD THE ABILITY TO SERVE MULTNOMAH COUNTY CITIZENS, INCLUDING THE ELDERLY, CHILDREN, AND MENTALLY ILL; AND THAT SHE CONTINUES TO VALUE AND APPRECIATE THE ASSISTANCE OF THE BOARD OF COMMISSIONERS. COMMISSIONER ROBERTS ADVISED HE APPRECIATES CHAIR STEIN'S GOOD HUMOR. COMMISSIONER CRUZ ADVISED SHE APPRECIATES CHAIR STEIN'S TOUGH QUESTIONS, INTELLIGENCE, AND WILLINGNESS TO FIGHT FOR THE UNDERDOG. COMMISSIONER LINN ADVISED SHE APPRECIATES CHAIR STEIN'S EMBRACING CITIZEN INVOLVEMENT IN A MEANINGFUL WAY AND HER TENACITY. VICE-CHAIR NAITO RECALLED GOING DOOR TO DOOR WITH CHAIR STEIN WHEN SHE WENT INTO THE LEGISLATURE AND ADVISED SHE APPRECIATES CHAIR STEIN'S WORK ON EARLY CHILDHOOD, HER CALMNESS AND KINDNESS, AND THAT SHE IS PROUD OF HER ACCOMPLISHMENTS. CHAIR STEIN ADVISED THAT BILL FARVER WILL HATE SITTING HERE BUT WILL DO A GREAT JOB UNTIL THE NEW CHAIR IS ELECTED. COMMISSIONER LINN ADVISED SHE IS PROUD OF CHAIR STEIN, AND EXPLAINED THAT TODAY IS HER LAST MEETING TOO, AS SHE IS RESIGNING TO FILE AND HOPES TO COME BACK AS COUNTY CHAIR. COMMISSIONER LINN INTRODUCED HER INTERIM COMMISSIONER PAULINE ANDERSON IN THE AUDIENCE AND ADVISED THAT WITH HER EXPERIENCE AND EXPERTISE, SHE WILL DO AN EXCELLENT JOB. COMMISSIONER NAITO ADVISED SHE APPRECIATES CHAIR STEIN'S SERVICE AND ABILITY TO BE A TEAM PLAYER WITH OTHER CITIES, COUNTIES AND THE STATE, HELPING MAKE MULTNOMAH COUNTY INNOVATIVE ON EVERY LEVEL. COMMISSIONER CRUZ ADVISED SHE IS PROUD OF THE ORGANIZATIONAL CHANGE LEGACY CHAIR STEIN LEAVES THE COUNTY; AND EXPRESSED HER APPRECIATION TO CHAIR STEIN FOR TEACHING HER HOW TO BRAINSTORM AND GAIN A SENSE OF PERSPECTIVE ON HOW A PARTICULAR PROBLEM FITS IN THE SCOPE OF THINGS. COMMISSIONER ROBERTS ADVISED HE CAME TO RESPECT CHAIR STEIN WHEN THEY SERVED IN THE LEGISLATURE TOGETHER

AND THAT HE HOPES SHE WILL BE OPEN AND NOT FORGET MULTNOMAH COUNTY WHEN SHE MOVES TO SALEM.
