General Information

1. What action are you requesting from the Board?

Approval of IGA 31708 with the State of Oregon Department of Transportation (ODOT). The ODOT provides reimbursement to the Multnomah County Sheriff's Office for commercial vehicle inspections.

2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

Program offer 60063-17 (Patrol): The Patrol Unit protects citizens residing and/or recreating in unincorporated Multnomah County by responding to emergencies, patrolling neighborhoods, performing traffic safety duties and providing education throughout the communities. Patrol provides emergency preparedness, assistance and intervention as part of the treatment service continuum. Patrol deputies and sergeants develop and implement community policing projects utilizing community based policing principles and frontline human services while providing safety to citizens.

This IGA will reimburse the Sheriff's Office for truck safety inspections conducted to support the Oregon Motor Carrier Safety Action Plan (MCSAP). The goal of the MCSAP is to reduce accidents involving commercial motor vehicles (CMV) and to reduce injuries and fatalities resulting from accidents involving CMVs. Both straight time and overtime will be reimbursed to the Sheriff's Office for conducting these inspections.

3. Explain the fiscal impact (current year and ongoing).

The Oregon Department of Transportation has agreed to reimburse the Multnomah County Sheriff's Office an amount not to exceed \$60,000 for these services for fiscal year 2017.

4. Explain any legal and/or policy issues involved.

Pursuant to ORS 825.248, the Oregon Department of Transportation (ODOT) is required to develop an annual commercial motor vehicle safety plan, referred to as the Oregon Motor Carrier Safety Action Plan (MCSAP). The goal of the MCSAP is to reduce accidents involving commercial motor vehicles (CMV) and to reduce injuries and fatalities resulting from accidents involving CMVs. On-road vehicle inspections focusing on conditions that would require the CMV or CMV operator to be taken out of service can reduce truck-at-fault crashes on Oregon highways. Because the on-road vehicle inspections would be precipitated by a valid traffic stop of the CMV, the on-road vehicle inspections may also curb unsafe driving actions of CMV operators that would be subject to a traffic citation or written warning.

This IGA has been reviewed and approved by the County Attorney's Office.
