Health and Human Services Policy Framework Discussion
April 23, 2002
Office of School and Community Partnerships

On January 31, 2002 the Multnomah County Board of Commissioners adopted Ordinance 975, which created the Office of School and Community Partnerships (OSCP) as a vehicle to align the County's community program and partnership services to individuals, families, youth and children.

The major programs that are the responsibility of OSCP are:

- Early childhood services,
- Youth services,
- Family and community resource services,
- Early learning and school achievement programs,
- Services for the homeless, and
- Weatherization and energy assistance services.

The Office of School and Community Partnerships will manage, expand and align services and supports aimed at individuals, children and families in partnership with public schools, local and state governments, businesses, non-profit service providers, foundations and community members with an emphasis on services and supports to infants and young children, school aged children and youth, and individuals and families impacted by poverty.

The Office of School and Community Partnerships will work in partnership with the Commission on Children, Families and Community (CCFC) who has been given the charge for development of the Schools Services Policy Framework. The framework will provide the "big picture" rationale for the County's involvement in school partnerships and services and provide recommendations for alignment of those services. The School Services Policy Framework will also develop policy recommendations in the following areas: Intermediate goals, "system of services" across ages outlining risk levels and investments, criteria for service distribution, programmatic alignment, multi-jurisdictional partnerships, administration and contracting structures, linkages between community based services and schools, data systems, collection and evaluation, resource development and deployment of investments. OSCP will carry out policy direction and will implement changes in practices and programs to align services.

Priority Issues facing the Office of School and Community Partnerships:

- **School-based community services and linkages**
 - Issue: When students are seen in the school based system and need follow-up services; does that family receive a prioritized referral from the County service system?
- **Parental Access to school based services**
 - Issue: Can parents or siblings of students, who have received an assessment in the school-based system, also be seen in the school-based system?
- **Equity of access versus equity of service**
 - Issue: The Asian Family Center is located in northeast Portland as a countywide resource but access is difficult from other geographic areas.

- Develop child care services to meet the child care needs of parents, i.e. infant/toddler care, flexible hours, children with special needs, etc.
- Ensure access to health and safety consultation and materials

strategies

- Children have the opportunity to participate in developmentally appropriate early childhood programs
- Children have smooth transitions between settings, through the engagement of parents, early childhood providers and schools
- Provide comprehensive approaches (parent/child/school-based) to prevent and address severely challenging forms of behavior

strategies

- Develop and implement a shared plan with all stakeholders
- Actively engage new stakeholders, including parents, the faith community and investors
- Increase funding from a variety of sources for the early childhood system
- Support the early childhood system of care through public/private partnerships
- Merge/coordinate similar programs to maximize efficiency and effectiveness

The Framework was developed by an ad hoc advisory group convened by Multnomah County Commissioner Lisa Naito, Portland Commissioner Dan Saltzman, and Gresham Mayor Charles Becker. The Early Childhood Care and Education Council, of the Multnomah County Commission on Children, Families & Community, collected and compiled feedback.



The School Services Policy Framework will result in recommendations to the Board and Departments and will incorporate the process, research and survey work conducted by the Commission in partnership with the Office of School and Community Partnerships.

Key Framework Products

Policy Framework

The School Services Policy Framework will include a vision, goals (including goals for multi-jurisdictional partnerships) and roles for Multnomah County. The framework will provide the "big picture" rationale for the County's involvement in school partnerships and services. It will be built on previous and current planning and will be reviewed, revised and adopted by the Board of County Commissioners.

Policy Recommendations

The School Services Policy Framework will also develop policy recommendations in the following areas: Intermediate goals, "system of services" across ages outlining risk levels and investments, criteria for service distribution, programmatic alignment, multi-jurisdictional partnerships, administration and contracting structures, linkages between community based services and schools, data systems, collection and evaluation, resource development and deployment of investments.

A number of appendices to support the recommendations and assist the Board in reviewing perspectives by stakeholders will be included in the final framework report, such as the inventory of current services and investments, results of the referral study, assessment of system strengths and gaps and best and promising practices research (successful systems, multi-jurisdictional partnerships, key leverage points for academic support, referral and coordination systems, contract monitoring standards and employee release approaches).

Key Participants and Process

Lorenzo Poe and I will co-chair the consultation with providers, consumers, partners and advocates. At the close of the consultation, Director Poe and I will develop recommendations to Departments, and Policy Making Boards for approval and action. Director Poe will also institute changes in the practices and programs of the OSCP as appropriate during the framework timeline.

Key participants include:

- County and County-funded Providers (SAI, SUN, Touchstone, Community & Family Service Centers, School Based Health Clinics, School Based Mental Health, School Based Alcohol & Drug, Caring Communities, Libraries)
- Consumers, Service Partners and Advocates (including Youth, Parents, Caregivers and representative organizations [e.g., Youth Advisory Board; East County and Portland Regular and Alternative Schools; Higher Education, Cultural, Community and Private Sector Organizations focused on achievement])
- Service Partners (Parks & Recreation, Oregon DHS, Provider Networks)
- Other people and agencies to be identified.

The process will include periodic briefings for the Board as a whole, briefings and involvement of the Chair and the Chair's Office, appropriate Department Directors and the Board staff. The system is complex and involves many partners. The process reflects that complexity. As we have discussed with Commissioner Naito and Chief of Staff Rakowitz, the work required to develop the framework and recommendations will take us into December and will be available for the FY04 budget process.

3. The following principles should guide the Task Force in its work:

" Access to services children and their families in school; " Services should address children and families most in need and at highest risk of negative outcomes; " The community has many resources to support students and their families. These informal supports are important; " The basis for planning and services will be a strengths-based, assets approach for all students and families in the County; " Special attention and funding are important to communities within the County who, whether because of language or cultural differences, have difficulty accessing traditional services; " School success programs efforts should be within schools. Schools must be enlisted as full partners in the support and provision of these services; " Major services efforts should receive three to five year funding commitments from the County and be expected to provide meaningful outcome and evaluation studies; and " Services should be evaluated for efficiency and the delivery of outcomes.



In response to evolving community needs and priorities, the Commission is in the final stages of reorganizing and redirecting its resources and efforts. Our ultimate goal is to increase our impact in making Multnomah County a great place to grow up and live.

The Commission's primary focus is now directed toward policy and planning for the systems that serve our children and families and people in poverty. The County and the community provide valuable services, many of which have independently emerged over several decades. Now we are working to take these services to the next level by aligning them and developing system linkages for greater efficiency and effectiveness – a vital task, especially in difficult economic times.

The Commission's work, including its policy and planning efforts, are now centered around four goal areas:

Early Childhood: Our work includes managing the Healthy Start allocation process; launching a Parent Education Resource Database to assist parents in raising healthy, thriving children; and advancing the Early Childhood Mental Health Partnership.

School Partnerships: We are developing a Policy Framework for delivering school-based and –linked services to children and their families; focusing on third grade literacy – a key factor in determining whether children ultimately succeed in their education; and working with school districts to increase the number of developmental assets our young people possess, subsequently increasing their chances of succeeding in school and life.

Youth: The Commission is working in partnership with the Portland/Multnomah County Youth Advisory Board to amplify the Youth voice throughout the community; and we provide support to the Sexual Minority Youth Advocacy Team.

Poverty: Our current projects include developing a cohesive policy framework; and launching Oregonhelps.org, an online tool that helps families easily and confidentially determine what types of public assistance they may be eligible for.

Additionally, we have State mandates to fulfill. These include developing a multi-stage Comprehensive Community Plan and managing the County's Healthy Start program.

DEPARTMENT OF COUNTY HUMAN SERVICES

FY 03 BUDGET POLICY FRAME WORK DISCUSSION

DCHS CROSS-COUNTY DEPARTMENTAL ISSUES

SCHOOL BASED SERVICES

- × The primary DCHS school based services are provided through the Mental Health and Addiction Services Division (MHAS). This division provides a variety of services to school aged children including, mental health consultants in the School Based Health Centers, alcohol and drug evaluation, children's care coordination, assessment and referral services for school aged children and early childhood therapeutic services.
- × The Domestic Violence Division provides a school based prevention program.
- × Development Disabilities Services Division provides case management services to over 1,000 children ages 5-21 years old. Within the DD and public school systems this age range represents school age individuals. Case Management Services include linkage to community-based services, assistance with development of Family Support Plans which provide access to funding for in-home supports, and support of families in the development of Individual Education Plans (IEP's), which identify the need for school-based resources.

HEALTH INFORMATION PORTABILITY ACCOUNTABILITY ACT (HIPAA)

DCHS is currently working with the Health Department, the Office of School and Community Partnerships and the ITO to develop a coordinated implementation plan for this important act. We are currently funding a study to identify all the programs that must comply with the act. Once the survey is complete, a plan will be developed for implementation by the April 2003 compliance date.

HOUSING FOR SPECIAL POPULATIONS

CHS staff, County Housing staff, Corrections staff, etc. are collaborating to develop additional housing units for needy populations. The collaboration brings together property, capital resources, Federal, State and local housing funds, and Housing-related services funding. A special housing task force expects that the collaboration will result in the development of new units within 12 to 24 months.

DCHS DEPARTMENT WIDE ISSUES

MERGER OF TWO DEPARTMENTS

A major issue facing all Divisions in the Department during the next fiscal year is the reorganization of the department. Mid-way during the current fiscal year the BCC adopted resolutions that:

- × Created the Office of School and Community Partnerships. The OSCP was created from several programs formerly in the Department of Community and Family Services and includes the Commission on Children and Families.
- × Merged the Department of Aging and Disability Services and the Department of Community and Family Services.

Good progress has been made developing the Departmental FY 03 Requested Budget and on merging these shared service functions:

- × Finance
- × Contracts
- × Human Resources
- × Planning and Evaluation
- × Information Services

Much work remains to make the shared service areas efficient and effective work units that meet the needs of the new department.

During the next fiscal year, work will continue on integration of programs for common clients of three divisions (ADS, DD and MHAS). The recent location of DD staff at the new East County Aging and Disability office is a great first step.

AGING AND DISABILITY SERVICES (ADS) ISSUES

- × The reorganization creating the County Human Services Department and the redesign of the Mental Health system offer opportunities for ADS to improve the coordination of client services to those served through the financial assistance offices in ADS.
- × ADS is working with the state Department of Human Services division of Seniors and Persons with Disabilities to implement a care coordination pilot program in partnership with the Robert Wood Johnson Foundation to improve the coordination of services with the health system.
- × ADS is implementing a new program for family caregivers, that supports people who are trying to care for a family member on their own without federal Medicaid support. The program was funded by the Administration on Aging to support people who are at risk of losing their ability to provide care because they lack respite or other supports.
- × The Oregon Project Independence program has sustained state level reductions that could impact many of the 800 people who receive services in Multnomah County. A 30% reduction (\$500,000) in funding has been assessed over the next 15 months. The impact will be better known the end of April after full assessments of all clients have been completed.
- × The State reorganization of DHS impacts ADS as changes are being made to information systems, communications, and performance measures.
- × ADS continues working to integrate disability and aging service systems that were merged a year ago. East County has the most integrated physical structure due to the new East County building. Integration is happening throughout the system as communications, protocols and policies are developed to facilitate services for the full mix of clients in ADS.

DEVELOPMENTAL DISABILITIES SERVICES (DDS) ISSUES

- × Implementation of the Staley Settlement Agreement and DDS organizational redesign. This priority represents a wide range of initiatives including establishment of a community-based services Brokerage, reduction of caseload ratios, an improved Quality Assurance system, increased consumer participation in budget, program and policy development, creation of a Medicaid monitoring system, and expansion of service capacity for people on the Wait List.

- × Implementation of a new Family Support program for individuals under 18 years old that will provide limited funding for respite, in-home supports, adaptive equipment and community integration activities.
- × Ongoing efforts to maintain public safety through dedication of resources to transition and monitoring of persons with developmental disabilities moving from state correctional facilities to the community.
- × Continued leadership in development of organizational and program approaches to workforce diversity and cultural competency.
- × Completion of implementation of the County Auditor's Protective Services Audit.
- × Completion of implementation of a Centralized Records system to improve client services and Medicaid Audit preparedness.

MENTAL HEALTH AND ADDICTION SERVICES (MHAS) ISSUES

× MENTAL HEALTH REDESIGN

The mental health budget has been reallocated to support a new approach to clinical services, which should serve to keep expenditures within revenue projections. Only if these services effectively improve access to treatment that works, will certain risk driven expenditure categories decrease. Important reallocations of county clinical services are planned in both the adult and children's mental health systems.

Two Intensive Community Service teams are being constructed from existing units in the child and adult service areas. Members of these teams are being assigned to deliver mental health services and care coordination together with Health, Community Justice and the Sheriff's Departments. This will occur in a model consistent with existing school, DHS and Head Start based children's mental health programs already in place.

Most provider contracts have been overhauled. The capitated business model now supports more than 90% of mental health care.

Planning for the integration of the Addiction Services unit with Mental Health and other delivery systems is underway.

All utilization trends and process indicators have either gone flat (no further deterioration) or are improving since the crisis year of 2001. Revenue is needed to back fill cuts and to add capacity, such as a consumer operated drop in center and culturally specific outreach services. This revenue is already beginning to materialize from the decreases in acute care utilization we are seeing.

- Need to build partnerships and support other community health care providers.
