**General Information**

**1. What action are you requesting from the Board?**

Approval for the Director of the Health Department to submit an application for up to \$625,000 to the Oregon Health Authority's School-Based Health Center (SBHC) Program Office's Mental Health Expansion Capacity Building Grant Program.

**2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.**

The Oregon State Legislature recently approved the Oregon Health Authority budget for 2013-2015, which included increased funding to the Addictions and Mental Health Division to support Oregon's community mental health system. A portion of this funding has been allocated for children's mental health, allowing for a funding opportunity for School-Based Health Centers (SBHCs) to increase their capacity to provide mental health services to their clients.

The SBHC State Program Office (SPO) has released SBHC Request for Qualifications (RFQ) for School-Based Health Center Mental Health Expansion Grant: Capacity Building. These monies will be awarded to the Local Public Health Authorities be used to support mental health capacity within the school-based health center system by adding mental health staff and expanding current mental health staff hours, with the ability to collect and report on mental health encounter visits.

This award is designed to cover a) up to 1.0 FTE salary of a Qualified Mental Health Provider for the SBHC; and b) any necessary capacity/infrastructure to collect and report on the mental health encounter visits. MCHD intends to apply for up to 1.0 FTE Mental Health staffing time for at least two SBHCs; David Douglass and Franklin have been identified as priority schools for increased mental health capacity. This grant will also provide funds for additional mental health data collection support.

**3. Explain the fiscal impact (current year and ongoing).**

Approximately \$3.6 million is available to support all projects over an 18 month period. Future funding will be based on each biennium's legislatively adopted budget.

**4. Explain any legal and/or policy issues involved.**

None.

This project is a collaboration with Department of County Human Services.

Awardees will be expected to provide services that are culturally and linguistically appropriate to their target population. Data tracking of mental health encounters is required. Awardees will be expected to be the primary contact regarding project implementation, and will be responsible for data tracking and reporting. Awardees will be expected to submit a mid-year report on mental health encounters visits and final report.

- **Explain grant funding detail – is this a one time only or long term commitment?**

This is a one time funding opportunity. Future funding will be based on each biennium's legislatively adopted budget.

- **What are the estimated filing timelines?**

The application was due November 22, 2013. If the NOI is not approved, the application will be withdrawn.

- **If a grant, what period does the grant cover?**

Mid-January 2014 to June 30, 2015.

- **When the grant expires, what are funding plans?**

When the grant expires, MCHD intends to maintain increased staff capacity by continuing to leverage funding opportunities to ensure staff time can be sustained.
