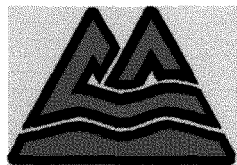

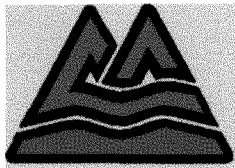

Dear Doug,

As you know, the County is facing a current fiscal year shortfall of approximately \$20 million dollars in general funds.

The timeline for Board of County Commissioners (BCC) decisions regarding rebalance of the FY 01-02 budget is extremely tight. The BCC anticipates that it will vote on a final package of reductions on November 29, 2001. Notification to staff and contractors about those decisions will follow shortly afterwards for execution on January 1, 2002.

Most of the work to produce rebalance packages for the Board's consideration is being done by a group of Department and central budget staff directly reporting to the County's Chief Operating Officer, John Ball. On Monday of this week, the Department was asked to submit to this group proposed 10% reductions to our current year's budget.

Per the Board's policy guidelines developed on October 15, 2001, the Department has provided proposed reductions for analysis and consideration. These guidelines included:

- Fit to the Benchmarks and County's core mission;
- Elimination of entire programs versus "across the board" reductions; and,
- Consideration of all programs, nothing "held harmless".

This letter serves to inform you that general funds for your program(s), *Case Management: Service Access Resource Staff, Resource Coordination: Domestic Violence and School Retention*, have been identified as a part of the Department's proposed 10% reduction package that has been forwarded to the budget work group.

The amount forwarded is 50% of your FY01 allocation for these services. This would mean a potential reduction of up to \$106,347, effective January 1, 2002.

In the event that this reduction is finally approved by the BCC, your contract liaison will be in touch with you to determine specific amounts to be reduced based upon actual year-to-date spending.

The following is information that has been provided by the budget work group to all departments regarding the 10% reductions.

"The 10% reductions departments have been asked to submit will exceed the need so not all the cuts that have been submitted will be required. This is an idea list, NOT a cut list. These are ideas only, not decisions. There is room in the process to communicate the negative effects of the cuts.

Work group meetings will consider the ideas "on the table" and help sort them for the Board to address policy considerations. The Board will be given more cuts to review than they need to reach the goal so they can choose to address their policy needs. Their decision date is November 29; nothing is final until then."

You will also receive a letter from the Department describing the overall County financial situation. However, I did want to alert those specifically named in the proposed reduction package to that fact so that you have as much information as possible.

I know that this is disturbing news to say the least. I am well aware of the impact these reductions, if executed, will have on our communities. I remain positive that in the final analysis, reductions will not be as deep as they have been proposed (although there will be reductions made). I am committed to sharing with you as much information as I have access to as soon as possible. I urge you to access the County's website for the daily and weekly updates from the budget work group.

Lastly, there are a number of opportunities for you to provide feedback about these proposed reductions. Every Tuesday morning from 9:30am-12:00pm the Board receives a briefing from the budget work group on the previous week's work. There is time set aside on those agendas for public comment. There will be three evening public hearings around the County. Meeting details for those hearings are available on the County's website. And, if you have interest in a potential special meeting for DCPD contractors with representatives from the Chair's office please let me know.

My name is Rosa Dominguez; I am here to speak for myself and for my classmates, the latino students of H.B. Lee Middle School.

Thanks to the help of the School Retention Program of El Programa Hispano, many students in our school have learned how to solve their problems such as the difference in the language, the way the school works, to understand the different cultures, and little by little we have gotten adjusted to the system.

Thanks to the activities organized by the staff of El Programa Hispano many of my classmates are working harder at school instead of doing drugs or getting involved in gangs.

El Programa Hispano also helps our parents to understand better the way the school works. They know more about our work at the school because the staff of El Programa Hispano attends the meetings with the teachers and translate for our parents. Our parents can call because there is someone at the school that can understand our language.

Thanks to El Programa Hispano, we get better grades because the staff of the School Retention Program helps us to understand better our homework.

The most important thing is that El Programa Hispano encourages us To get ahead in our studies, because they make us realize that if we want to be something in the future we need to study today.

For those reasons I ask you, please do not cut the funds for the School Retention Program of El Programa Hispano. If you do that, many of us will get discouraged, drop out of school, will get involved in gangs and drugs because they will think that nobody cares, that they don't have anyone to help them and won't want to study.

I think that is better that you spend money in improving our education now than to have to spend more money on police to stop juvenile delinquency later in the future.

SPEAKER #17

Good evening, thank you for listen to us tonight

My name is Dunetchka Otero, I am the domestic violence program coordinator for El Programa Hispano of Catholic Charities, also a resident of Multnomah County. I am here to oppose to the recommended cuts to the Domestic Violence's Program and to all Domestic Violence's Program of the County. As it is there are not enough services for survivors of Domestic Violence.

At Multnomah County we have a "Coordinated Community Response", this is working and critical to stop domestic violence. The cuts as proposed means that the county would not fund any shelter bed or culturally specific services for six months, starting in January. Right now there are many women staying in violent home because our shelters are already full.

To our program this will mean to cut a full position that serve over 150 survivors a year. Survivors that receive basic services such as Safety Plan, Crisis Intervention, Referral to Shelters or placement in Motels to keep them and their children safe. As you know East County has the highest concentration of Latinos/Hispanic population of the whole county. We are the only, the only, Latina Domestic Violence services in East County. You also know, that last year, we already had a cut that cost the community a long-term case manager position. Because of that this year over 30 women will not receive long term services.

Over 50% of our clients receive mental health counseling at El Programa Hispano and many of them have children that receive services from the youth investment system or school retention program.

For the well being of this women and their children I got to urge you not to take away this services from the community.

I am very proud of living in Multnomah County a place that takes seriously domestic violence and its repercussions. I am from Puerto Rico a very well educated Country. In Puerto Rico every 15 days a woman die because domestic violence. We can not wait that that happened here to act, then will be too late.

Testimony of Gloria Wiggins
Youth Retention Program Specialist and Coordinator
El Programa Hispano – Catholic Charities

My name is Gloria Wiggins and I work for El Programa Hispano – Catholic Charities as the Youth Retention Program Specialist and Coordinator. I am here to tell you a little bit about the School Retention Program at Reynolds School District.

Picture yourself in a strange town far from home, where everyone speaks a different language than you do. You don't know anyone and you don't know where things are. Your children have to go to school but the all school's staff speaks that unfamiliar language. You need someone at the school you can talk to.

Picture yourself a twelve years old in a new school, in a new town, in a new country and all the other children at the school know each other and speak a different language. You must find your way in this new school with a schedule written in that language that you don't understand but must follow. You don't know how to open your locker, how to get your lunch, how to find your classroom or your way home at the end of the day. If you feel sick you can't explain it to your teachers or the nurse because they can't understand you. You need a place where you can feel at home, where you are not a stranger. You also need someone you can talk to, who can understand your feelings and language and who can also help you with your problems.

This is what we do every day at the School Retention Program. We help the latino students who are around 20% of the Reynolds School District student body. Most of these students and their families are new to this country, neither they nor their families speak the language, know their way around, don't have any idea where to go for help and are afraid to ask.

We help this people with their small day to day problems that you take for granted because you speak the language and know the culture. But this people need just a small hand to help them up with the small problems they face today. If these problems are not addressed while they are small and can be easily handled, they can quickly become large and complicated and expensive for the county. As you know when people have problems with the law, with the medical community, with the schools, they can create a much greater burden for the tax- payers of Multnomah County.

In this difficult economic times we understand you have to make tough choices, but we know you will be wise enough to see that expending pennies today can save dollars in the near future. These kids can become good citizens, good tax - payers and an asset to the community if you allow us to help them, or they can become a burden for the community if you cut the funding of the School Retention Program, it is your choice.

Buenas tardes distinguidos comisionados, soy Nelson Melgar, Especialista en Vivienda y Prevención de Pandillas en EPH de CC.

Antes que nada, quiero mencionar que es muy preocupante la propuesta de eliminar muchos de los programas que dan esperanza a nuestra comunidad, la cual viene con el deseo de integrarse a esta sociedad y nuestros servicios son vitales en tal proceso.

En breve mencionare la historia de una familia que vino de California en Julio del año pasado con el objetivo de trabajar en los campos agrícolas de Oregon. Pero no encontraron empleo y dormían en el carro por no tener dinero para un motel; hasta que alguien los llevo a EPH y les ayudamos a conseguir vivienda permanente.

Las necesidades han aumentado alarmantemente. Por ejemplo, durante todo el año fiscal anterior ayudamos a 23 familias con vivienda. Mientras que en el transcurso de este año fiscal ya hemos ayudado a 33 familias.

A la misma vez trabajo con jóvenes Latinos en 3 escuelas de el Distrito Escolar de Reynolds. 51 estudiantes participan en nuestro club de fútbol el cual le ofrece la oportunidad a los jóvenes a mantenerse fuera de pandillas y drogas.

Nosotros tratamos de ayudar con los pocos recursos que tenemos, y si los quitan no tendremos nada que ofrecer.

Por lo tanto, en nombre de nuestra comunidad les pido que no quiten lo poco que se les ofrece porque seria una injusticia social.

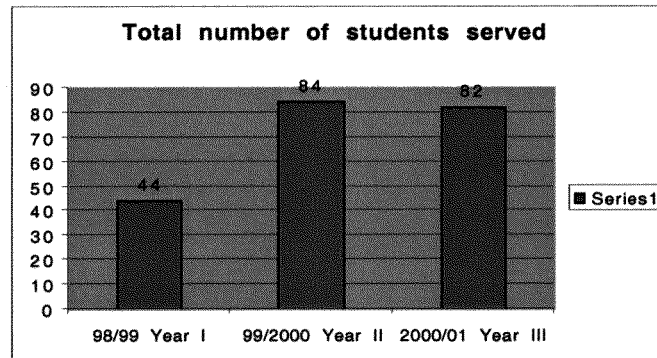

Highlights from Clear Creek:

- ◆ **Student Health Fair:** 578 students participated. Event partners included: Al-Anon, Eastwind Center, MADD, Girls Initiative Network, Trauma Nurses Talk Tough, Gresham Police Dept., American Red Cross and Special Emergency Response Team (SERT).
- ◆ **Blood Drive:** Held in conjunction with Student Health Fair – 70% of targeted blood donation reached.
- ◆ **Cinco de Mayo:** 625 Students and 30 Family & Latino Community Members participated in the celebration, which included traditional and contemporary dance routines and a piñata-breaking contest.

- ◆ **The Great Oregon Beach Clean Up:** Youth and family members took a field trip to Seaside to participate in SOLV's annual beach clean up.
- ◆ **Arts Alive:** 200 people attended an evening celebration showcasing student's artwork. Students also showcased their talents through musical performance and a poetry slam presentation.
- ◆ **SUN Activities:** Activities are offered before and after school. The SUN program offers 17 academic, recreational, arts, and skill-building activities for students at no cost to participants. Snack and transportation are provided.
- ◆ **SUN Center:** This summer, in collaboration with the school, the SUN program converted the old Home Arts Room into the SUN Center. We redecorated the room to create both a comfortable and creatively stimulating space for students. This print rich environment was also stocked with engaging academic enrichment games, magazines and books to cater to the students' wide range of learning styles.
- ◆ **Person of the Month Contest:** This is a monthly writing contest in which students nominate a person he/she believes is a positive role model for the community; nominations can be made in either Spanish or English. The winner receives a gift certificate to a bookstore and designs the Bulletin Board on which the nominee is highlighted for that month.
- ◆ **East County Caring Community Action Team:** This is a partnership between the SUN programs in East County, East County Caring Community and the East County Family Centers for the purpose of enhancing our partnerships through clearer communication
