Transferring Unclaimed Property List 15-2 to PropertyRoom.com for Auction with the Proceeds of the Sale to be Deposited in the County General Fund.

**The Multnomah County Board of Commissioners Finds:**

- a. Multnomah County Code Chapter 15.650-15.656 provides for the Sheriff to seek authorization from the Board of County Commissioners to dispose of unclaimed property by transfer to law enforcement or government agencies; offered for sale; or disposal through destruction.
- b. The found/unclaimed or unidentified property has been in the Sheriff's possession for over 30 days. All attempts to establish the rightful owner(s) of the listed property have proven negative. The property was acquired from closed case files which were originally connected to the following crimes or events: Burglaries; Identification theft; Narcotics cases; Found property; Recovered stolen property, unable to locate owner.

**The Multnomah County Board of Commissioners Resolves:**

1. Property List 15-2 will either be sold on the Internet or disposed of by the County's Contracted vendor, "PropertyRoom.com". Proceeds from sales will be deposited in the County Treasury to the credit of the Multnomah County general fund.
2. A 32" Craig Television #C11007428 from case 12-403839 is to be retained by the Sheriff to be used for public information purposes.
