The department is requesting board approval of budget modification DCA-01-16, reclassifying a Development Analyst to a Development Analyst Senior.

2. Please provide sufficient background information for the Board and the public to understand this issue. Please note which Program Offer this action affects and how it impacts the results.

This request is an extension of the FY15 budget modification, DCA-12-15 which was approved by the Board on June 18, 2015, carried into fiscal year 2016. This modification reflects a Class/Comp decision (#2819); a reclassification request initiated by management. The position involves an increasing demand in complexities in web development and design that require a higher level of duties, responsibilities, and skills on a County-wide basis. The Development Analyst Senior will apply expert-level knowledge of applications development and applications administration, work more independently, and have a higher level of responsibility, problem-solving, and experience than the Development Analyst. Program offer affected is 78033-16.

3. Explain the fiscal impact (current year and ongoing).

Personnel expenses are expected to increase \$19,643 for FY16. This will be offset by a decrease in the professional services budget. Ongoing, the annual fiscal impact will be an increase of about \$21,882.
