Multnomah County, in its various roles and responsibilities, participates fully in the implementation of the Affordable Care Act and Medicaid reform. Two years ago, Coordinated Care Organizations (CCOs) were established in the largest move to transform the health system. Medicaid expansion began on January 1, 2014 and dramatically increased the number of County residents insured by the Oregon's Medicaid plan, the Oregon Health Plan.

Multnomah County may not be the principle driver of health system transformation but we are an important actor and have been using our resources to change the way we work to improve the care of our clients, improve health outcomes, and reduce costs.

This presentation provides an opportunity to learn about three success stories which highlight how we are working across systems, identifying and bridging gaps, and guiding our most vulnerable and complex clients to appropriate care and necessary services.

**Addictions Resource, Coordination and Integration** – Improve and strengthen the resourcing, coordination and integration of care of addiction services for complex clients. Working across two financial systems to ensure that clients receive the treatment they need.

**Tri-County 9-1-1 Service Coordination Program** - Provide complex care management and coordination to ensure that co-morbid and tri-morbid clients are connected and engaged in the care and services they need. Outcomes and lessons learned from this Health Commons Grant intervention.

**HUB Model to bridge gaps in care for area Seniors and People with Disabilities –**

Successful state innovation grant will provide us with an opportunity to stabilize and improve the quality of life of people suffering from chronic health, mental health and substance use disorder. Improve care coordination and use of under-utilized resources to improve outcomes and reduce costs.
