

Beginning at the Northwest corner of Lot 30, Andrews Acres, a duly recorded Subdivision in Sec. 9 T1N R1W, W.M., Multnomah County, Ore., which corner bears N56°19'12"E 70.63 ft. from a Railroad spike at Engineers' centerline station 80 + 09.03 B.C. in Old Germantown Road (County Road No. 1636); and running thence, S01°14'51"E along the West line of said Lot 30 and a portion of the West line of Lot 34, said Subdivision, a distance of 548.77 ft. to an iron pipe; thence, East 245.72 ft. to an iron rod; thence, N01°14'51"W parallel with the West line of said Lots 30, 34 a distance of 531.98 ft. to an iron rod; thence, East 269.90 ft. to a point on the centerline of said County Road, and from which point an iron rod bears West 32.55 ft.; thence, N00°07'10"W along the East line of Lot 31 a distance of 259.18 ft. to a point in the centerline of said County Road, and which point bears S82°56'25"W 13.77 ft. from a Railroad spike at Engineers' centerline station 73 + 45.15 E.C.; thence, Southwesterly along the centerline of said County Road 579.48 ft., more or less, to the point of beginning; containing 5.00 acres, more or less.


