


## THE ROLE OF THE BRENTWOOD-DARLINGTON COMMUNITY CENTER IN THE LANE MIDDLE SCHOOL SCHOOLS UNITING NEIGHBORHOODS (S.U.N.) SITE PARTNERSHIP

As envisioned during its design and construction, the Brentwood-Darlington Community Center is a neighborhood facility that provides space and opportunity for schools and community to come together. The four major areas of collaboration with the Lane SUN Site Partners are: 1) meeting space, 2) opportunities for learning, 3) volunteer coordination, and 4) community events that market available resources.

### Meeting Space

Since its opening in October of 1996, the Brentwood-Darlington Community Center has provided meeting space for neighbors and youth groups. One of the first Lane Middle School based youth groups to utilize the Center made a permanent imprint. The Girls Leadership and Development (G.L.A.D.) program worked with Center staff to design and paint a mural on the north wall of the Center in 1997. The mural depicts the history of the site where the Center and Lane Middle School now stand. The GLAD girls continue to meet weekly at the Center during the school year. Other Lane Middle School youth groups that have utilized the Center during the school day are: Latino Boys Support Group, Asian Girls Leadership, and Katusha (a Russian girls' group). Other Lane related groups include the Lane Partners, Families and Schools Together ( F.A.S.T.) and FASTWorks, several GEARS related meetings, and Lane Middle School staff functions.

### Learning Opportunities

Opportunities for community service learning at the Brentwood-Darlington Community Center have been provided to Lane Middle School students since the Center opened. The first student to volunteer stayed until his promotion from Lane in June of 1998. His many contributions to the Center's operations were invaluable, which included providing an internet tutorial to the Executive Director. Other community service learning examples include summer maintenance of the Lane Middle School and B-D Community Center grounds. Students play an important role in keeping trees, shrubs, and plants from dying during warm, dry weather. Students have assisted with the Senior Lunch program as well as staffing the front reception desk.

The Center has also partnered in support of the After-School program. In 1999, Center staff collaborated with Mary Richardson, Lane Community School Coordinator, to create and fund a Theatre Class through the Regional Arts and Culture Council's Neighborhood Arts Program from January to May. The Theatre Class led to the development of additional After-School staffing and class offerings. The Center also served as the sponsor of Time 4 Kids funding for the After-School program in the fall of 1999.

In developing structured recreational programs for children during the summer term, Center staff sought input from the Lane Community School Coordinator to design an extended day program run by the Lents Boys and Girls Club from 3 p.m. to 5 p.m. The Youth Librarian from the Woodstock Branch Library also collaborated with Center staff and the Lane Community School Coordinator to schedule cultural enrichment programs for children at the Center during the summer months. Other summer learning opportunities include scheduling the Portland Community College GED classes at the Center to maintain continuity of adult education opportunities during Lane's abbreviated summer operating schedule.

### Volunteer Coordination and Management

Since 1998, the Brentwood-Darlington Community Center has worked with GEARS to coordinate the use of volunteers recruited from the corporate sector. Volunteer management efforts have been enhanced by a Community Initiative grant from the City of Portland's Bureau of Housing and Community Development. The grant adds .2 FTE to an existing part time position to expand the Brentwood-Darlington Community Center's ability to recruit volunteers from the community and local businesses. Volunteers are matched with students either individually as tutors and mentors or as a group advisor for community and school projects such as the community gardens program, wildlife projects, or a cultural enrichment project such as oral history. The Center's Volunteer Coordinator teams up with the Parent Involvement Coordinator at GEARS to link school and community volunteers together. The grant funds the program for calendar year 2001.

### Community Events

The Brentwood-Darlington Community Center participates in the Health Action Team of the Outer Southeast Caring Community along with the GEARS program and several other community-based organizations. The Health Action Team actively promotes resources for healthy lifestyles through a variety of ways. Two of the larger promotions are a Back to School event in August and the Winter Warming Festival in December of each year. The Back to School event combines a resource fair with school immunizations at the Lane Maternal and Child Health Clinic, a clothing exchange run by the GEARS staff and volunteers, and a distribution of school supplies. Free hotdogs and drinks and door prizes create a picnic atmosphere. The Winter Warming Festival combines a resource fair with children's arts and craft activities, a toy and winter clothing exchange and Christmas caroling. Both events attract hundreds of families from Outer Southeast Portland and East County.

## RESOLUTIONS NORTHWEST'S FAMILY MEDIATION PROGRAM

### History

The Family Mediation Program has been **operating since 1988 (merged with RNW 1998)**, serving the mediation needs of families in Multnomah County. RNW's mission is to strengthen personal and community responsibility by promoting constructive conflict resolution through mediation services, education and training.

### How Does the Program Work?

The Family Mediation Program (FMP) works primarily with parents/guardians and their adolescent children who are experiencing conflict or crisis. It teams **professionally trained adult and teen mediators** to help parents and teens sort through their problems, identify the most important issues, and come up with a set of agreements that everyone can accept. Typical issues that families bring to mediation include curfew and other house rules, choice of friends, trouble in school, involvement with the law or drugs, and running away. Most families report that they leave mediation with improved communication and new skills for handling future conflict.

### Who are the Mediators?

The Program **relies on volunteers** and maintains a pool of about 20 active **adult and teen mediators**. Teens receive a small stipend for each mediation session. In addition to mediating, FMP offers its volunteers opportunities for continuing education and leadership, such as presenting at workshops and assisting with training new mediators.

## In Home Nursing Services Cuts to seniors

Currently Multnomah County Health Dept is in the process of planning to cut in home nursing services to seniors (those over 60 years of age.) The program is called MDT, which stands for Multiple Disciplinary Team. This team is composed of social workers, case managers, mental health specialists, and registered nurses. The nurse provides direct care such as help with medications, evaluation of health problems, and assistance in connecting with medical care.

This group of four nurses provides care to hundreds of seniors that live within the boundaries of Multnomah County. Without a nurse as part of this team there would not be medical services for many seniors who would not be able or eligible for medical care from other sources.

Attached is a packet of information about the schedule of hearings where people can speak up in support of continuing this program.



# Skip

**Health and Developmental Screening and Referral**  
Child Services Center - 531 SE 14<sup>th</sup> Avenue - 503 916-5840, Ext. 208

**SKIP (Screening Kids, Informing Parents)** is an interagency outreach program which provides free health and developmental screening and referral to approximately 600 infants, toddlers and preschool children in Multnomah County each year.

**Areas of screening are** general and dental health, vision, hearing, speech/language/cognition, coordination, fine and gross motor skills. Lead and nutrition testing are provided at the larger screenings.

**Screening is done by specialists** assisted by graduate students in medicine, dental hygiene, audiology, speech, occupational therapy, physical therapy and early childhood education. Interpreters are provided for non-English-speaking families. Many of the specialists also speak a 2<sup>nd</sup> language.

**SKIP** was started in 1987 due to concern about the increasing number of children entering the school system with developmental delays, emotional and health problems.

**Primary Funders:** Portland Schools (\$17,288 - .5 FTE clerical services)  
Multnomah County (\$35,348 - operations)

*The loss of these funds means the end of SKIP services.*

**The purpose** is to reach high-risk children and families through a multi-agency approach and address their needs before those needs interfere with success in school. Problems are identified in as many as 65 to 70 percent of the children, although at some sites, it has been as high as 85 percent of the children screened.

**Most of the children** are already being served by a social service agency, teen parent and early childhood programs, shelter or treatment center. Screenings are requested by the agency and done on site. In addition, there are two or three screenings that are open to the public each year.

**Insurance or not,** access to health care is not easy for most of the families SKIP serves. An Oregon Health Plan eligibility specialist is available at most screenings to help families understand the insurance they have or help them apply to the Oregon Health Plan.

**If county funding is reinstated,** SKIP will apply for non-profit status, then seek to supplement funding with grant money.

## HEALTH AND DEVELOPMENTAL SCREENING PROJECT

### *FACT SHEET*

*SKIP* (Screening Kids, Informing Parents) provides infants, toddlers and preschool-age children in Multnomah County with free screenings in areas of general and dental health, lead poisoning, hearing, vision, speech/language and motor skill development. *SKIP* provides parents with information and connects them with services, programs and other resources appropriate to their children's identified needs and family income. Parents are also provided with ideas for activities to build their children's skill level and confidence.

The purpose of this project is to reach high-risk children through a cooperative multi-agency approach and address their needs before health and developmental problems become a deterrent to success in school and life. Its purpose is consistent with the federal law, Individuals with Disabilities Act of 1990, requiring identification and service to children with special needs.

Screening is done by professionals assisted by college students studying professions directly related to the screening areas. Community members volunteer their time for the non-professional aspects of the screening. A supervised play area is often available for brothers and sisters. Interpreters are provided to help non-English speaking or hearing impaired families and to translate written materials.

Professional time is contributed from private practice and the following schools and agencies: Oregon Health Sciences University, Portland State University, Hearing and Speech Institute, Portland Community College, Mt. Hood Community College, University of Portland, Housing Authority of Portland, Head Start Programs, Multnomah County Health and Human Services, Multnomah Education Service District, Portland Public Schools, the Children's Program and participating East Multnomah County Schools.

*SKIP* was an initial project of the Portland Leaders Roundtable "Portland Investment Plan" to invest in our future by investing in our young people. *SKIP* also addresses goals for the Multnomah Commission for Children and Family Services and is committed to achievement of state and local benchmarks for Early Childhood Development. It is a first step toward the establishment and expansion of preventive programs for children in their early years and toward the formation of linkages among schools and agencies to assure a continuum of services that will meet the needs of our young people as they develop.
