**RESOLUTION NO. 09-117**

Filling a Vacancy in the Legislative Assembly, Oregon State Senate District 22

**The Multnomah County Board of Commissioners Finds:**

- a. Effective August 31, 2009, there is a vacancy in Oregon State Senate, District 22, due to the resignation of State Senator Margaret Carter.
- b. Pursuant to state law, on Thursday, September 17, 2009, the Democratic Party Precinct Committeepersons of Senate District 22 met to choose nominees to fill the vacancy.
- c. The nominees chosen were: JoAnn Bowman, Karol Ann Collymore and William "Chip" Shields.
- d. In accordance with procedures established by the Secretary of State, the Multnomah County Board of Commissioners considered the nominations at a public meeting at 10:30 a.m. on Thursday, September 24, 2009.
- e. At the conclusion of the public meeting the Commissioners voted to appoint William "Chip" Shields to fill the vacancy, said nominee having received the highest number of votes as indicated on the vote tabulation attached as **Exhibit A**.

**The Multnomah County Board of Commissioners Resolves:**

1. William "Chip" Shields is selected as the appointee to fill the vacancy in the Legislative Assembly, Oregon State Senate District 22.

2. This Resolution shall promptly be forwarded to the Secretary of State as required by ORS 221.060(3).
