PARCEL II
RAYMOND SMITH TO PARKS

PARCEL 1

That portion of Government Lot 5 of Section 14, Township 1 North, Range 5 East of the Willamette Meridian, bounded on the Northwest by the Southeasterly line of Columbia River Highway Road #804, on the South by the South line of said Government Lot 5; on the Northeast by a line described as follows:

Beginning at a point on the East line of the Southwest quarter of the Southwest quarter of said Section 14, which is 520 feet South of the Northeast corner of the Southwest quarter of the Southwest quarter of said Section 14; thence North $44^{\circ} 58'$ West, 860 feet to the Southeasterly line of Columbia River Highway Road #804.

PARCEL 2

That portion of the Southwest quarter of the Southwest quarter of Section 14, Township 1 North, Range 5 East, of the Willamette Meridian, lying Southeasterly of the Southeasterly line of Columbia River Highway Road #804, and Southwesterly of a line beginning at a point on the East line of the Southwest quarter of the Southwest quarter of said Section 14, which is 520 feet South of the Northeast corner of the Southwest quarter of the Southwest quarter of said Section 14 and running North $44^{\circ} 58'$ West 860 feet to the Southeasterly line of Columbia River Highway Road #804; excepting therefrom that portion of the Southwest quarter of the Southwest quarter of said Section 14 as was conveyed to Dorothy H. Jacobson, by deed recorded August 8, 1916 in book 720, page 3, deed records.

PARCEL 3

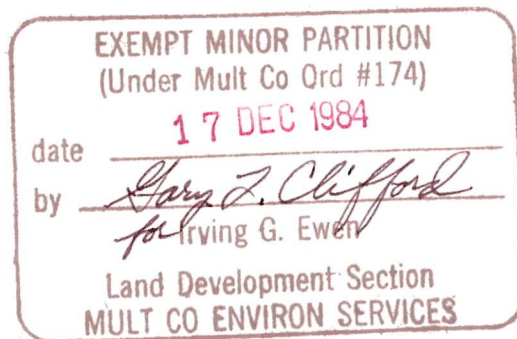
The West half of the Northwest quarter of Section 23, Township 1 North, Range 5 East, of the Willamette Meridian, EXCEPT the East half of the West half of the Southwest quarter of the Northwest quarter of said Section 23.

ALSO EXCEPT that portion lying southerly of the following described line: Beginning at a point on the Section line, North $1^{\circ} 40' 56''$ West, 340.78 feet from the quarter corner common to Sections 22 and 23; thence North $84^{\circ} 04' 12''$ East, 165.22 feet; thence North $58^{\circ} 22' 30''$ East, 125.85 feet; thence North $76^{\circ} 18' 58''$ East, 66.66 feet; thence South $81^{\circ} 44' 51''$ East, 343.47 feet; thence South $68^{\circ} 55' 50''$ East, 231.10 feet; thence North $75^{\circ} 59' 10''$ East, 111.50 feet; thence North $80^{\circ} 47' 09''$ East, 217.83 feet; thence North $80^{\circ} 34' 14''$ East, 140.39 feet to a point on the East line of the Southwest quarter of the Northwest quarter of said Section 23, said point being North $0^{\circ} 13' 04''$ West, 374.14 feet from the Southeast corner of said Southwest quarter of the Northwest quarter of Section 23.

PARCEL 4

That portion of Section 15, Township 1 North, Range 5 East of the Willamette Meridian, described as follows:

Beginning at the Southeast corner of said Section 15; thence North along the East line of Section 15, to the Southeasterly line of that tract of that tract of land conveyed to Dorothy H. Jacobson by deed recorded August 8, 1916, in Book 720, page 3 Deed Records; thence Southwesterly along the Southeasterly line of said Jacobson tract to the most Southerly corner of said tract; thence North 42° 20' West along the Southwesterly line of said Jacobson tract, 154 feet to the most Easterly corner of the tract of land conveyed to William Vanderlinden, et ux, by deed recorded August 9, 1934 in book 260, page 278, Deed Records; thence South 49° 15' West, 100 feet along the Southeasterly line of said Vanderlinden tract to the most Southerly corner of said tract; thence North 42° 20" West, along the Southwesterly line and its Northwesterly extension, 86 feet to the most Easterly corner of the tract of land conveyed to Ed Harnam, et ux, by deed recorded September 13, 1928 in Book 1157, page 178, Deed Records; thence South 49° 15' West along the Southeasterly line and its Southwesterly extension of said Harnam tract to the South line of said Section 15; thence East along said South Section line to the place of beginning.

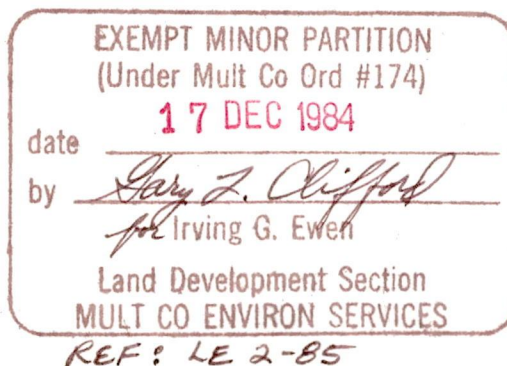

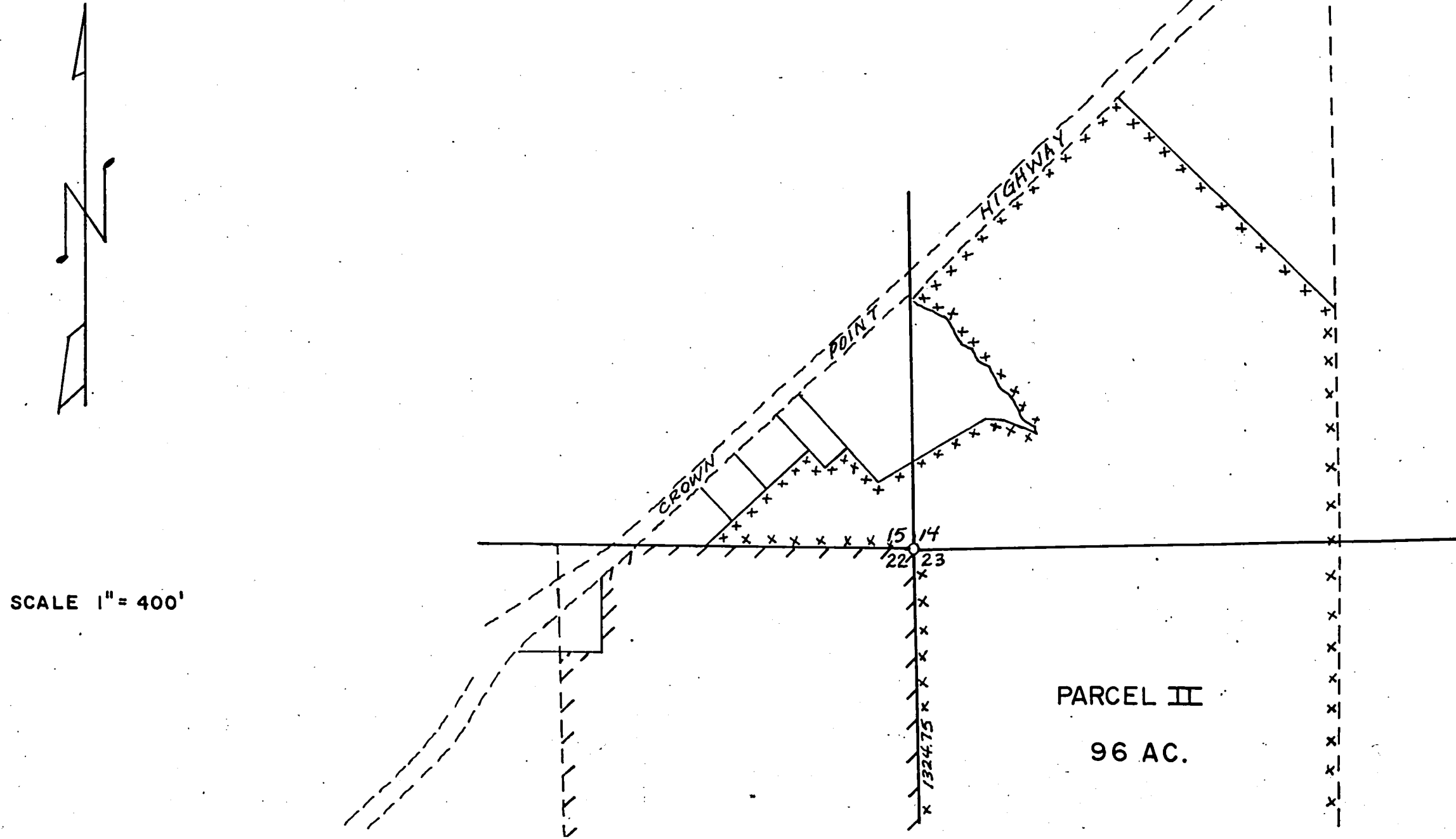

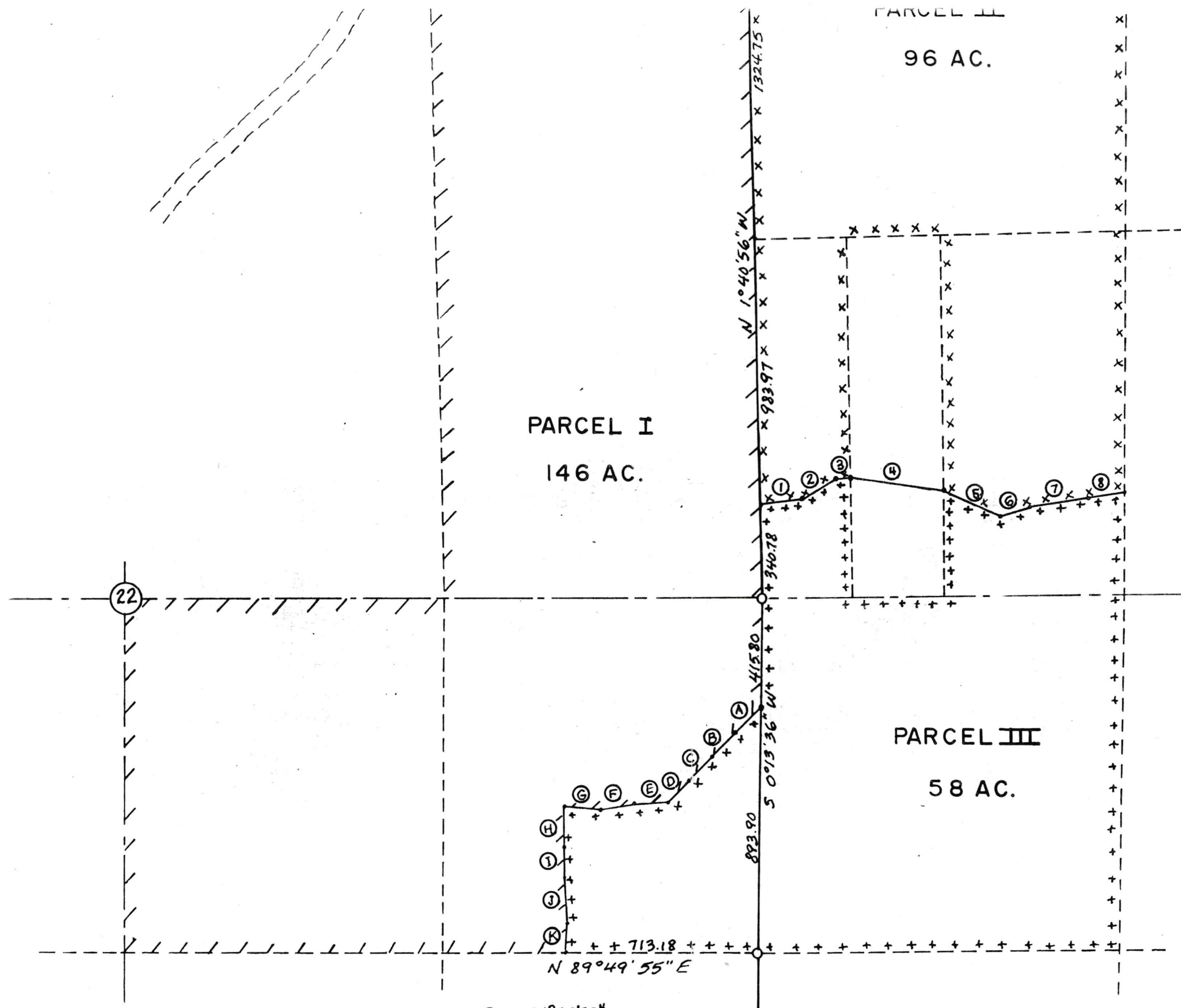
