RESOLUTION NO. 2017-041

Adopting the Fiscal Year 2018 Budget for the Multnomah County Library District and Making Appropriations Thereunder, Pursuant to ORS 294.456

The Multnomah County Library District (MCLD) Board Finds:

- a. The MCLD budget, as prepared by the duly appointed MCLD Director/Budget Officer, has been considered and approved by the MCLD Board acting as the Budget Committee.
- b. A public hearing on this budget was held before the Multnomah County Tax Supervising and Conservation Commission on the 17th day of May, 2017.
- c. The budget is now on file in the Multnomah County Library's Administrative Office.
- d. The MCLD Board has made one amendment to the above described budget and that amendment is attached to this resolution as Attachment A.
- e. The appropriation authorized is as follows:
