RESOLUTION NO. 2015-082

Authorizing the Repurchase of a Tax Foreclosed Property by the Former Owner, CCW LLC, a dissolved Oregon Limited Liability Company.

The Multnomah County Board of Commissioners Finds:

- a. CCW LLC, a dissolved Oregon limited liability company, is the former owner of certain real property, more particularly described as:

Unit PGU 2, GARDEN COURTYARD CONDOMINIUM, as set forth in Condominium Declaration recorded March 30, 2007 as 2007-056775, in the City of Portland, Multnomah County, Oregon, together with those limited common elements appurtenant to said Unit as set forth in said declaration, and together with an undivided fractional ownership of the general common elements of said Condominium as set forth in the said Declaration and in any subsequent amendments thereto as appurtenant to said Unit.

(the "Property"). On or about September 25, 2012, judgment was entered in Multnomah County Circuit Court foreclosing the delinquent taxes levied against the Property.

- b. On September 25, 2014, the County Tax Collector deeded all right, title and interest in the Property to Multnomah County as authorized under ORS 312.200.
- c. The registered agent and a member of CCW LLC, Wendall Talley, has applied to the County in compliance with MCC Section 7.402 to repurchase the Property for \$3,000, which amount is not less than that required by ORS 275.180 and MCC Subsection 7.402(C).
- d. The County has received payment in the amount of \$3,000 from Mr. Talley on behalf of CCW LLC, and it is in the best public interest that the Property be sold to the former owner.

The Multnomah County Board of Commissioners Resolves:

1. The County Chair is authorized to execute a deed, in substantial conformance with the attached deed, conveying the Property to CCW LLC.
