Dear Commissioners Buchanan and Mosee:

Enclosed is a copy of a report of our districting subcommittee to the full committee. It is largely self-explanatory, but I wanted to add a couple of comments to you personally, since this affects you both directly.

I recognize that districting is not the way that either of you would do it. As you know, I offered several compromise plans. These attracted some support, but seemed to draw more heat than support from both sides of the controversy. The most colorful description was that I was making a sirloin into a hamburger. Given the apparent choice between districting and at-large election, our subcommittee strongly feels that a fair districting plan, with a separate chairman, is the best way to go.

I also recognize that the proposed limitation on the budget of the Board of County Commissioners is going to cause you some problems. However, our committee is becoming increasingly convinced that we are going to have to come up with something that will pass, or the form of county government will be determined by whoever comes up with the most demagogic initiative next year. This means we will have to counter the charges--which we have been assured will be made--that our proposal for an additional commissioner will make government more expensive. In the year of proposition 13, we will have to address that concern. We have been urged to do this by limiting the commissioners' salaries. I believe that is unfair and not necessarily the best way to economize. Our subcommittee's proposal for limiting the total budget of the Board allows the Board to determine how best to economize.

While our proposals may differ in some important respects from the way you would have preferred things to be, I hope you will recognize that this is a sincere and responsible effort to develop a workable form of government and to end the continuing "warfare by initiative." We have a good county government, and I think we can make it even better, and increase public confidence in it. I hope we will have your support.

The purpose of this letter is twofold. First, it transmits to you and to each member of the Commission a copy of the following documents:

Financial Planning Report #8: County Service Allocations, 1966-1977

Office of County Management Discussion Paper #1:
An Analysis of Financial Planning Report #8
With Findings and Recommendations

Financial Planning Report #9: Mandated County Services

I believe these documents have been requested by members of the Commission and that they are self-explanatory; however, I would be happy to discuss them with any member of the Commission. Second, I wish to express my concern about proceedings before the Commission to date, and for that reason, I am sending a copy of this letter to each member of the Commission along with the above documents.

Simply stated, my concern is this: that opinions of the quality of the County's current management will, in the absence of facts about that management, influence the ultimate decisions of the Commission. If so, I believe the Commission has an obligation to seek out facts about County management in a way and to a degree it has not done to date.

I will be the first to say that my concern may be unfounded. It is based on the fact that, for several weeks now, the Commission has listened to comments from citizens and employees who have strong opinions about the way the County is managed and about those of us who manage it. Few of those people have much factual understanding of the managerial mess that we all inherited three years ago or of the efforts we have made and are making to deal with it.

Perhaps one example can be used to illustrate my concern. At the Commission's hearing on March 20, several statements were made that the County's civil service system has been emasculated over the last three years and that, in the process, the Chairman has acquired the right to hire and fire at will over 300 County employees. Fact: 324 County employees are not protected by both civil service and union contracts; however,

- a. 105 of those employees are fully protected by civil service,
- b. 86 are professionals (physicians, attorneys, dentists, registered engineers, veterinarians, psychiatrists) traditionally exempt from civil service,
- c. 41 are the personal staff of elected officials (Commissioners, judges, Auditor, District Attorney) of whom nine serve at the pleasure of the Chairman and who are traditionally exempt from civil service,
- d. 8 are personal staff to department heads who are traditionally exempt from civil service,
- e. 79 are line managers (division heads, section heads), and
- f. 5 are department heads traditionally exempt from civil service.

In a traditional civil service system the only difference in the treatment of this entire group would be that the 79 division and section heads would be protected by civil service and have a tenure right to their jobs. Should line managers have such tenure rights? That issue is being hotly debated

nationally at the moment, and the County is far from unique in having removed them. Furthermore, the hiring and firing of employees in those 79 jobs are subject to affirmative action regulations which require procedural steps quite comparable to those under civil service, and the County's management is making a major effort to see that those steps are followed.

It is also a fact that in January, 1975, the County's civil service system was a shambles, and the last three years have seen a consistent effort to repair that system, not destroy it. Now, for example, in contrast to the situation three years ago,

- a. New classifications are reviewed and approved by the Merit System Civil Service Council according to ordinance,
- b. Employees are hired and promoted according to civil service procedures,
- c. Employees paid from grant funds are treated as County employees fully protected by civil service, and,
- d. A rational job classification plan has been completed which, if not scuttled by Local 88, will go a long way toward improving the equality of pay for equal work among all classes of employees covered by union contracts and civil service.

An example of the steps necessary to get the civil service system back in a semblance of order is that, two months ago, it was finally necessary to amend the civil service ordinance to grant retroactive civil service tenure status to 227 employees (about 10% of the County's full-time work force) who over the last ten years had been hired and/or promoted without following civil service rules or procedures.

More could be said on the issue of the civil service system, but I think the above comments serve to make my point about variations between fact and opinion when it comes to the management of the County. Quite a debate could be staged about whether we have done enough, well enough, fast enough in the last three years. From the standpoint of the Commission, however, I think the issue is this: under a strong executive charter the County's civil service system was allowed to fall apart, even helped along in that process, and under the same charter a serious effort is being made to put the civil service system back together again. What, then, can one reasonably conclude

is the necessary effect of a strong executive charter on personnel management? I suggest it is only this: that the locus of authority and responsibility for taking action is clear and undiffused.

That conclusion, however, is not the point of this letter. The point, again, is that I fear the preponderance of opinion and the dearth of fact presented to the Commission thus far about the management of the County will shape the Commission's recommendations on the charter. If each member of the Commission can fairly say that the statements about the civil service system made on March 20, the facts I have mentioned above, or discussions of similar management issues before the Commission have no effect or bearing on his or her views about the issues before the Commission, I would concede, on that test, that my fear is ungrounded. If the contrary is true, then the Commission has a problem, and I have reason to be fearful.

If the Commission does have a problem, it would serve the Commission and the voters well if some fact finding occurred. Fact finding is not going to occur in a public hearing in which each person testifying is given five minutes to cover his subject and in which speakers arise in random order. Such a proceeding only encourages the histrionics witnessed on March 20 or the absence of those who have no stomach for them.

Finally, I trust that each member of the Commission will accept that my comments here represent my own opinion. I assume others responsible for the management of the County can speak for themselves.

Dear Mr. Faust;

I read the article in this morning's Oregonian by Rod Patterson expressing your concern over the lack of citizen participation at the Review meetings. I share your concern. I don't know what your committee is doing, when it meets, where it meets, or what communication systems it is developing. May I offer some suggestions anyway?

1. Invite to a meeting representatives of one of the organizations that studied the charter during the past year or two. These people, such as those with the League of Women Voters, have studied the problems and can give an informed opinion, but may be reluctant to offer suggestions until you approach them. Do not try to cover every organization at one meeting. This also may add support to those helping you pass the final proposal.
2. Develop a mailing list. Either mail all the information to everyone or select those people living in a given area for a given meeting. Your list should include neighborhood associations (both city and "it just grew" groups), all people who offered to serve on the Review Committee, and all politicians within Multnomah County. I know it costs money, but we don't attend meetings we don't know about.
3. While it is important for citizens to have an opportunity to help develop the charter proposals, be sure to leave enough time for public response to a proposal before it is voted on. Be willing to change details or language for the final draft. Some people only react and don't develop.
4. Take small steps. You can't change the world or rewrite the whole charter. Try for two or three specific areas.

You may be doing most of these things already. If not, maybe I've helped. Good luck with your task. I'll attend one of the meetings, if I know when and where.
