Riad,

This is a little confusing. I reviewed a version of #29856-01 identified as Amendment 1 on January 22nd, that is different than the one attached below. I made a mistake yesterday, when I thought that what I reviewed back in January was the contract. In any event, the version of this amendment no 1, back then had an Exhibit C, captioned "Project Key Milestones". The one attached does not. I don't know the full significance of that Exhibit not being included. To me the deletion of the Exhibit C seems to remove some reporting and other obligations that would otherwise apply to the County.

With respect to the other ROW IGA, this is sort of the new normal with respect to ODOT funded right of way acquisition. See the Agency Obligations, Sections 3 and 4 as to what the options are for right of way services. I think this is much more closer coordination with ODOT than what we have done in the past. Also, I don't know if the property acquisition is going to be funded with ODOT money.

Assuming these issues as outlined here are acceptable to the County Transportation Program, the attached IGA and IGA Amendment have been reviewed and approved for submission to the BCC for its consideration.
