**From: Jan Johnson**

You have seen me up here many times asking for -- and thanking you and Sheriff Reese -- for efforts to improve policy and training regarding immigrant protections.

Each time, I have stressed the importance of *accountability and transparency*.

That is why I am testifying today. I have three concerns about your agenda item to remove two citizens from the county's citizen involvement efforts.

**Reason No. 1: We all need to hear and respect opposing views.**

I was part of a company where 12 people with no assets grew what become one of the largest providers of wind power in the country with more than 900 employees and \$12 billion in assets in just 10 years. Citizen involvement was key to every project we built.

Citizen involvement is by its nature feisty. The whole point of citizen engagement is to open up a space for voices and sometimes those voices get loud and angry. In my experience, sometimes people bring guns.

But never did we describe any citizen in the kind of language you use in your agenda item.

Any attack on volunteer community members is punching down. And punching down is never okay.

**Reason No. 2: These claims are not believable.**

Yu Te has provided IT consulting for my business and personal computing needs for more than six years. As a resident of the Hollywood District, I also admire his work as a leader of the Hollywood Boosters.

We also share a common passion for bridging the urban-rural divide. While I was putting up wind farms in red states or red parts of blue states, he was helping rural youth in Oregon put their computing skills to use in their communities. I view Yu as a model of *reducing* polarization.

So these words you use to describe him are, in my experience, not plausible.

**Reason No. 3: We need more citizen involvement today than ever before.**

I have been talking with your staffers and some of you personally about redress -- specifically creating a joint ombudsman office with the City of Portland along the lines of

the Dayton, Ohio-Montgomery County joint ombudsman. I am in favor of *more* independent oversight with *more* robust structures to address complaints and improve practices—not staff-led citizen rubber-stamping.

Anybody volunteering time and energy to exert grassroots power deserves to be heard.

This is not the time in history to silence citizen voices.

All the punching down this nation can stand is coming from the highest office.

Multnomah County has been one of the few beacons in a dark time. Passionate community engagement will only make this county better.

Thank you for your time and consideration. I will follow up with each of your offices on this matter.

To Whom it May Concern,

By way of introduction my name is Teresa Walton. I am a former member of the Citizen Involvement Committee. I was an active member in various capacities for a total of fourteen years until my retirement in 2016. During my tenure I served as an officer on the Executive Committee a total of twelve years often replacing a member on short notice. I served on the DCJ CBAC a total of six years and served as Chair of the Central CBAC two years. During my term as chair of the Central CBAC I was charged with revising the current program to meet the needs of the BOCC. Reports were streamlined and user friendly and concise. It was given a general facelift that worked to everyone's advantage while it maintained the independence of the committee with regards to budget recommendations. In addition I am the proud recipient six times of the Public Service Award for our department and the recipient of the Multnomah County Volunteer of the Year Award. However my greatest achievement occurred whenever I was asked to represent Multnomah County as an ambassador to the World Affairs Council. This remarkable program hosted dignitaries from around the world in order to learn our way of government and the important role we as individual citizens played in insuring transparency from our elected officials. It was the greatest honor of my lifetime. In addition to my volunteer duties I work forty hours a week in the high stress position as an emergency room nurse.

I first met Mr. Anderson shortly before my retirement. He had applied for membership and asked that we meet for coffee to discuss the role of the committee as it relates to county government. Always happy to promote the work of the committee in a positive way I agreed. Mr. Anderson left our meeting energized and excited to become a part of our unique and elite group.

Two months later I received yet another call from Mr. Anderson. He was concerned that he had not heard back on his application and was worried that he had been rejected. I assured him that I would look into it only to find out that after several months his paperwork had never been processed by the OCI office staff. He expressed an insecurity about the situation but agreed to "hang in there" and continued to participate in an active role while waiting for his official confirmation. Shortly after this I retired.

Several months passed when I again received a call from Mr. Anderson inviting me to have lunch. When I agreed I questioned him in good faith about the status of my beloved committee. Polite small talk to break the ice. He confided in me that there was a lot of confusion regarding the role and mission of the committee but he felt certain this would work itself out. He was however clear that it was nothing close to what I had described to him in our past conversations.

One evening the phone rang and it was Mr. Anderson. He proceeded to inform me that he had just been elected chair and wanted to talk. He stated that he was concerned that due to a lapse of leadership the previous year he was unsure if the committee had a clear direction. He solicited my help to bolster his confidence and asked if I would be available to speak at the upcoming retreat about the history of the CIC and why it had a thirty year history of success. While I was flattered to be asked, I felt that former director

Kathleen Todd would be a much better choice. Kathleen had been my mentor for fourteen years and knew infinitely more than I ever could. Mr. Anderson then asked staff to please extend the invitation to Ms. Todd. Staff refused opting instead to gather a brief history via telephone. When questioned afterward about the success of the retreat Mr. Anderson stated that most members left feeling frustrated and confused. It was then that he solicited my help once again to help him compile a research paper on the history of the CIC in hopes of inspiring the current generation and future generations of members. Once started he discovered that all historical records of the past had been destroyed. His hopes of building on the once strong foundation of a successful committee seemed very distant and he was getting no help with this from staff. In fact he was getting a lot of resistance. But he persisted and produced what I consider to be one of the most accurate accounts in modern day history of the purpose and role of the committee. This document will endure time and serve as an important teaching tool for generations to come.

Shortly after his publication was distributed he asked again to have Kathleen speak at the CIC second retreat. This request again was denied by staff. The reasoning being that staff felt the past to be inconsequential. Traditionally this would have never been a decision by the staff since the staff purpose is to serve as support for the committee. Mr. Anderson asked the committee for their opinion after having read his manuscript and the committee agreed history did indeed play a vital role in the success of the committee, and the success of the committee for the future. The retreat was cancelled shortly thereafter by staff.

Approximately a week later I received a call from Mr. Anderson asking me to attend a steering committee meeting at Kennedy school on a Sunday afternoon after work. He had hopes that by my speaking in a positive way about the success of the committee it would provide clarity and inspiration to those who chose to attend. During my conversation I detailed some of the highlights of the various programs promoting citizen involvement.

Programs included:

- The nationally recognized Departmental Review Program. This program was designed in Multnomah County and put us on the map. It won several awards and set the gold standard nationwide. This program has been abandoned and awards removed from the walls of the office as if they never existed.
- The county Volunteer Awards. Hosted by the CIC each April in conjunction with National Volunteer Month. This is when we honor the hundreds of selfless volunteers who devote their time unpaid to the citizens of the county. It takes months to plan. These volunteers save the county millions each year and are the best we have to offer. It is always a joy and a pleasure to meet each one and say thank you for your service. Program disbanded.
- The CIC / CBAC tribute dinner. Again our time to say thank you to each other and the families who sacrificed their time in order that we as a committee could make educated and informed budget recommendations from a citizens point of view to you our elected officials. I can't begin to tell you how many nights I would crawl into bed exhausted after a late CBAC and working all day but I did it and you got my report at the end of budget season. Dinner cancelled.
- The World Affairs Council Guest Ambassador program. This was originated by the CIC in conjunction with the World Affairs Council of Oregon. A select few were chosen to represent Multnomah County as hosts to visiting diplomats from around the world who had come to study from us our way of government and the importance of transparency and independent thought in the decision making process. Program disbanded.
- A month ago I attended a mental health forum in the county board room put on by Commissioner Meiran's office. This was of particular interest to me because this is the very population I serve eight hours a day. Traditionally the CIC and OCI would receive a call from the sixth floor asking us to host this event, order food greet people at the door, provide the publicity and gather recommendations from the constituents to be compiled into a report by the office and sent back to the elected official. No representative from the CIC or OCI were even in the building.
- The Abernathy Shelter lease signing. Again it should have been the role of the CIC and OCI to publicize and coordinate meeting times and places. In the event of a cancellation this should have

been on the OCI website along with changes made in order to accommodate the needs of the community. CIC Vice Chair Brian Balla had no clue that this was something the CIC /OCI was in charge of and he is the President of the Abernathy Neighborhood Association. This had the potential to save a lot of heartache and misunderstanding had the OCI been doing its job the way the charter had intended.

My question to you at this point is, if it is the primary responsibility of the office staff to support the work of the committee in promoting civic involvement and there are no active projects on the table what do these two people do all day to earn a paycheck and why does it take two paychecks to do it?

Two weeks later another small group met at Elmer's at mall 205. At this gathering Kathleen Todd was in attendance and everyone including myself got an education. It was an inspirational evening for all of us. It also reinforced the ideology that staff while paid out of the county general fund was to serve as support for the work of committee in order to better serve the community at large. Not the other way around. When questioned about the issue this did not appear to go well with staff. Consequently staff has decided retribution was the way to handle the "situation" Mr. Anderson and Yu Te were singled out and summarily threatened to be fired by staff with no public hearing. Vague allegations were launched damaging their reputations and I personally was labeled to be a subversive for clarifying to role of the committee. It makes one have to ask since when do we take lessons from the Trump Whitehouse. How embarrassing this would prove to be should the press ever get wind of this. Clearly this is an abuse of power as office staff continues to separate itself from the committee. This was the very reason why the last Executive Director was dismissed from his position. My concern is that if this pattern continues not only will the CIC lose its independence and valuable role in the community the CBAC program will lose theirs. Both programs are the only independent voice left for the people of Multnomah County and must be preserved at all cost. The Office of Community Involvement (OCI) was established by County Charter to develop and maintain community involvement programs and procedures for the purpose of facilitating direct communication between the people of Multnomah County and the Board of County Commissioners.

### Program Summary

The OCI coordinates programs and activities designed to engage people from Multnomah County's diverse communities. Programming includes community outreach, community forums, and trainings. The OCI conducts continual outreach and recruitment to inform communities about opportunities to engage with Multnomah County committees and programs by attending community events and through communications including social media and email.

The OCI maintains a community contact list for communications, including notifying qualifying organizations of the opportunity to nominate members for county committees. The OCI also hosts an annual volunteer recognition event for all county departments.

The OCI staffs the volunteer members of the CIC, including providing support, training and coordination for CIC meetings. The CIC engages in an ongoing study and discussion of the county's priorities, programs and procedures and makes recommendations to the Board of Commissioners and county departments regarding timely, equitable, and inclusive civic participation in county decision-making.

*The OCI also provides technical and clerical assistance and training to the CBACs, and staffs the County's Central and Non-Departmental CBACs.*

This "narrative" program description was recently attached to an email from current staff. It advances/asserts that the "Office of Community Involvement was established by County Charter to...." in The Executive Summary and is completely void of CIC mention.

The "narrative" in this Program Summary speaks to a "high-profile OCI" throughout its content, and diminishes the work and authority of the "Committee," essentially further separating the CIC from its Office of Community Involvement. This document was offered to the CIC to "review," and no approval was proposed, nor requested.

This serves to follow-up on your predecessor's earlier mention of wanting to make sure that adequate support exists, or was being provided to, the Community Involvement Committee (CIC) and OCI, and current desires by some CIC members to be provided with some type of mediation, which I support and want to add my voice to.

As you know, there has recently been a resurrection of old-wounds within the CIC and OCI, due in no small part to unresolved conflicts and issues from the "2016 Debacle" and today's CIC reorganizing efforts which include a desire by some to identify and correct the damage then done to the organization, and to thereafter move prudently forward together.

Several of our members, as a result of the resurfaced tensions, have suggested that some type of 'mediation' be provided by the County for our members. I agree with those sentiments wholeheartedly, and write to urge serious and immediate discussion about considering some type of professional mediation to support our group.

For your added information, when I first took the office of Chair of the CIC, I made several promises to the members, among which were to at all times strongly press for the principles of "*full-disclosure, robust-discussion, and transparent decision-making.*" As I see it, recent assertions of an imposed change in organizational structure and supervision-of-staffing model from the previous 33 years, without any record of transparency or decision making, in public, by either the BOCC or CIC, as reflected in the records, is one of today's contributing sources of that resurrected tension and conflict.

Please know that I stand personally ready to support, or participate in, any professional mediation efforts that would help heal the reopened wounds for our group, particularly as we head into an important Committee Retreat in just days. We have a good group of people that deserve support for the volunteer work that they do, and who, I believe, are talented, intelligent, and who are, and justifiably feel, that they are dedicated public servants to their constituents.

While I can't speak for individuals within the group, it is my observation that a core group of leaders within the CIC would support a meaningful, serious, and professional mediation service. When that suggestion was aired in our last public meeting, not a single voice opposed that suggestion, and it's my belief that virtually all members would support it.

Thanks again, Kim, for your time and insights, along with/from Dani and others at our meeting this past Monday.
