Authorizing the Private Sale of a Tax Foreclosed Property to Michael G. Lubitz and Kari J. Lubitz.

The Multnomah County Board of Commissioners Finds:

- a. Multnomah County acquired through the foreclosure of liens for delinquent real property taxes, certain real property located in Multnomah County, more particularly described in a copy of a proposed deed, attached as Exhibit A (the "Property").
- b. ORS 275.225 allows the County to sell County owned property, including property acquired through tax foreclosure, at a private sale if that property meets certain conditions with respect to value and the applicable zoning and building codes.
- c. The Property has a real market value of \$8,100 on the assessment roll prepared for the County, consistent with the requirement of ORS 275.225(1)(a).
- d. Although no written confirmation from the City of Portland was obtained, the Division of Assessment, Recording & Taxation has reviewed the location, size, and zoning of the property and concludes that the property is unsuitable for the construction or placement of a dwelling thereon under applicable zoning ordinances and building codes, as provided under ORS 275.225(1)(b). The current zoning, R7 requires a minimum lot size of 4,200 square feet, whereas the property is approximately 2,700 square feet. Additionally, the property terrain is a very steep slope which likely makes it unsuitable for the construction or placement of a dwelling thereon.
- e. The County has received payment in the amount of \$7,500 from Michael G. Lubitz and Kari J. Lubitz, an amount the Board finds to be a reasonable price for the Property in conformity with ORS 275.225.

The Multnomah County Board of Commissioners Resolves:

1. The County Chair is authorized to execute a deed, in substantial conformance with the deed attached as Exhibit A, conveying the Property to Michael G. Lubitz & Kari J. Lubitz, in consideration of \$7,500.
