

The Multnomah County Social Services Division anticipates the issuance of a Request for Proposals (RFP) for Black minority alcohol and drug outpatient services and alcohol residential services for Multnomah County, if responses to this solicitation of interest are received from two or more qualified organizations for either service.

Scope of Services

Black Minority Alcohol Outpatient Services and Drug Outpatient Services:  
121 alcohol outpatient slots: \$140,118; 53 drug outpatient slots: \$98,156;  
\$28,252 of local 2145 funds to supplement the above slot rates. Total outpatient funding: \$266,526 to be awarded to one provider.

In addition to meeting the requirements for outpatient alcohol and drug treatment services (OAR 309-51-000 through 309-51-070; OAR 309-53-050 through 309-53-120) this program must meet the minority service requirements of OAR 309-52-030 through 309-52-050. At least 51% of all clients served must be Black.

Black Minority Alcohol Residential Services: 11 beds to be awarded to one provider. Total residential funding: \$59,257.

In addition to meeting the requirements for residential treatment (OAR 410-10-000 through 410-10-170) this program must meet the minority service requirements of OAR 309-52-030 through 309-52-050. At least 51% of all clients served must be Black.

Qualifications



ORDERED that the above-entitled Order be approved.


Commissioner Kafoury said she wanted to clarify that the term for Commissioner, East District, will run through December 31, 1992, and that there had been an error in the paper.

RE: Procedure for Declaring Vacancy in

The procedure for declaring and filling the vacancy created by the death of Commissioner Casterline is as follows:

1. The Board should promptly convene to declare the vacancy. MCC 4.30.030(A). I will draft an appropriate Order for that purpose. The Order can be adopted at a single public meeting, but if the meeting is a special meeting, it must be ratified at the next regular Board meeting. Charter, section 3.50(3).
2. The vacancy must be filled by election. Charter, section 4.50(1)(a).
3. The election must be held on the next available election date which is not sooner than the 45th day after the date of declaration of vacancy. MCC 4.30.055. (May 16, 1989).
4. A petition or declaration of candidacy to fill the vacancy must be filed with the Director of Elections not later than the 34th day prior to the date of election (April 12, 1989).



### COMMISSIONER ELECTION SET FOR MAY 16

The date for an election to fill the Multnomah County Commission position left vacant by the death of Polly Casterline has been set for May 16. The filing deadline is April 12. The Multnomah County Board of Commissioners ordered the election at a meeting Tuesday February 21.

The election will cover the entire remaining term for the commission seat, which expires in December of 1992. No interim commissioner will be appointed.

Candidates may file for the election by paying a \$50 fee to the county Elections Office, 1040 S.E. Morrison St. in Portland, or by filing a petition signed by 500 eligible voters.

Only residents of the east county district, stretching roughly from east 122nd Avenue to the Bonneville Dam, are eligible to run for the position and to vote in the election.

In related action, the Board of County Commissioners also decided to retain Casterline's staff through the May election. Staff members will continue to work on projects and to respond to citizens' needs.

RE: Election Procedure to Replace  
Commissioner Casterline

The vacancy created by the death of Commissioner Casterline will be filled by election on May 16. Several of you have asked what would be the consequence if no candidate receives a majority of the votes.

The answer to this question depends on whether the voters approve the amendment to section 4.50 of the Home Rule Charter at the March 28 election. If that measure is approved, and no candidate receives a majority of the votes cast at the May 16 election, a run-off between the top two candidates for Commissioner Casterline's office would be required. If the voters reject the charter amendment at the March 28 election, the candidate receiving the most votes will be elected to replace Commissioner Casterline.

In concluding that the May election will be governed by the charter as it reads after the March vote, I have considered two points.

First, under the county code, a voter-approved charter change would take legal effect before the May election. See MCC 4.51.080(H) (charter amendment effective 30 days after voter approval).

Second, there would be no hardship or surprise to candidates by applying the revised language of section 4.50 to the results of the May election. The vote on the charter amendment will precede the filing deadline for the May election (April 12). Thus, all candidates for Commissioner Casterline's office will know the election procedure as of the filing deadline for the office.





Laurence Kressel, County Counsel, advised the Board that Board Rules state that two working days after a vacancy is declared, the Commissioners staff are terminated unless the Board determines otherwise. He stated he had prepared an Order to allow the Polly Casterline staff to remain until the vacancy is filled at the May election.

Commissioner McCoy read the Order.

The Board agreed the Casterline staff will bring a list of duties to the Board meeting on Thursday at which time it will be determined to what extent each Commissioner will supervise that staff.


At this time, the motion was considered, and it is unanimously




