Adoption of the Proclamation in observance of Veterans Day on November 11, 2014.

In the thirteenth year of sustained combat operations by US Armed Forces in Afghanistan, Commissioner McKeel and the Veterans Employee Resource Group are bringing this proclamation forward to ensure Multnomah County recognizes Veterans Day on November 11th, 2014.

The duty and sacrifice of veterans throughout the history of the United States has been tremendous and significantly impactful on not only service members themselves but their families and friends. More than 1,000 Oregon Guard soldiers and airmen have been deployed this year around the world, including approximately 900 who will serve in Afghanistan. When troops deploy, life changes for so many people both at home and abroad. Recognition of our veterans and continued understanding of their experiences is important and recognized on Veterans Day each year.
