

The above-described portion of N.E. 179th Avenue is a regularly dedicated street, and the same has been constructed and improved according to Multnomah County specifications under Project Agreement No. 5206. The work was paid for by Chet DeBois Homes, Inc., 1311 N.E. 181st Avenue, Portland, Oregon 97230, and the County Engineer has recommended to the Board that said portion of said N.E. 179th Avenue be taken over as a county road, and the Board being fully advised,

IT IS HEREBY ORDERED that that portion of N.E. 179th Avenue from E. Burnside Street, northerly to N.E. Couch Street be and the same hereby is established as a county road, in accordance with ORS 368.016(2)(c) and with the centerline and right-of-way boundary lines as dedicated by the plat of Multi-East Park, recorded 5-13-82, in Book 1215, Page 96, in the Plat Records of Multnomah County, Oregon, and the deeds of dedication to the public recorded 4-2-68, in Book 612, Page 238 and 5-4-89, in Book 2206, Page 618 in the Deed Records of Multnomah County, Oregon, in accordance with Technical Engineering Corp. Field Survey. Said N.E. 179th Avenue being all in Section 31, T1N, R3E, W.M. The right-of-way to be variable and to include all that area lying south of Station 4+03.62, P.O.T.

FURTHER ORDERED, the County Surveyor is hereby directed to file a map of same as required by law.

FURTHER ORDERED, this Order establishing County Road No. 4871 be recorded in the Deed Records of Multnomah County, Oregon.
